Dear Ms. Weisman:

Reference is made to your Freedom of Information Act (FOIA) appeal dated May 19, 2020 appealing the initial no records response to your April 16, 2020 FOIA request for both records reflecting the use of government funds to provide security and other services for Ivanka Trump and Jared Kushner's trip to Trump National Golf Club Bedminster in April 2020 and records reflecting the number of Secret Service agents involved in the detail for that trip.

With respect to your appeal regarding the first request, the use of government funds for the trip to Bedminster, that portion of the appeal has been granted. Enclosed are responsive documents located in a subsequent search after the travel costs had been entered into the agency's financial system.

With respect to your appeal regarding the second request, your appeal has been denied. Revealing the size of the protective force would reveal a significant part of the overall protection plan and law enforcement techniques underlying it, as well as endangering the protectee and Secret Service employees. Any information regarding the size of the protective detail is properly withheld under FOIA exemptions b(7)(E) and b(7)(F).

Under federal law, we are required to advise you that any decision on appeal is subject to judicial review in the district court in the district where the complainant resides, has a principal place of business, or in which the agency records are situated, or in the District of Columbia.
