Dear Requester:

This is the fourth interim response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on January 21, 2021, for information pertaining to:

1. All records from December 1, 2020 to January 6, 2021 reflecting any plans for demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021 that were identified by any DHS component—including without limitation the Office of Intelligence & Analysis (“I&A”) and the Federal Protective Service (“FPS”)—or other agencies through social media monitoring, threat assessments, or other means.
2. All records from December 1, 2020 to January 6, 2021 reflecting any tips, complaints, referrals, allegations, or reports submitted to any DHS component—including without limitation I&A and FPS—regarding planned demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021.
3. All records from December 1, 2020 to January 6, 2021 reflecting DHS’s communication to other agencies—including without limitation the U.S. Capitol Police, the D.C. Metropolitan Police Department, the Federal Bureau of Investigation, the Department of Justice, or the Department of Defense—of the risks or threats posed by planned demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021.
4. All records from December 1, 2020 to January 6, 2021 relating to any DHS component—including without limitation I&A and FPS—providing assistance or support to the U.S. Capitol Police, the D.C. Metropolitan Police Department, or any other agency in connection with the January 6, 2021 congressional session to count electoral votes.

After a detailed review of potentially responsive records, 114 page(s) were released. Exemptions under the FOIA Statute, Title 5 U.S.C. § 552 have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.

**FREEDOM OF INFORMATION ACT**  
**SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552**

**Provisions of the Freedom of Information Act do not apply to matter that are:**

- (b) (1) (A) specifically authorized under criteria established by an Executive Order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified pursuant to such Executive order;
- (b) (2) related solely to the internal personnel rules and practices any agency;

(b) (9) geological and geophysical information and data, including maps, concerning wells.

Good Morning All,

Many of you are probably aware of this by now but there will be another Women For America First (AKA Million MAGA March) First Amendment event to occur in Washington, DC on January 6, 2021. This event was first mentioned by POTUS early Saturday morning when he tweeted about a report concerning election fraud and said that there will be a big protest in D.C. on January 6<sup>th</sup> and that it "will be wild". Since then, the tweet has gained significant traction and many of the same groups from the November 14<sup>th</sup> and December 12<sup>th</sup> events are planning on attending.

Details are still limited at this time but the main organizer is requesting to hold the event at Freedom Plaza, the same location as the previous two events. However, this location has not been approved by NPS at this time. Additionally, the organizer has submitted a parade permit application to MPD from Freedom Plaza to the U.S. Capitol. Expected attendance according to the permit application is the same as before. We are seeing the same upticks in hotel reservations as we did for the previous two events. Some of the counter groups are also aware of this event and have posted messages on social media about countering this event.

The following website provides some information on the event, invited speakers, and hotels with room blocks. The counter groups are already sending out messages to their followers asking them to call the hotels and urge them to cancel reservations so you may start receiving calls from hotels in your AOR regarding harassing phone calls. If this occurs, please let us know.

\*No credible threats have been identified for the 6 January Event.

- Virginia Women for Trump will be having a pre-event beginning around 1400 hours at Freedom Plaza on 5 January. The main event will occur on 6 January at the Ellipse.
- Not tracking any counter protest demonstrations.
- Per Hotel partner reporting, hotels in DC are completely sold out. They are almost sold out in NVRA. MPD has a partnership with the Hotels Security Director in the event anyone needs a contact. Shut Down DC and Antifa were calling for participants to protest today at an identified Alexandria Hotel based on information that a counter group will be staying there. Alexandria Police Department are aware and tracking.
- Proud Boys indicated they will be attending the events on 6 January, however the number expected is unknown.
- Antifa is reporting on social media that they will not let their city be taken by Trump supporters and conservatives, however no plans have been identified.
- Social media reporting is urging individuals attending the events on January 6 to come armed. No threats have been identified. MPD reminded the group that at the November event, there were 5 arrests and 8 firearms recovered. MPD did not recover any firearms in the December event.
- MPD will have high visibility. CDU will be deployed at hotel, churches, 16<sup>th</sup> St. They will have zero tolerance for any criminal activity and will deescalate any situations that become heated. They will also have overt and covert surveillance.
