Dear Requester:

This letter is in response to your Freedom of Information Act (FOIA) request dated January 10, 2021 for following:

(1) All records from December 1, 2020 to January 6, 2021 relating to Department of Defense, the National Guard, or the Army providing assistance or support to the District of Columbia Metropolitan Police Department in connection with the January 6, 2021 congressional session to count electoral votes,

(2) All records reflecting the parameters for the National Guard's deployment to D.C. on January 6, 2021, including any limitations imposed on the number of personnel deployed, their movement within the District, or their use of force, and

(3) All communications with the D.C. Mayor's Office or the D.C. Metropolitan Police Department regarding the parameters for the National Guard's deployment to D.C. on January 6, 2021.

Your request was received by the National Guard Bureau (NGB) on January 22, 2021 and assigned case #J-21-0076.

A search by the Comptroller Division of NGB revealed 3 pages responsive to item 1 of your request. This office is providing an interim response to you through the Department of Justice. These records you have requested are being granted to you in part. After a thorough review of this document, our office determined that portions of it are exempt from disclosure under the FOIA, 5 U.S.C. § 552 (b)(6).

Exemption (b)(6) protects personnel, medical, and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Under this exemption, I am withholding names of Department of Defense employees below the grade of General Officer and personal information on third parties.
