Dear Ms. Weismann:

This responds to your Freedom of Information Act (FOIA)/Privacy Act request dated July 23, 2020 and received by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) on the same day, in which you requested records regarding documents and communications from June 2, 2020 to the present that explain or pertain to:

- 1. The decision to deploy federal law enforcement agents, officers, or other personnel in response to the ongoing protests over racial justice in Portland, Oregon and Chicago, Illinois:
- 2. Any decisions or plans to deploy federal law enforcement agents, officers, or other personnel in response to the ongoing protests over racial justice in Albuquerque, New Mexico; Baltimore, Maryland; Detroit, Michigan; Kansas City, Missouri; New York City; Oakland, California; and Philadelphia, Pennsylvania;
- 3. Any policies to which law enforcement officers under the auspices of ATF are bound governing the treatment of protesters in the above-mentioned cities.

This is a rolling production and this is **Release FIVE**. In response to your request, we have reviewed a total of 2,170 pages for responsiveness, of those 2,170 pages, 177 pages were found to be responsive. After reviewing those 177 pages, 23 pages were duplicative, 23 pages have been referred in full, and 138 pages are either being released to you in full, in part, or withheld in full. Of those 138 pages, we are releasing 34 pages in full, 93 pages in part, and withholding 11 pages in full. Each page of this production indicates whether it is being released in full (RIF), released in part (RIP), or withhold in full (WIF). Individual redactions identify the exemption pursuant to which the redacted material has been withheld.

We are withholding deliberative materials in the records you requested under FOIA Exemption (b)(5). FOIA Exemption 5 permits the withholding of "inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency." FOIA Exemption 5 protects advice, opinions, recommendations, predecisional discussion, and evaluative remarks that are part of the government decision-making process. Release of such predecisional advisory communications would harm the quality of agency decision-making and the policy of encouraging frank, open discussion among agency personnel before making a decision (5 U.S.C. §552 (b)(5)).

The most commonly invoked privilege within Exemption 5 is the deliberative process privilege. The general purposes of this privilege are to prevent injury to the quality of agency decisions and to protect government agencies' decision-making processes. The deliberative process privilege allows agencies to freely explore alternative avenues of action and to engage in internal debates without fear of public scrutiny (Missouri ex rel. Shorr v. United States Army Corps of Engineers, 147 F.3d 708, 710 (8th Cir. 1998)). Exemption 5 protects not merely documents, but also the integrity of the deliberative process itself, where the exposure of that process could result in harm.

We are withholding third party information, including the names of ATF employees, under FOIA Exemption (b)(6). To disclose personal information about a living individual to a member of the public, we need the written consent from the persons whose information you requested. Without written consent, proof of death, or an overriding public interest, personal information is exempt from disclosure under the FOIA. The FOIA does not require agencies to disclose information that would be a clearly unwarranted invasion of personal privacy (5 U.S.C. § 552(b)(6)).

At this time, we are withholding information regarding open and ongoing investigative matters under Exemption (b)(7)(A). Exemption (b)(7)(A) authorizes us to withhold investigatory records or information compiled for law enforcement purposes, the release of which could reasonably be expected to interfere with enforcement proceedings.

We are withholding third party information, for whom you did not provide a waiver for, under Exemption (b)(7)(C). Exemption (b)(7)(C) permits the withholding of information compiled for law enforcement purposes that "could reasonably be expected to constitute an unwarranted invasion of personal privacy." The public interest in disclosure is limited to the FOIA's core purpose of shedding light on an agency's performance of its statutory duties. The public interest under Exemption (b)(7)(C) must be both significant and compelling in order to overcome the legitimate personal privacy interests of a third party. In this matter, the disclosure would not serve the core purpose of the FOIA, but rather, would serve as an unwarranted invasion of personal privacy (5 U.S.C. § 552(b)(7)(C)).

We are withholding the specific law enforcement codes, techniques, and procedures used in our investigation pursuant to Exemption (b)(7)(E) of the FOIA. Exemption (b)(7)(E) exempts from mandatory disclosure records or information compiled for law enforcement purposes when production of such records or information "would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law" (5 U.S.C. § 552(b)(7)(E)). The information withheld reveals various law enforcement file numbers and codes, which are primarily used to store and retrieve law enforcement information. Disclosure of such numbers and codes could allow individuals outside the agency to circumvent agency functions and gain access to sensitive investigative information. The information withheld also reveals specific law enforcement procedures and techniques used in this investigation. Disclosure of such information could enable individuals outside of the agency to circumvent agency functions and gain access to sensitive investigative information.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.







Deputies contacted one of the individuals who was found to be in possession of a Glock 43 with 9mm armor piercing bullets, a Beretta

pistol, as well as an A.R. pistol with a silencer. Additionally, the individual was wearing body armor. A **search of the phone** revealed the two persons had recently been at a protest in Roseville, CA and showed conversations about **looting a gun store and shooting cops in Sacramento**, CA.






VCC Civil Unrest Data


ATF National Data of Arsons and FFL Burglary/Thefts Occurring During this Current Period of Civil Unrest

On May 29, 2020, at approx. 12:30 pm, US Army Corps of Engineer staff located damage to lower spillway of the Lewisville Dam. Lewisville Police, Fire and Lead Ranger were notified. The investigation revealed a possible homemade explosive device was detonated causing a 2.5 foot wide x 1 inch deep circle into the concrete with approximately a 100 foot long fuse. Debris was located 50 feet from the blast site. Fire Marshal notified FBI as well.

• ATF CFI and TFO responded to a structure fire at a vacant restaurant at 321E Colfax Ave (a block away from the Capitol). The fire was located on an exterior patio on the north side of the building. ATF CFI collected two fire debris samples and submitted to Denver PD lab due to overload of fire cases at ATF lab. No cameras in area facing in the right direction to capture anything. No incendiary devices found. No injuries or fatalities reported.

All- Please review this guidance document as it relates to the clear ballistic shields. Cliff notes-this shield is only for deployments in and around vehicles. It is not designed to be used during traditional building clearing and room movement. I am currently in the process of identifying a standard ballistic shield to replace our antiquated inventory of "body bunkers", most which were purchased pre-1994. More to follow on that. Lastly, SOD-TTRD (Tactical Training Research and Development) branch is also diligently working on procuring protective bags for the clear ballistic shield. Until the bags arrive, take care to protect the clear shields from scratches and abrasions, for obvious reasons.

The purpose of this memorandum is to offer operational guidance and initial instruction on the deployment of the recently issued (b)(7)(E) Shield. This shield is not meant to replace the large body bunker "traditional" ballistic shields currently in use. (b)(7)(E)

Background

During FY 2018/19 the Operational Equipment Branch (OEB) conducted testing and evaluations of ballistic shields to replace and upgrade the Bureau's current inventory. Based upon feedback from the field, the ATF National Academy, and Division Tactical Advisors (DTAs), OEB proposed a two-phase replacement plan. Phase 1 was executed and resulted in the selection and delivery of the (b)(7)(E) clear ballistic shields in the fall of 2019. Phase II of the replacement plan will result in the total replacement of the body bunker style shields that were procured mostly before 1993.








Consideration of the number of subjects, location(s) in the vehicle of the subject(s), type of vehicle, and window tinting, should dictate which agent would deploy with the shield. Training with the shield during scenario based tactical training sessions should be conducted prior to operational use.


Vehicle Stabilization

(U) Response Guidance

(U//LES) The danger posed to law enforcement officers and the general public from both IIDs and fireworks is substantial. To ensure the highest degree of safety, the following guidance is provided for first responders.

I am definitely NOT an attorney, but this is from my experience thus far working in A&E groups and as a CFI, as well as talking to other CFI's within our ATF Community, and after speaking with Brendan Day from the US Attorney's Office in Trenton. This is certainly a new situation for everyone, so much of this below information is new to our ATF CFI community.

It is always important to advise the USAO of the likely requirement to obtain an origin and cause report since many Assistant US Attorneys and other federal law enforcement partners, are not familiar with charging arson cases. Additionally, educating them on the scientific method investigation process, NFPA 1033 and 921, fire cause and classifications, and the need to attempt to identify an ignition source and a first fuel, as well as how those two came together (even with clear video depicting the arson), is paramount.

The charge of 18 USC 844(i) (Destroys or Damages any Real Property by means of Fire) requires an interstate nexus to charge it...businesses, schools, some houses of worship, banks, etc. It would be difficult to charge this on a vehicle or residential fire, except with some mitigating circumstances that CFI's are aware of. For "normal" residential fires (no business, no clear fraud charges at the outset, etc.), this charge would likely be difficult to prove and therefore, less likely to charge at the USAO level. Even though a police vehicle (for example) may have been partially paid for by government funds, many district court judges may find it (and have found it) to be a huge stretch to say that a particular municipal vehicle or residence is involved in Interstate Nexus. depending on the jurisdiction. The US Attorney's Office has argued that other district courts have said that police departments talk to other law enforcement agencies, speak to sources outside the state, and occasionally travel outside the state, and therefore fires to police vehicles may qualify for this charge. As a result, they HAVE charged this in New Jersey for the recent police vehicle fires in Trenton during this civil unrest, citing these afore-mentioned case laws. There have been at least 3 police vehicle fires on record where this charge has been used prior to New Jersey. Two of them have been in New York over the past couple of weeks and both involved Molotov cocktails. The other one was from Georgia in 1997 and involved a bomb placed underneath a police vehicle.

Therefore, none of them were strictly "fire" incidents, but incorporated an explosive-related device.

The charge of 18 USC 844(f) (Damages or Destroys Government Owned Property by Fire) requires federal funding to have been used in the purchase of the police vehicles. The AUSA found two cases on this at the federal appellate level, and they are split on whether or not this charge can be used. The 10th Circuit says that if the police department receives ANY federal funding, then a police vehicle would qualify as a "federally funded" police vehicle and therefore qualifies. The 1st Circuit said that any federal funds received by the department would have to be specifically earmarked to purchase police vehicles, and therefore this charge would likely not be supported (unless the federal funds were specifically designated for this purpose). Similarly, the NJ USAO DID charge this as well for the Trenton police vehicle fires. (b)(5)

Finally, as another CFI in our community has stated, 18 USC 844(h) (Using fire or explosion to cause any felony) MAY qualify if the underlying charge used is 18 USC 231(a)(3). That latter charge is an old Civil Disorder charge and, according to our Division Counsel (see below), must be charged by the FBI. There has been supposed success with it in pleading out cases to civil disobedience crimes (and dropping 18 USC 844[h]) because defendants don't want to risk the 10-vear sentencing enhancement. 
"De-Escalation. When safety, time, circumstances, and law enforcement priorities reasonably permit it, special agents should use verbal persuasion, warnings, or other tactics (such as repositioning to increase distance or gain cover) to attempt to gain voluntary compliance from suspects. Special agents should consider whether a suspect's lack of compliance is a deliberate attempt to resist or an inability to comply based on factors such as medical conditions, mental impairment, developmental disability, physical limitation, language barrier, drug interaction or behavioral crisis. De-escalation, however, does not replace necessary, proportional, and objectively reasonable force as an available option for special agents to safely resolve situations









FINAL THOUGHTS

- ☐ For years, law enforcement has used these techniques. An old police adage is an "officer would rather talk someone into the backseat of the police car rather than to have to use force."


Use of Force by Special Agents





I spoke with the FBI and ASAC Kamentz this morning. The Tampa FD has The Chief had a conference call with DAD Watson and SAC McCrary. Below is the plan:

The RNC is August 25-27 and is now a National Security Special Event (NSSE); therefore a federal official is responsible for the overall security.
