(LES) **“The Federal Invasion”**: As riots and vandalism escalated in Portland, Oregon, a number of different federal agencies were deployed to support the Federal Protective Service (FPS) whose mission is to protect the federal buildings in the city. Officers were deployed from the U.S. Marshals Special Operations Group and U.S. Border Patrol’s elite (b)(7)(E) tactical unit to support and supplement FPS personnel to safeguard the federal building. Anarchists refer to this as a “Federal Invasion”. In response to President Trump stating that he is considering sending federal officers to other cities the PNW Youth Liberation Front and other anarchist organizations in Portland posted a July 25th call to action. Rallies have been organized for July 25th in various cities at Federal Courthouses, City Halls and an FOP Lodge.

(LES) **Violence Against Federal Officers in Portland**: For the past 54 days violent anarchists targeted the Hatfield Federal Courthouse and federal law enforcement officers in Portland. Attacks on federal personnel and property have included violent attacks on federal officers with weapons as well as efforts to start fires at the Hatfield Federal Courthouse with federal law enforcement officers inside the building. Officers have been hit with frozen water bottles, rocks and other objects - some of them incendiary, had paintballs spatter their face shields, and been harassed with red, green and purple lasers which can cause permanent blindness. A CBP Officer was injured when he was struck with a projectile from a suspected wrist rocket. Border Protection Acting Commissioner Mark Morgan stated “They come prepared every single night with deadly weapons, commercial-grade fireworks, lasers, frozen water bottles, rocks, and hammers.” “Just the other night, they established a plywood barrier that they inserted nails and put it up against one of the doors so that if a federal agent came out, they would come in contact with the nails and seriously injure themselves,” “We recently discovered what is allegedly a pipe bomb in one of the satchels.”

A plan was created to replace the boards across the front of the Hatfield entrance, securing them to the frame and ground.

By 04:30, all protesters had been cleared from the area and USMS and FPS forces began to shut down the night operations.

FPS will have additional resources available through the weekend. A 12-man (b)(7)(E) team, along with FPS, will be stationed at Hatfield this weekend to assist in protest operations.

The protesters, once again, focused on the Hatfield courthouse, breaking one window, attempting to remove plywood from the exterior, painting over two cameras, and shattering both of the remaining from doors.

At approximately 21:30, 150 protesters were gathered out in front of the courthouse. The numbers grew to well over 200 before they departed the area of Hatfield and marched down to the waterfront. They listened to speakers at the water front and made their way back at approximately 22:30. Protesters marched west on Salmon Street before stopping in front of the Hatfield courthouse. Protesters began knocking and banging on the doors of Hatfield and trying to look inside the lobby. USMS and Border Patrol (b)(7)(E) team members stayed out of sight in an effort to avoid riling the protesters.

Reports came out from PPB that an individual in a grey sedan, that was parked in front of Hatfield, had brandished a small handgun and pointed it at the courthouse. We were unable to get a camera shot of the vehicle due to trees blocking the view. The sedan eventually sped off and was trailed by PPB Air 1.

The protesters, once again, focused on the Hatfield courthouse, breaking one window, attempting to remove plywood from the exterior, painting over two cameras, and shattering both of the remaining from doors.

At 00:51, an individual wearing a black jersey with white number "52" was seen throwing a projectile to an upper window, above the plywood, at Hatfield. The projectile broke the outside pane of glass, but the inner pane remained intact. Protesters continued to test the doors of Hatfield. Approximately 300 protesters blocked 3<sup>rd</sup> ave between Salmon and Main. Fights were sporadically breaking out amongst the crowd. One live streamer stated the atmosphere was more like a party with multiple individuals drinking heavily and acting drunk.

After not receiving a response at Hatfield, protesters moved in front of the JC. Mortars were being shot at the JC and Hatfield most of the night. Protesters acquired barriers and fencing from the construction site on 3<sup>rd</sup> and Salmon and began creating a border across main and 3<sup>rd</sup>. By 03:00, protesters set a wooden picnic table on fire just north of 3<sup>rd</sup> and Main, about 50 protesters remain. Approximately 8-10 individuals walked over to Hatfield and began violently kick and knocking on the front doors. Eventually protesters were able to shatter the north doors and South doors. Protesters leaned past the threshold to yell at USMS and BP personnel but did not fully enter the building. USMS and BP used diversionary munitions to push the protesters back across the street. PPB responded and USMS and BP deployed from the building to assist.

Protesters were eventually pushed back to the west side of the park and held until Board Up could arrive to secure the open door ways. USMS and BP assisted in holding the line until 06:15.

By 07:22, less than 10 individuals remained in the area and Board Up continued to shore up the perimeter.

Multiple protesters stated the night of the fourth is when they are bring the fight to law enforcement and "burning it down."

Activity Summary 07/05/20

Tonight was much more low-key than the previous two. The contractors boarding the front windows took a bit more time than anticipated and were working late into the evening. A report came out that protesters in Lownsdale Park were throwing fireworks at the vans of the contractors.

SOG and (b)(7)(E) exited the building to push individuals to the west to ensure the safety of the contractors. While holding the line for the contractors, SOG and (b)(7)(E) began taking multiple laser strikes. Individuals were located and arrests were effected. Two were taken into custody. It was reported that a female was at the elk statue holding a large knife to her neck. SOG team tased the lady and were able to hold the scene until AMR and PPB were able to assist.

Around 01:00, SOG and (b)(7)(E) deployed again to attempt to arrest a protestor for using a green laser on the eyes of law enforcement. One in custody.

**Overview:** Weeks ago we were seeing thousands of protesters and experiencing numerous incidents of vandalism and attacks with rocks, bottles, launched projectiles, etc, and repelled numerous attacks on federal facilities by skirmishing with rioters, but lacked sufficient forces to move into large crowds of anarchists and make arrests. We currently have that capability. Once we started putting consequences on violators, unlawful activity reduced dramatically and is less often directed against federal facilities and LEOs as the anarchists are learning that federal LEO will not tolerate their misconduct. The majority of crime is now happening off property where local elected officials have ceded control of parts of the city to violent anarchists and other lawless elements during hours of darkness. Every night dramatic video is coming out of Portland of lawless behavior that is happening near the Hatfield USCH, Edith Green Wendell Wyatt Building, Pioneer USCH and other facilities, but the majority of this crime has no federal nexus and we lack jurisdiction and authority to make arrests.

**Potential for Additional Arrests:** Shrinking sizes of protests, lower numbers of hostile actors, and fewer crimes against federal LEO will likely result in fewer enforcement opportunities. In the 9<sup>th</sup> circuit it is very difficult to get convictions for 18 USC 111 Assault on a Federal Officer unless that officer experiences a significant injury. Making custodial arrests for laser attacks is a very aggressive approach and may not be successful in court but we feel these arrests are important for protecting our officers and disrupting criminal activity. Also, we are booking arrestees into the Multnomah County Jail via a contract they have with the USMS. We may be able to make more arrests for minor Title 41 USC CVB violations such as littering, failure to comply etc. We have historically dealt with these by cite and release. I will take up possibility of lodging these type offenders into jail but they aren't likely to meet Multnomah County booking standards with COVID health requirements in place.

**First Amendment Protected Activity:** FPS conducts safe, legally-defensible, constitutionally-sound police work that is content neutral in accordance with the US Constitution and existing public order policing case law. The vast majority of protesters in Portland Oregon are engaging in constitutionally protected free speech/free assembly activity even if it is disruptive or objectionable. We are using tactics and techniques that build and maintain the credibility of FPS, DHS and the DOJ, by only conducting enforcement operations on individuals who are violent, destructive, and in my opinion, attempting to subvert these lawful protests for their nefarious purposes. I believe there is an opportunity to build community support for our actions by calling on elected officials and other influential figures to draw a clear distinction between these groups and assist us in dealing with the violent elements while protecting the constitutional rights of the others.

**Background:** Once we received the DHS partner support I requested for Operation Diligent Valor we put a large contingent of DHS LEO at the Hatfield USCH on July 3<sup>rd</sup> and made a plan to deal assertively with lawless behavior. We were countermanded by the USMS, who are the ISC Designated Official for that building, and have primacy for making security decisions. They desired to continue a de-escalation posture they had been taking for 4 weeks. Both FPS and (b)(7)(E) were frustrated as we watched lawless and destructive behavior going on around us. On the morning of July 4<sup>th</sup> I pressed the USMS and other

partners for a more assertive approach and FBI SAC Renn Cannon and I collaborated on a plan that I then briefed to (b)(7)(E) and Portland Police, USMS, and the US Attorney's Office, and got concurrence. Only July 4<sup>th</sup> we implemented the joint plan which involved LEO who had never worked together previously conducting operations outside of their training, experience, and traditional mission set. Given these complexities the operation was highly successful and we have now improved on our tactics and coordination significantly.

#### **Operational constraints:**

- Anarchists dress in “black bloc” deliberately to make identification and arrest difficult. The observation site used by the joint PPB/DHS/FBI team on July 4<sup>th</sup> left some areas of the parks obscured by vegetation. The building was also identified by anarchists and attacked and we had to relocate the teams to the Hatfield USCH. We made investigative detentions of several individuals that we later did not believe we had a strong enough identification of to book into jail.
- Anarchists also use tactics such as obscuring movements behind umbrellas, shields and vegetation, and changing clothes after committing crimes to avoid detection by law enforcement. They coordinate their movements by communicating with encrypted apps and radios.
- Due to it being the first time (b)(7)(E) and FPS had worked together jointly and no interagency comms we had to do radio swaps (19 years after 9/11 report) it took time to master coordinating movements to coordinate flanking and pincer maneuvers.
- On July 5<sup>th</sup> we increased use of (b)(7)(E) marking suspects with IR lasers and had a better observation post which led to making positive identifications with improved accuracy and vector in snatch teams with team leaders who have NODs. We also maneuvered more squads on foot and were able to conduct several pincer type maneuvers to cut off routes of suspects attempting to flee. Improved tactics and communications resulted in a much more efficient operation but we had fewer anarchists and less attacks against federal officers on July 5<sup>th</sup> which accounted for the fewer arrests.
- Arrests for “probable cause” rely on a 51% legal standard, a preponderance of the evidence. When making on-view arrests for probable cause it happens frequently that this standard is met for arrest by police but prosecutors don't believe we will be successful in court, where the “reasonable doubt” standard is in place and instruct LEOs to release the subject.
  - Example – we arrested a subject for a laser attack who threw their laser during a foot chase. Given the chaotic situation we were not able to recover the laser but believed we had PC based on the strong victim and witness accounts. The US Attorney's Office did not believe this would be a successful prosecution without the physical evidence and told us to release them. I am meeting with the FBI and AUSA today and will ask if we can relook this case. (only one case like this, the others released were either minor crimes suitable for citations or weren't sufficiently strong IDs).



SUBJECT: DHS Support to Protect Federal Facilities and Property

---

**Purpose:** The purpose of this memorandum is to provide guidance for direct support to the Federal Protective Service and our interagency partners to protect all federal facilities and property.

**Introduction:** The Department plays a key role in protecting Federal facilities and property primarily through the Federal Protective Service (FPS) and in partnership with other DHS law enforcement Components, interagency partners, and state and local partners. Recently, we have seen numerous instigators, criminals and other bad actors use peaceful protests to harm people and property, both Federal and private. For the past month, these bad actors have continued their unlawful activity which has resulted in numerous threats, disruption, and damage to Federal facilities and property.

**Background:** On June 26, the President issued the following Executive Order: Protecting American Monuments, Memorials, and Statues and Combating Recent Criminal Activity. In this order, the President directed that DHS “shall provide, as appropriate and consistent with applicable law, personnel to assist with the protection of Federal monuments, memorials, statues, or property.”

In furtherance of this directive, I have formalized the DHS Protecting American Communities Task Force (PACT) to provide an ongoing assessment of potential civil unrest and property destruction and to address internal resource allocation and potential surge activity to ensure the continuing protection of people and property.

Additionally, with the consent of other Departments and Agencies, I have determined that it is in the public interest and fiscally sound for FPS to partner with other federal law enforcement to execute the direction of the President. To that end, DHS began coordination with the Department of Justice (DOJ) and the Department of the Interior (DOI) to establish information/intelligence sharing and resource coordination as outlined in the order.

**Action:** The upcoming July 4<sup>th</sup> holiday weekend has the potential for increased disruptive activity at specific locations across the country that could threaten our personnel and the Federal facilities and property they protect. DHS will be forward leaning in preparing to protect Federal facilities and property.

Components with law enforcement personnel will coordinate with the Office of Operations Coordination and the FPS to:

1. Pre-position PACT Rapid Deployment Teams (RDT) or their equivalent (with appropriate training, equipment, and command and control) at each of the following locations: Portland, OR; Seattle, WA; and the District of Columbia, no later than 2 July to be used in a reserve force role.
2. Provide regional RDT's on standby to be used as a strategic reserve that can deploy within 6 hours of notification by the Department and to any location in the United States. The RDTs should be available by 2 July.
3. Complete cross-designation consent and the appropriate training with FPS to legally allow Components to support the protection of Federal facilities and property. This action must be complete prior to 2 July.

DHS' Office of Operations Coordination will continue to facilitate Department-level information sharing, reporting, and all other supporting actions across the Components and with our DOJ/DOI partners. FPS will continue to serve as the Department's lead for the protection of Federal facilities and property and shall be supported by Operational Components and all other DHS organizations.

Components should use existing guiding principles and risk assessments in support of this mission, ensuring the safety and security of our personnel.

With the consent of the Deputy Director and Senior Official Performing the Duties of the Director of U.S. Immigration and Customs Enforcement (ICE), and pursuant to my delegated authorities from the Under Secretary of Management, as memorialized in DHS Delegation No. 02500 § II(D) (Dec. 18, 2019) and Title 40, United States Code, Section 1315(b)(1), I designate you as a law enforcement officer for duty in connection with your support of the Federal Protective Service (FPS) in the protection of federal property and persons on the impacted federal property that are under FPS's protection responsibility.

This designation is limited to law enforcement functions on the federal property assigned to you by FPS. This designation expires 60 days from the date of my signature.

While engaged in the performance of official duties, you have the authority to use the following police powers:

“You are authorized to conduct investigations; require and receive information relating to offenses; serve and execute search and arrest warrants; serve subpoenas and summons; administer oaths; make arrests without warrant; take actions to preserve the peace while protecting federal government facilities and personnel; bear firearms; and perform other activities for the promotion of Homeland Security in accordance with Title 40 United States Code Section 1315 as created by the Homeland Security Act of 2002.”

Prior to utilizing this authority, you are required to receive legal briefings provided by FPS legal advisors on 40 U.S.C. § 1315 authorities and jurisdiction, to include relevant criminal statutory and regulatory provisions enforceable on the federal property.

#### D/OR Portland Courthouse Activity Summary 07/06/20 (Monday)

At approx. 8:30 pm, approximately 200-250 protesters were gathered in front of the Justice Center (JC), Hatfield federal courthouse, and Chapman park. Protesters were lighting fireworks in the park, nothing directed towards the courthouse, some limited green lasers being aimed at the JC and Hatfield courthouse. The main group stayed across the street and occasionally small groups would hang out at the street corners near the JC and Hatfield courthouse on SW Third Ave.

At approx. 9:30 pm SW Third Ave. was blocked by vehicles and protesters. The group was focused in front of the Hatfield courthouse with some barriers being put up at the intersection of SW Third Ave and SW Salmon Street, the majority of protesters stayed on SW Third Ave. and remained off the courthouse property.

At approx. 9:45 pm, members of (b)(7)(E) providing overwatch on the 7<sup>th</sup> Floor of the courthouse were observed by protesters and soon protesters began aiming green lasers at them. There were approx. 8 individuals shining the lasers from Chapman park.

11:30 pm – Via livestream feeds it appears some protest group leaders had a discussion in the middle of SW Third Ave about staying away from the federal courthouse and decided to focus their attention at
