Dear Mr. Sus:

The Department of Defense ("DoD"), Office of Information Counsel, is providing a second response to your January 10, 2021 Freedom of Information Act ("FOIA") request to DoD. You requested, in part, "All records reflecting the parameters for the National Guard's deployment to D.C. on January 6, 2021, including any limitations imposed on the number of personnel deployed, their movement within the District, or their use of force."

76 pages are enclosed, of which four (4) pages are released in full. The remaining pages contain information has been withheld from release under 5 U.S.C. § 552 (b)(5), which pertains to certain inter- or intra-agency communications protected by the deliberative process and/or attorney-client or attorney work product privileges; (b)(6), which allows for withholding information that if disclosed, would result in a clearly unwarranted invasion of the personal privacy of individuals; and (b)(7)(E), which allows for withholding information that if disclosed, would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law.

Additional monthly productions will be made as we continue to coordinate the review of the remaining responsive documents DoD has in its possession.

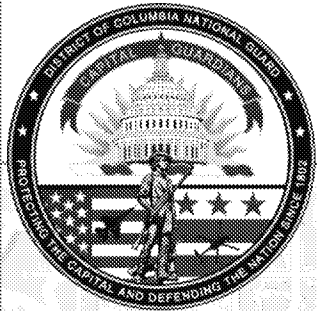

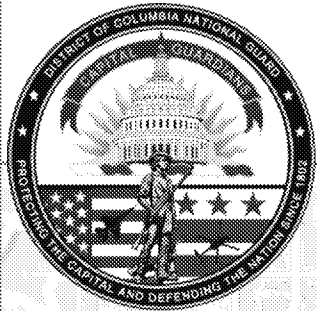

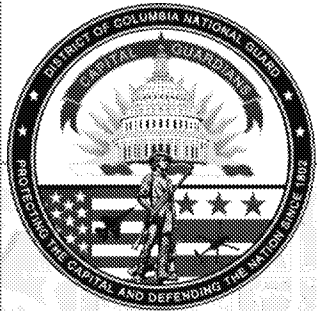
