National Demonstrations Related to George Floyd Incident

6/4/2020

Topic: National Demonstrations Related to George Floyd Incident. Capture Event # (b) (7)(E)

Background: The May 25, 2020 death of George Floyd, Minneapolis, Minnesota, and the subsequent video circulating on social media depicting a police officer kneeling on Floyd’s neck on the ground while Floyd stated he couldn’t breathe has sparked nationwide protests this week. Some of these protests have turned confrontational and has led to looting, arson, and riots, and calls for violence against law enforcement officers.

USMS personnel have been asked to provide assistance to impacted areas. The TOD Office of Emergency Management has been asked to request, collect and report up on the operational status/impact of those Districts/Divisions involved. The TOD Joint Operations Command Center (JOCC) has been activated and is ready to receive information and to provide assistance as needed.

- **Eastern District of California (Sacramento)**

- There has been continuous protest and looting near the Robert Matsui Federal Courthouse.
- In response to gathered intel, the district will have personnel assigned to be in the courthouse in preparation for the scheduled protests. The National Guard is in Sacramento and will provide additional support to local law enforcement and USMS. In addition to deputies, (b) (7)(E) CSOs will be assigned to the control center and an FPS-Guard will be roaming the interior of the building.

- **Central District of California (Los Angeles)**

- There were several mass gatherings scheduled for June 3, 2020. The community tension appears to be on a downward trend of de-escalation.

- **Northern District of California (Oakland)**

- (b) (7)(E) deployed to the Oakland Federal Building and Courthouse to assist FPS in facility security.
- The PSWRFTF has dispatched (b) (7)(E) to the district who will assist in deconfliction efforts with Alameda County Sheriff's Department.
- MCV-West is staged for demonstration activities and RAM deployment.

- MCV-West is currently operating 24/7, assisting in the investigation involving shooting of FPS officer.
- **Western District of Kentucky (Louisville)**
 - Louisville is experiencing the most protests and violence (the Breonna Taylor shooting). The District has [REDACTED] DUSMs remaining after the deployment of a [REDACTED] [REDACTED] (b) (7)(E) to conduct district activities. The District will be starting normal court operations next week.
 - **The District may be requesting additional USMS resources.**
- **Eastern District of Louisiana (New Orleans)**
 - E/LA currently has [REDACTED] (b) (7)(E) DUSMs assisting the New Orleans Police Department as a tactical response team and providing intelligence.
 - Protests scheduled daily for the next five days in Orleans Parish. Last night approximately 2500 participated. All protests have been non-violent.
- **District of Massachusetts (Boston)**
 - **On June 3, 2020, the Boston Police Department received information that ANTIFA or a similar group may be en route to the Moakley Federal Courthouse. The district is seeking to corroborate the information with local authorities, FPS and the JTTF.**
- **District of Minnesota (Minneapolis)**
 - **VPOTUS will be in Minneapolis on Monday, June 8, 2020.**
 - **The District is requesting a second rotation of DUSMs. The District is requesting the detail be staffed until June 13, 2020. IMT is currently working on fulfilling the staffing request.**
 - The District has been requested to provide security for the ATF during arson investigations. A coordination meeting will take place on June 3, 2020, to determine the date range that USMS assistance will be utilized. The mission will be staffed by [REDACTED] DUSMs. The ATF has approximately 87 fires to investigate.
 - A bond hearing will be held June 8, 2020, for former officer Derek Chauvin. This hearing may cause more disturbances.
 - USA Erica MacDonald and the State AG will be meeting with the Floyd family in the next 48 hours.
 - George Floyd Memorial is scheduled for Thursday, June 4, 2020, at 13:00.
- **Western District of Washington (Tacoma)**
 - **On March 3, 2020, Manuel Ellis died during an arrest conducted by the Tacoma Police Department. The cause of death has been ruled as a homicide with the cause of death of hypoxia due to physical restraint with the underlying factor of extreme methamphetamine intoxication. The video is expected to be officially**

released next week but may reach the public domain sooner. The media interest in the case is gaining momentum.

- **Eastern District of Wisconsin (Milwaukee)**
 - Milwaukee DUSMs will deploy with the Milwaukee Police Department June 3, 2020, to assist with planned protests.
- **Western District of Wisconsin (Madison)**
 - Madison has experienced its third straight night of rioting and looting in the downtown area. The courthouse is located one block off State Street which has been the hardest hit area. So far, the District has only experienced graffiti at the courthouse.

- MCV-West is currently staffed with (b) (7)(E) personnel and supporting N/CA located at Coast Guard Island.
- (b) (7)(E) DC
 - (b) (7)(E) members continue to support USPP on various missions without incident.
 - (b) (7)(E) reported significant security enhancements were made at Lafayette Square.
- (b) (7)(E) MN
 - (b) (7)(E) coordinated with JSD OPO regarding aiding protection details.
 - VPOTUS will arrive in Minneapolis on June 08, 2020. (b) (7)(E) is coordinating with USSS.
 - A protest of approximately 500 individuals was conducted protest at Hennepin County Jail, which is located one block from the Federal Courthouse.
 - FBI is conducting interviews throughout the city in accordance with the AG's guidance on investigating the riots. During the course of the interviews, one FBI Agent was assaulted. They are requesting assistance from the USMS to possibly provide additional security for their interview teams. They are currently preparing for various interviews for June 4, 2020.
 - The memorial for George Floyd will occur on June 4, 2020, at North Central University located 5 blocks from the Federal Courthouse. It is scheduled from 13:00 until 15:00.

- **Northern District of California (San Francisco)**

- (b) (7)(E) promoted damage to police and government facilities. (b) (7)(E) provided suggested props and supplies.

- **Northern District of Illinois (Chicago)**

- A decrease in violent activity has led to the opening of bridges and other forms on transportation on June 3, 2020.

- **District of Minnesota (St. Paul)**

- An unidentified cyber actor compromised the network of the Senate of the State of Minnesota. Passwords were publicly posted referencing “#justiceforFloyd.”
- A total of 612 arrest have been made since May 29, 2020.
- Former Minneapolis police officer Derek Chauvin’s charges have been upgraded to 2nd Degree Murder. The other three former officers have been charged with aiding and abetting 2nd Degree Murder on June 03, 2020.

- **Southern District of New York (New York City)**

- On June 4, 2020, a march is scheduled to occur at approximately 13:00 at the Camden Plaza Park, which is adjacent to the Eastern District of New York Courthouse, and end in the Southern District of New York.
- NYPD has made 1500 arrest since the beginning of the period of civil unrest.
- NYPD has reported fewer arrests since in the period after the curfew was established at 20:00.

- **District of Oregon (Portland)**

- DUSMs have begun assisting Federal Protect Services (FPS) in securing the safety of the interior of the building 24 hours a day.
- Groups of disruptive protestors and rioters have routinely been in the hundreds to thousands. Portland Police and the USMS deputies are greatly outnumbered. The protestors/rioters have assaulted law enforcement with fireworks, frozen water bottles, rocks, bottles, batteries, and

Molotov cocktails. The Justice Center has been set on fire and they have attempted to start other buildings and facilities on fire.

- USMS is protecting the interior of the courthouse with minimal manning. Exterior operations are minimized to officer down situations at this time.

- **District of Columbia**

- (b) (7)(E) active duty troops remain in the Washington, DC area to assist the civil authorities if necessary. No active duty troops have been deployed as of now. The troops remain on heightened alert and under Title X authority and therefore are not participating in defense support to civil authority.

- **JSD Divisions**

- OPI maintains 24/7 support in coordination with USMS Comm. Center and JOCC.
- SecEd Detail is supporting ad hoc DOJ operations.
- TMC OSINT team continues to support multiple districts and details with information concerning planned protests and demonstrations that may impact USMS protected persons and facilities.
- OPI continues to monitor the protests taking place in the Washington Metropolitan Area to assess how they may impact operations.

- **DAG Detail**

- The DAG detail is coordinating with Main DOJ for protective activity in the DC area.
- The DAG detail is providing ad hoc protection for AAG Advocates with transport to and from the DOJ in addition to the customary DAG protection.
- The DAG Detail returned to DOJ on June 03, 2020, and is currently managing the DOJ response to the civil unrest.
- (b) (7)(E) .
- OPI has assigned an IRS to handle all intelligence related to the DAG Detail. The IRS is scheduled to provide on site support from (b) (7)(E) daily.
- The BOP SORT Team, that AG Barr has directed to protect DOJ, has assigned team members to support the DAG Detail as needed.

- **DOJ Attorney Detail**

- (b) (6), (b) (7)(C), (b) (7)(F) is leading the DOJ Attorney ad hoc Protection Detail requests.

- The detail has formalized and relayed a protocol to OAG staff attorneys for moving their personnel through the active protest area.
- **Other Notes**
 - FBI HRT has a large contingency staged at FBI HQ. Part of their current assignment is to provide DOJ with an additional Quick Reaction Force in case of a major incident.

 - The USSS continues to have a large perimeter, to include road closures, around the White House.

- **OCAG, CARFTF, SOIB, and IIB**

- CARFTF provided support for the escort of National Guard resources to Andrews Air Force Base.
- CARFTF along with the support of NCR District personnel, OCAG, SOIB, and IIB continue the mission of supporting the US Park Police in various hotspots throughout the District.
- The current efforts focused on four specific areas of operations:
 - CARFTF personnel at Lafayette Park/White House supported USPP and the USMS Special Operations Group in maintaining security in front of the White House.
 - CARFTF requested IIB support to provide staffing at the Metropolitan Police Department’s JOCC.
 - A District of Columbia Superior Court team assigned to CARFTF was assigned to augment the Park Police’s force protection efforts at the Anacostia station.
 - A request for additional medical support and resupply has been approved. A USMS Operational Medical Support Unit doctor and medics are on scene and have deployed.

Risks/Challenges: Damage to property and continued targeting of law enforcement personnel.

According to Homeland Security Intelligence Report, in the aftermath of the death of George Floyd on May 25, Current and Emerging Threats Center (CETC) is tracking incidents of violence against US Law Enforcement Officers (LEOs) and subsequent arrests (to include arrests of individuals who traveled out-of-state) stemming from the civil unrest. CETC has compiled the below numbers from information being shared by federal, state and local partners as well as press reporting. CETC estimates the official number of LEOs injured and the official number of arrests made is significantly higher. CETC is working with our partners across the U.S. to obtain additional information.

On June 2, 2020, the FBI Norfolk division received information indicating the Richmond Federal Courthouse exterior walls were spray painted with a thick black line around the entire exterior. The black line has been identified as a marker by anarchist/ANTIFA to designate targets for potential acts of vandalism/arson. The previous day, unidentified individuals were overheard discussing the Richmond Courthouse as a target for arson. The individuals were believed to be members or associates of a local anarchist/ANTIFA group.

Next Steps: TOD OEM will continue to staff the JOCC, obtain SITREPs from Districts/Divisions, and provide Executive Briefings as requested.

SITUATIONAL AWARENESS

- E/MO and (b) (7)(E) assisted SLMPD in the arrest of the suspected murderer of retired Police Captain Dorn on Monday night. USMS is assisting SLMPD with surveillance and anticipated arrest of the suspect wanted for shooting at four police officers on Monday night (June 1, 2020).
- E/MO (St. Louis) – On June 7, 2020, there will be a protest with an estimated 4,000 individuals at the Mayor’s office, which is one block from the U.S. federal courthouse. This organizer was responsible for the protest on June 1, 2020, which resulted in the shootings, murder, fires, and looting. The protest group has been observed photographing the federal courthouse. Additionally, a large gathering of *pro-police* demonstrators has been announced for the same time and location as the anti-police protest.
- S/TX (Houston) - A public memorial will be held on Monday, June 8, 2020, in Houston, TX. On June 9, 2020, a private ceremony will be held for friends and family in Houston, TX.
- NCR – A deployed DUSM experienced symptoms consistent with dehydration and was released early for rest and recovery on June 6, 2020.
- NCR – FBI relayed intel that 4 protests are scheduled on June 7, 2020. They also report there are a total of 11 protests scheduled across Northern Virginia on June 7, 2020.

National Demonstrations Related to George Floyd Incident

June 7, 2020

Topic: National Demonstrations Related to George Floyd Incident. Capture Event # (b) (7)(E)

Background: The May 25, 2020 death of George Floyd, Minneapolis, Minnesota, and the subsequent video circulating on social media depicting a police officer kneeling on Floyd’s neck on the ground while Floyd stated he couldn’t breathe has sparked nationwide protests this week. Some of these protests have turned confrontational and has led to looting, arson, and riots, and calls for violence against law enforcement officers.

USMS personnel have been asked to provide assistance to impacted areas. The TOD Office of Emergency Management has been asked to request, collect and report up on the operational status/impact of those Districts/Divisions involved. The TOD Joint Operations Command Center (JOCC) has been activated and is ready to receive information and to provide assistance as needed.

- **District of Arizona (Phoenix)**

- D/AZ Phoenix assigned a team consisting of (b) (7)(E) DUSMs, (b) (7)(E) FPS Officers, and (b) (7)(E) U.S. Secret Service Agents to the SDO Courthouse to monitor protest activity from 16:30-20:30. Approximately 2,000 people peacefully protested in the area, and departed by the 20:00 curfew.

- **District of Columbia**

- All agencies prepared for the One Million Persons demonstration on June 6, 2020 at the Lincoln Memorial. Intel suggested a full protest route of Lafayette to U.S. Capital to DOJ Main Justice to Lincoln Memorial. DCSC (b) (7)(E) and SWIFT assisted with required movements for personnel inside the building.
- FBI intelligence reports that there are four separate protests scheduled June 7, 2020, as well as 11 protests scheduled in Northern Virginia.

- **Middle District of Florida (Jacksonville and Orlando)**
 - Hundreds of protesters marched in Jacksonville with activity within three blocks of the federal courthouse. No incidents reported.
 - Hundreds of peaceful demonstrators in Orlando with activity within two blocks of the federal courthouse. No incidents reported.
- **District of Hawaii (Honolulu)**
 - (b) (7)(E) DUSMs were deployed to the U.S. Courthouse and Federal Building in Honolulu. A march with an expected attendance of over 3,000 individuals are marching to the state capital and possibly the Federal Building. No significant incidents reported.
- **Northern District of Illinois (Chicago)**
 - On June 6, 2020, approximately 30,000 protesters marched through Wicker Park, Old Town, and River North areas of Chicago, IL near the Federal Courthouse. No incidents reported.
- **Southern District of Indiana (Evansville)**
 - On June 6, 2020, approximately 400 protesters marched in Evansville and gathered approximately one block from the Federal Building/U.S. Courthouse. No incidents reported.
- **Northern District of Iowa (Cedar Rapids)**
 - On June 6, 2020, a large protest involving approximately 1,000 people occurred in Cedar Rapids within 5 blocks of the federal courthouse.
- **Eastern District of Louisiana (New Orleans)**
 - E/LA continues to support NOPD SOD with (b) (7)(E) and (b) (7)(E).
- **Western District of Louisiana (Lafayette)**
 - Multiple protests/demonstrations occurred in Shreveport on June 6, 2020. The largest group calling themselves a “March Against Police Brutality” is expected to consist of 1,300 protesters and was originally scheduled to take place at the Shreveport Federal Courthouse. The march proceeded through downtown Shreveport. Simultaneous to this event, a group claiming to be 2nd Amendment supporters with militia ties staged at the old Confederate Memorial at the Caddo Parish Courthouse. The stated purpose was to protect the monument. The group organizer advised that the group consisted of a large number of open carry participants.

- **District of Minnesota (Minneapolis)**
 - No significant incidents to report.
 - VPOTUS will be in Minneapolis on June 8, 2020.
 - A bond hearing will be held June 8, 2020, for former officer Derek Chauvin. This hearing may cause more disturbances.
- **Eastern District of Missouri (St. Louis)**
 - On June 7, 2020, there will be a protest of approximately 4,000 people scheduled at the Mayor's Office, one block away from the U.S. Courthouse. This is the same group that held protests June 1, 2020, which led to the shooting incidents, fires, a murder, and looting. The District has received intelligence that a group involved in the rioting and looting has been photographing the U.S. Courthouse. Local police have asked for assistance from the USMS in regards to warrant service and riot control if needed. National Guard has been activated and is stationed at every police department, fire department, and local government buildings.
- **Western District of New York (Buffalo)**
 - (b) (7)(E) DUSMs continue working courthouse security do to on-going demonstrations. Immigration ERO Special Response Team and FPS have also been providing assistance.
- **Southern District of Ohio (Dayton)**
 - The group Racial Justice Now led a protest on June 6, 2020. The attendance was estimated in the range of 200-300. The protest did not approach the federal courthouse, but a pallet of bricks and several water bottles, which were believed to be filled with cooking oil, were discovered within one block of the protest.
- **District of Oregon (Portland)**
 - During an early morning check on June 5, 2020, GSA located a bullet on one of the overhangs at the Hatfield Courthouse. Early this morning June 6, 2020, the federal security team noticed that one of the courthouse windows had shattered but was still intact. The window had been hit with some type of projectile and both PPB and FBI are investigating the matter.
 - The district has received assistance from both Bureau of Prisons (BOP) and Border Patrol. On June 5, 2020, the D/OR deputized (b) (7)(E) BOP personnel and (b) (7)(E) Border Patrol Agents and conducted reaction walkthroughs should the team be needed.
 - The district devised a plan to staff the Hatfield Courthouse with USMS, BOP, and Border Patrol Agents from 18:00 to 06:00. Pioneer Courthouse is currently staffed with FPS Agents and the local FBI S.W.A.T. team.

- The protestors/rioters have assaulted law enforcement with fireworks, frozen water bottles, rocks, bottles, batteries, and Molotov cocktails. The Justice Center has been set on fire and they have attempted to start other buildings and facilities on fire.
- **Eastern District of Tennessee (Chattanooga)**
 - A protest occurred on June 6, 2020, in Miller Park which is located across the street from the federal courthouse. All previous six nights of protest remained peaceful and no incidents were reported.
- **Southern District of Texas (Houston)**
 - A public viewing will be held in Houston on June 8, 2020, and a private funeral service will follow on June 9, 2020.
- **Eastern District of Virginia (Richmond)**
 - In addition to supporting the operations in Washington DC, on Saturday June 6th, the Eastern District of Virginia will begin supporting the Richmond, VA Police Department to address growing security concerns in the city where the federal courthouse has already sustained damage.



 - June 6, 2020, CARFTF leadership has been coordinating with elements of the recently deputized National Guard units. Approximately (b) (7)(E) [REDACTED] soldiers are currently on standby with USMS, ready to deploy to areas throughout the district.
 - CARFTF members are also supporting local law enforcement in efforts in Richmond, Virginia.

Risks/Challenges: Damage to property and continued targeting of law enforcement personnel.

As of June 5, 2020, there have been two reported deaths of law enforcement officers and 367 local officers injured around the country during protests, frequently from projectiles.

As of June 4, 2020, USAO charged 54 individuals with varying crimes ranging from use of explosive or fire to damage or destroy a vehicle used in interstate commerce; traveling in interstate commerce or using a facility of interstate commerce to incite a riot; organize, promote, encourage, participate in, or carry on a riot; and use of an explosive device; and conspiracy to destroy by fire and explosive.

To date, field offices reported more than 11,037 arrests made by various law enforcement agencies across the nation.

As of June 4, 2020, more than 32 states have requested National Guard personnel with more than 41,500 National Guard personnel on duty.

ATF reported 80 federal firearms licensees' burglaries have occurred with an estimated loss of 1,114 firearms; 854 reported arsons; 76 explosive incidents and 41 ATF arrests to date.
