Dear Governor Brown,

I appreciate your willingness to partner with us to help bring an end to the violence in Portland. This email is intended to put our operational discussions on paper to ensure that we are truly “on the same page.”

It is my understanding that you will move an adequate contingent of the Oregon State Police (OSP) into Portland to help address the nightly violence directed at federal facilities, and that our mutual operations will be – in their most basic form – as follows:

- OSP and PPB will police outside the fence at the federal courthouse, including but not limited to the adjacent streets and park(s) across from the courthouse;
- OSP and FPS will jointly police inside the fence at the federal courthouse; and
- FPS and the U.S. Marshals will police the inside of the courthouse.

We assume OSP will be in their regular uniforms and FPS will be wearing their blue uniforms with gold lettering. Given Portland’s current legal bar on their police having communication with federal law enforcement, until that situation changes, OSP will coordinate any needed communication between our federal law enforcement and both OSP and Portland authorities for operational purposes. Further, together we will have a joint operations center to coordinate activities.

Our additional federal law enforcement support personnel will be on stand-by at location(s) in line with our conversations. Once a period of time goes by without violence that allows us to draw down our stand-by personnel consistent with preserving safety at federal facilities in Portland, we will commence doing so.

I look forward to partnering with you to bring the violence in Portland to an end.

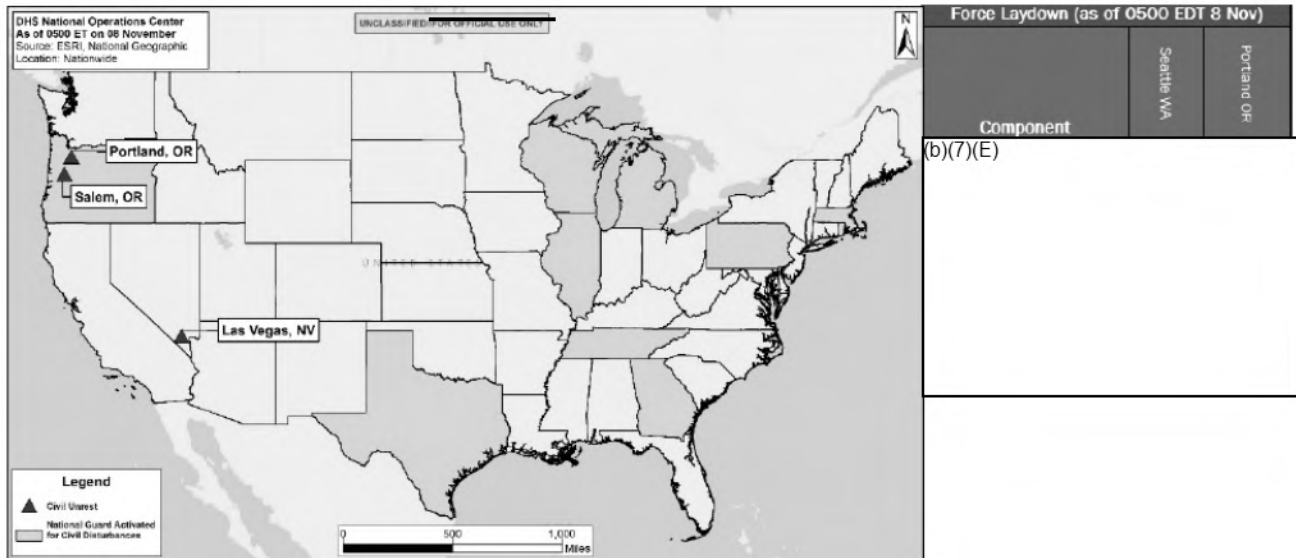

## National Roll-up of Civil Unrest



### Situational Overview

There was one attempted attack and one minor incident at federal properties resulting in federal forces deploying in both events. Across the Nation there were multiple gatherings in reaction to the election results, but only three cities incurred minor unrest overnight: Portland, OR, Salem, OR and Las Vegas, NV. In Portland, federal forces deployed to clear agitators off federal property at the ICE Building and arrested three people. In Salem, two large opposing groups clashed, resulting in multiple arrests. In Las Vegas, a FPS Protective Service Officer (PSO) deployed to stop an arson attempt at a Federal building and Courthouse. The PSO received minor injuries while attempting to arrest a suspect.

- There are 4,254 (-292) National Guard (NG) personnel activated or on standby related to civil unrest across 10 (n/c) states: GA, IL, MA, MI, OR, PA, RI, TN, TX, and WI.

### Locations of Interest

#### Portland, OR:

Approximately 300 protesters gathered at Director Park, near Pioneer Courthouse, and marched in the downtown area. This group's activities disrupted traffic, but otherwise remained peaceful eventually ending at Caruthers park and dispersed.

- As small group of approximately 35 people separated and proceeded to the ICE facility. Members of the crowd entered federal property and did not comply with announcements to disperse. One individual attempted to damage a card reader triggering DHS forces to deploy outside the building. The deployment resulted in three arrests.
- Four warnings were given to stay off federal property prior to deployment (b)(7)(E)

(b)(7)(E)

- There was no damage to the property and no injuries to law enforcement officers or civilians.



8 November 2020

**Salem, OR:**

Two separate political demonstrations occurred in the Salem Area overnight; one rally started at the Capitol and a second rally started at a nearby park that later marched to the Capitol. Altercations occurred between the two opposing groups resulting in four arrests.

- Approximately 100 people demonstrated outside the Capitol building in downtown Salem, partially blocking the streets and impeding traffic.
- A separate group of around 300 people assembled at Pringle Park, approximately six blocks southwest of the State Capitol, and marched to the Capitol.
- Due to violent altercations between the groups, Salem Police declared an unlawful assembly and ordered the crowds to disperse.
- No crowd control munitions were used, and the two groups eventually complied with the order to disperse.
- Four arrests were made for assault, unlawful use of pepper spray, unlawful possession of firearm, disorderly conduct and offensive littering and interfering with police. One individual had prior arrests due to protest activity.

**Las Vegas, NV:**

A male suspect attempted to set fire to the Foley Federal Office Building and Courthouse in Las Vegas during the early morning of 7 Nov. A FPS Protective Security Officer (PSO) observed the activity and confronted the suspect. A scuffle ensued, but the suspect managed to escape and is still at large.

- The suspect doused several plywood boards with gasoline placed over windows at the building that were in installed in preparation for potential civil unrest.
- The PSO attempted to stop and arrest the suspect. A struggled ensued and (b)(7)(E)
- (b)(7)(E) The suspect was able to escape and departed in a vehicle.

- The fire was quickly extinguished and no major damage was reported to the facility.
- The PSO sustained minor injuries to his face, right arm and back during the physical altercation.

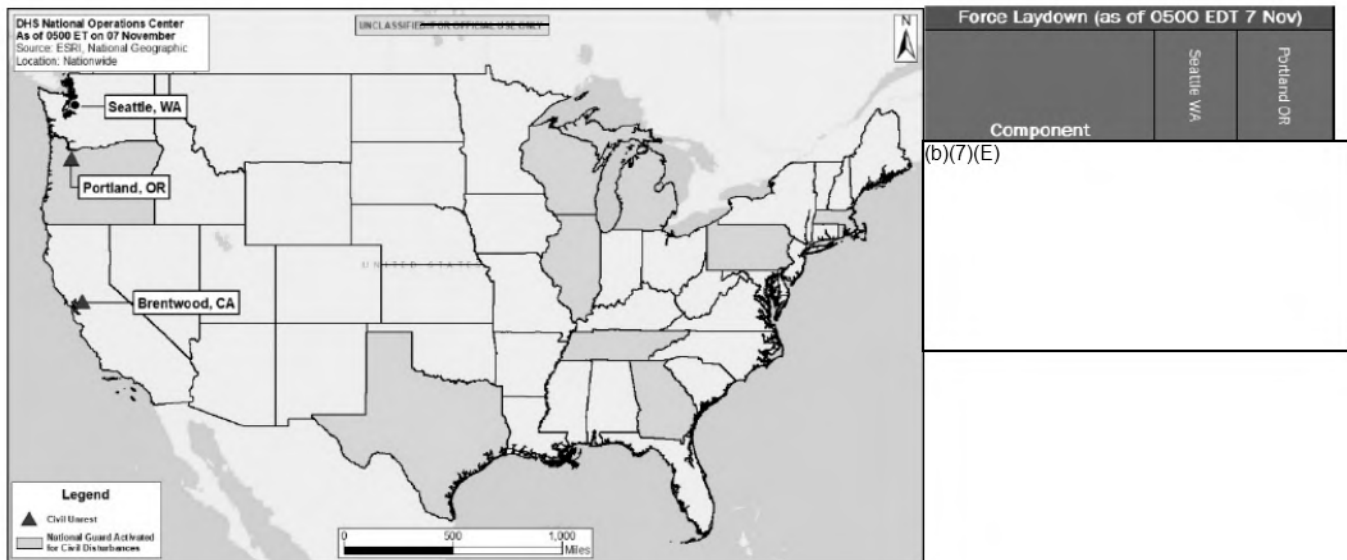

## National Roll-up of Civil Unrest



### Situational Overview

There was no activity directed at federal facilities or personnel, and no DHS law enforcement personnel were deployed overnight. Nationally, there were two cities with very minor degrees of civil unrest: Portland OR and Brentwood CA. There were no reports of significant damage and no serious injuries noted to law enforcement or civilians.

- There are 4,546 (-655) National Guard (NG) personnel activated or on standby related to civil unrest across 10 (-1) states: GA, IL, MA, MI, OR, PA, RI, TN, TX, and WI (MO has demobilized).

### Locations of Interest

#### Portland, OR:

Several dozen protesters gathered at Director Park, one block west of Pioneer Courthouse, and began a march in the downtown area.

- As part of an ongoing proactive policing effort under the PUC, officers saturated the park ahead of the scheduled gathering and performed high visibility patrols in the downtown core.
- A business one block from the park was vandalized; VOs broke glass from windows and the front door.
- A 42-year-old suspect was arrested for criminal mischief after painting the City Hall's front door. The suspect had a prior arrest during the civil unrest in July and was charged with interfering with a police officer and criminal mischief.
- There was no activity directed at federal facilities or personnel and no DHS personnel were deployed.
- The Governor of Oregon extended the state of emergency for Multnomah County until 2000 EST, 8 Nov.

**Brentwood, CA:**

For the second night, over one hundred people marched from the Brentwood Police Department (BPD) to a private residence where the owner had hung an effigy of one of the presidential candidates.

- The crowd gathered at the residence home and caused some disruptions to the home and neighborhood.
- BPD and the Contra Costa Sheriff's Department were called to the residence.
- Agitators from the crowd threw some water bottles at police prompting the police to push the crowd away from the residence. One arrest was made with charges pending.
- The gathering returned to downtown and eventually dispersed without incident.

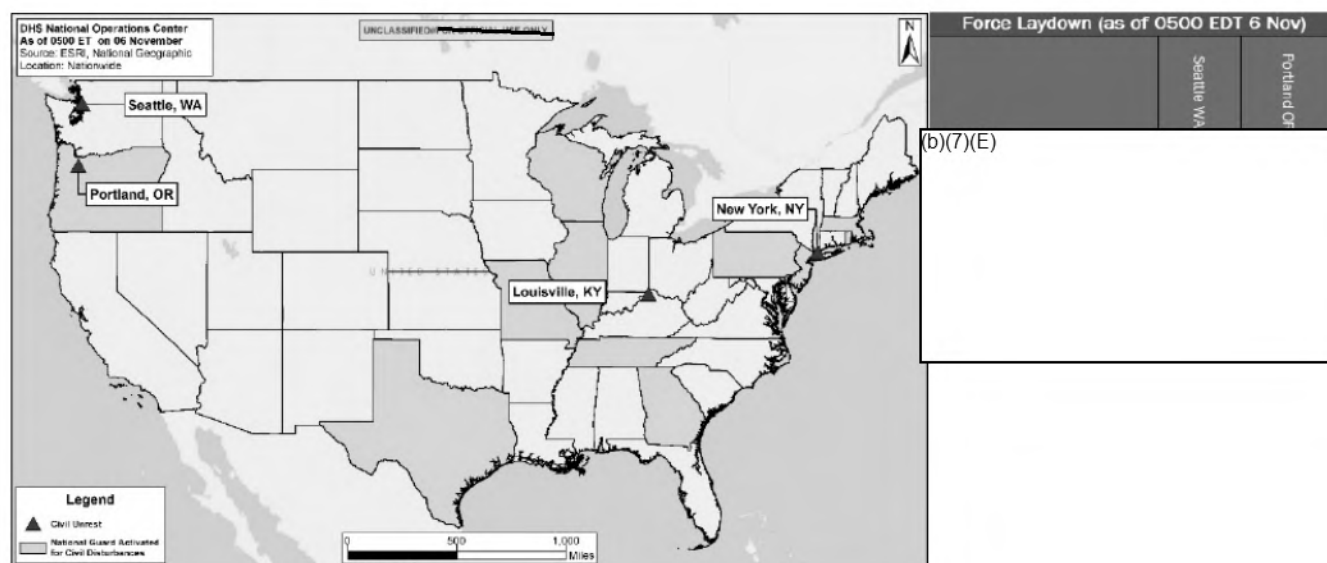

## National Roll-up of Civil Unrest



### Situational Overview

There was no activity directed at federal facilities or personnel and no DHS law enforcement personnel were deployed overnight. Nationally, there were four cities with various degrees of civil unrest: Portland OR, Seattle WA, Louisville KY and New York City NY. Events spanned several degrees of seriousness from blocking traffic to assaults on law enforcement. There were no reports of significant damage and no serious injuries noted to law enforcement or civilians.

- There are 5,201 (-275) National Guard (NG) personnel activated or on standby related to civil unrest across 11 (-2) states: GA, IL, MA, MI, MO, OR, PA, RI, TN, TX, and WI (MD and WA have demobilized).
  - 45 OR NG Airmen and 93 NG Military Police remain on standby in Portland OR.
  - No NG members were needed to assist local law enforcement.

### Locations of Interest

#### Portland, OR:

There was no activity directed at federal facilities or personnel and no DHS personnel were deployed.

- Violent opportunists in a crowd of approximately 60 vandalized the residence of a city council member resulting in the Portland Unified Command declaring an unlawful assembly, dispersing the crowd and making four arrests.
- A smaller group reconvened at the Portland Police Association building and was warned repeatedly by police to stay out of the streets; this group remained peaceful.
- Additionally, police responded to a fire set on the entryway doors to City Hall. An arson investigation is underway.
- No reports of injuries to law enforcement (see separate one-pager for additional detail).



6 November 2020

**New York, NY:**

Hundreds of protesters gathered in lower Manhattan in the early afternoon of 5 Nov. Agitators in the crowd clashed with police, resulting in the assault of an NYPD officer and a number of arrests. As officers began arresting agitators, one officer was pushed to the ground and had a heavy chain pressed on his neck.

- The assailant was arrested and charged with assault, criminal possession of a weapon, and attempted strangulation.
- Eighteen arrested were reported, with charges pending.

**Seattle, WA:**

A crowd of approximately 100 marched through downtown Seattle blocking traffic and VO's within the group caused some property damage.

- A small fire was set in front of the SPD East Precinct and was quickly extinguished.
- Two people were arrested, charges are pending.

**Louisville, KY:**

Early in the day, dozens assembled outside of City Hall to protest funding of a law enforcement contract. Agitators blocked traffic, prompting police to declare an unlawful assembly.

- No arrests were made.

In a second incident later in the evening (same cause), a group of about 40 gathered outside of the Metropolitan Council building.

- A local politician had to be protected by police officers as he headed to his vehicle. (b)(7)(E)

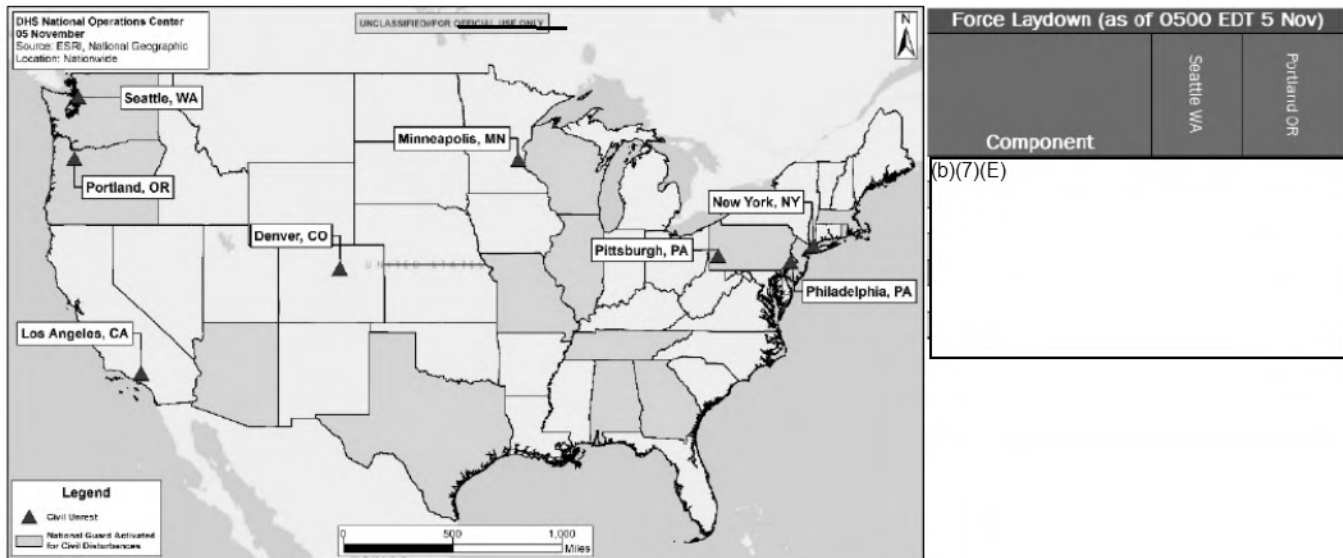

## National Roll-up of Civil Unrest



### Situational Overview

An unoccupied federal facility in Portland OR sustained damage overnight with no incidents directed at federal personnel in the past 24 hours. Federal agents in Portland deployed on one occasion to assist citizens in a crowd concerned for their safety outside a federal facility. There were at least eight cities over the past 24 hours with various degrees of civil unrest ranging from blocking traffic to assaults on law enforcement. Violent opportunists (VOs) in Portland were active throughout the night, prompting the governor to deploy the OR NG. There were no reports of injuries to federal personnel.

- There are 5,201 (-275) National Guard (NG) personnel activated or on standby related to civil unrest across 13 (+1) states: GA, IL, MA, MD, MI, MO, OR, PA, RI, TN, TX, WA and WI (MO and WI have activated, FL has demobilized).
  - There are 45 OR NG Airmen deployed to Portland OR with batons and shields and no other weapons. Another 93 NG Military Police remain on standby. All NG personnel will deploy in conjunction with PPB quick reaction teams.

### Locations of Interest

#### Portland, OR:

Multiple groups marched across downtown Portland committing widespread acts of vandalism. Law enforcement officers made at least 11 arrests. One gathering was declared a riot, while another was declared an unlawful assembly later in the night (see separate one-pager for additional detail).

- The USCIS facility in Portland was damaged with eight broken windows and one broken emergency door. FPS reports the building was not specifically targeted, windows and doors in surrounding facilities were also broken during the widespread acts of vandalism in the area.
- Federal officers deployed from Pioneer Courthouse briefly to protect two people who feared for their lives. They were detained and released.



5 November 2020

- Law enforcement confiscated at least two rifles were during arrests. Deputies arrested a man believed to have thrown a commercial grade firework at PPB officers.
- Forty-five Oregon National Guard personnel were deployed for the first time to assist PPB. They were not armed with lethal weapons.

#### **New York, NY:**

Several hundred people gathered outside the New York Public Library in midtown Manhattan and marched to Washington Square Park. NYPD declared an unlawful assembly after VOs fought with police and blocked traffic despite repeated warnings. NYPD made multiple arrests.

- The crowd blocked traffic, and VO's and agitators in the group set trash on fire, broke store windows, and threw bottles at officers.
- NYPD used its new Looting Task Force to arrest 58 people with charges pending. During these arrests, officers recovered a knife, a stun gun, spray paint, and M80 firecrackers.

#### **Denver, CO:**

A crowd of approximately 50 people marched in downtown Denver and became unruly as VOs vandalized businesses and set fires in the city center. Police declared an unlawful assembly and dispersed the group with crowd control munitions and made arrests.

- VO's broke windows, vandalized property with graffiti and set fire to a dumpster.
- Four people arrested were charged with criminal mischief, assault and weapons violations. A handgun, knife, hammer and bear spray were recovered.

#### **Seattle, WA:**

Several hundred people gathered in Seattle. VOs in the group damaged police vehicles and blocked intersections, resulting in seven arrests.

- Arrests charges ranged from obstruction, resisting arrest, assaulting an officer and/or property damage. One person arrested was a felon with two previous felony cases.
- One person placed under arrest was transported to the hospital for medical issues, although it is unclear whether the medical issue was related to the arrest. Widespread social media reports indicated that police had killed the subject, which is incorrect.

#### **Minneapolis, MN:**

A crowd of 200 people blocked the I-94 freeway that runs through downtown Minneapolis. State Patrol troopers and Minneapolis Police declared an unlawful assembly and arrested the majority of people who did not disperse.

- The freeway was closed for three hours while police arrested hundreds of people to clear the road.

**Pittsburgh, PA:**

Pittsburgh police arrested three people in connection with a small group who splintered off from a gathering of approximately 300 people downtown overnight. The arrests came after VOs in the splinter group began overturning garbage cans and vandalizing traffic signs.

**Philadelphia, PA:**

Two protest groups merged into a large demonstration of about 1000 people in Philadelphia overnight. Although generally peaceful, police made two arrests for unspecified charges.

**Los Angeles, CA:**

An unruly group gathered in downtown L.A., initially surrounding officers in a patrol car. LAPD declared an unlawful assembly and ordered the crowd to disperse. LAPD detained a few people and then released them. The crowd followed police orders to disperse without any further incidents.
