Dear Ms. White:

As we noted in our letter dated November 12, 2021, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department of State has identified an additional 24 responsive records subject to the FOIA. We have determined 22 records may be released in part and 2 records must be withheld in their entirety.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made redactions, the applicable FOIA exemptions are marked on each record. The records withheld in full are exempt from release pursuant to FOIA Exemptions 5, 6, and 7, 5 U.S.C. §§ 552 (b)(5), (b)(6), and (b)(7)(C). All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed.

We will keep you informed as your case progresses. If you have any questions, your attorney may contact Paul Cirino, Assistant United States Attorney, at Paul.Cirino@usdoj.gov or 202-252-2529. I had my local staff investigators try to track down an accurate answer for you regarding the importation of a personal firearm (rifle). Not an easy task given the complex and confusing laws here on firearms and other "dangerous goods" – Indonesian customs, police, and military all could conceivably have influence on the issue.

1. Based on information from Protocol and Diplomatic facilities office within Indonesian Ministry of Foreign Affairs (MFA), it is *possible* to bring the weapon in to Indonesia through commercial air. Based on information from a staff member who handles weapon permits, the MFA would have to process the request in the same fashion as when we (the Embassy) submit an official weapon permit request (i.e. for armed US protection special agents). We would have to submit a Diplomatic note to MFA with detailed information regarding the itinerary (arrival and departure information), the weapon, and the owner (make, model, serial #, caliber of weapon and copy of passport bio page of owner) a minimum 2 of weeks prior to the arrival.
2. Embassy General Services Office (GSO) local staff who deal with Customs officials advised us that if the VIP lands at the civilian airport (Soekarno Hatta commercial airport), it will take time to get clearance to take the weapon out of the airport. We would have to wait for the pilot to bring the weapon to the ground handling officer, who would bring the weapon to Chamber 14 at the airport (which is the office of Military Intel (BAIS/BIN) before the weapon can be brought outside the airport. This process can take approximately 1 hour.
3. Additional info from GSO: since the VIPs will be departing from Denpasar (Bali) to Ulaanbaatar, the Embassy would have to request that Customs officials at Soekarno Hatta airport send a notification letter to Bali airport custom office regarding the weapon and same procedures would be applied at Denpasar airport for weapon clearance/departure.

4. It should be noted that this procedure for importation of a personal firearm has not been attempted before by the Embassy. We have only dealt with official requests for security personnel traveling for protection duties. As I'm sure you are aware, the requirements to bring the weapon onto a commercial aircraft are separate matter beyond these requirements.

Below is the info gathered regarding the weapon:

7. Based on information from Protocol and Diplomatic facility of Indonesian Ministry of Foreign Affair (MFA) it is doable to bring the weapon in to Indonesia through commercial air. Based on information from Mr. (b)(6) one of the staff who handle the weapon permit, the MFA will process the request similar to official weapon permit request. We have to submit the Dip note to MFA with detail information regarding the rifle minimum 2 weeks prior the arrival.
8. Information from (b)(6) a GSO FSN who deal with customs, based on the experience, if the VIP landed in Soekarno Hatta commercial airport, it will take more time to take the weapon out of the airport. It is due to the reason that we have to wait for the pilot to bring the weapon to ground handling officer after that they will bring the weapon to Chamber 14 in the Soekarno Hatta airport which is the office of Military Intel (BAIS/BIN) before the weapon can be brought outside the airport. It will be much easier if the VIP use the chartered flight, the plane will be landed at Halim Military base and usually we can negotiate with the customs if we want to do the weapon check on the ground near the plane or at the VIP waiting area.

I had my local staff investigators try to track down an accurate answer for you regarding the importation of a personal firearm (rifle). Not an easy task given the complex and confusing laws here on firearms and other "dangerous goods" – Indonesian customs, police, and military all could conceivably have influence on the issue.

1. Based on information from Protocol and Diplomatic facilities office within Indonesian Ministry of Foreign Affairs (MFA), it is *possible* to bring the weapon in to Indonesia through commercial air. Based on information from a staff member who handles weapon permits, the MFA would have to process the request in the same fashion as when we (the Embassy) submit an official weapon permit request (i.e. for armed U.S. protection special agents). We would have to

submit a Diplomatic note to MFA with detailed information regarding the itinerary (arrival and departure information), the weapon, and the owner (make, model, serial #, caliber of weapon and copy of passport bio page of owner) a minimum 2 weeks prior to the arrival.

2. Embassy General Services Office (GSO) local staff who deal with Customs officials advised us that if the VIP lands at the civilian airport (Soekarno Hatta commercial airport), it will take time to get clearance to take the weapon out of the airport. We would have to wait for the pilot to bring the weapon to the ground handling officer, who would bring the weapon to (b)(7)(F) at the airport (which is the office of (b)(7)(F)) before the weapon can be brought outside the airport. This process can take over 1 hour.
3. Additional info from GSO: since the VIPs will be departing from Denpasar (Bali) to Ulaanbaatar, the Embassy would have to request that Customs officials at Soekarno Hatta airport send a notification letter to Bali airport custom office regarding the weapon and same procedures would be applied at Denpasar airport for weapon clearance/departure.
4. It should be noted that this procedure for importation of a personal firearm has not been attempted before by the Embassy. We have only dealt with official requests for security personnel traveling for protection duties. As I'm sure you are aware, the requirements to bring the weapon onto a commercial aircraft are separate matter beyond these requirements.
5. Assistant Secretary for Economic and Business Affairs Manisha Singh is traveling to Mongolia, Burma, and Laos, August 11-24. The trip is part of the Trump Administration's ongoing efforts to enhance Indo-Pacific economic engagement.

Assistant Secretary Singh will be in Ulaanbaatar, Mongolia, August 12-16 to meet with government and business officials to bolster economic opportunities and increase bilateral trade. The visit follows Mongolian President Battulga's meeting with President Trump at the White House on July 31, in which the leaders discussed the two countries' strong Strategic Partnership. While in Mongolia, Assistant Secretary Singh will visit the Asia Foundation's Women's Business Center and Incubator, which promotes women's economic empowerment. She will also tour Wagner Asia Equipment's facility. This heavy equipment dealership won the Secretary of State's Award for Corporate Excellence in 2014 for its commitment to partnership with Mongolia's local and national governments to protect the environment. She will also visit the Oyu Tolgoi mine, a joint project between Rio Tinto and the Government of Mongolia.

Assistant Secretary Singh will then travel to Rangoon, Burma, August 16-21 where she will meet with government officials, business leaders, and tech entrepreneurs to promote continued improvements to the investment climate. She will speak at a U.S.-Japan Investment Forum event hosted by the Japanese Embassy and Japanese, American, and Burmese Chambers of Commerce. JUSTIFICATION AND APPROVAL FOR OTHER THAN FULL AND OPEN COMPETITION
(OVERSEAS CONTRACTING ACTIVITIES)

1. I recommend that Embassy Ulaanbaatar use other than full and open competition for the acquisition of **accommodations**. The estimated cost is **\$24.000USD**. Post PO# 19MG1019P0191.
2. Accommodations for (b)(7)(E) personnel and a White House Doctor in an extremely remote locations between 8/17/19 and 8/24/19,
3. Mamara International is providing accommodations for (b)(7)(E) personnel and a White House Doctor in an extremely remote locations. Our protectee hired Mamara International as his hunting outfitter. This (b)(7)(E) will camp at various locations in remote areas in Mongolia as part of the hunt package they are providing our protectee. There are no other accommodations that are close enough to allow us to conduct our protective mission effectively.
4. We are seeking sole source procurement because there is no other operator who will provide us accommodations in the remote hunting areas. The hunting (b)(7)(E) will camp at various locations at undetermined dates and locations in remote areas in Mongolia as part of the hunt package they are providing our protectee. Additionally, there are no hotel accommodations that are close enough to allow us to conduct our protective mission effectively. Potential hunt sites would create commute times as much as 8 hours for the shift changes. 8 hours in addition to a scheduled 12 hour shift would add up to 20 hour work days which is unacceptable and unsafe.
5. The hunting (b)(7)(E) will camp at various locations at undetermined dates and locations in remote areas in Mongolia as part of the hunt package they are providing our protectee. The locations and dates all depend on where the animal being hunted is at that particular day. Animals are constantly on the move which requires the hunter to also constantly move to find them. Potential hunt sites would create 8 hour commute times for the shift changes. 8 hours in addition to a scheduled 12 hour shift would add up to 20 hour work days which is unacceptable and unsafe.
6. No other solicitations were found because we need to have our protective operation based out of the same accommodations as our protectee. Especially where our only other option is potentially 8 hours away. That is an unacceptable time to respond in case of an emergency requiring additional assistance from the off shift. Also, our Special Agents will have worked a full work day prior to even starting their 12 hour shifts.
7. The Contracting Officer was made aware of the facts and circumstances and understands the unique nature of this sole source request.
8. A market survey was not conducted due to the nature that there was no other option which would allow us to perform our protective mission.
9. No additional facts supporting the use of other than full and open competition at this time.
10. No other sources were requested due to the aforementioned reasons above.
11. The agency attempted to see if it was reasonable to base operations from the nearest hotel. No hotel was close enough given the ambiguity of where the hunt would take place each day.
