First Amendment Events—January 5&6, 2021

Multiple First Amendment demonstrations are currently scheduled to take place in downtown DC on Tuesday, January 5 and Wednesday, January 6. Unrelated events scheduled for similar times and locations and government operations in the vicinity could be affected. Anticipated overall impacts to the District—road closures and disruptions to businesses and government services located in the impacted area—are likely to resemble those observed during the Million MAGA March events in November and December. However, there is a possibility of increased impacts due to heightened public interest and amplification of the events on social media by prominent figures.

Below is a map of permitted events and street closures associated with activity during the 2-day period. Agencies with operations near impacted areas should review anticipated events for this week for potential impacts and adjust agency posture as needed to ensure safety and security of staff and residents.







 - First amendment demonstrations are expected in the District next week with most planned events scheduled to take place on January 6th. Participants are expected to be predominantly from right wing groups. There have been threats of violence on social media with some participants indicating plans to bring weapons into the District. The NTIC will be monitoring throughout the weekend and into the evening hours Mon-Wed, coordinating with MPD and Capitol Police. In addition to possible violence, the event also has the potential to be a COVID spreader event; social media posts have encouraged participants not to wear masks. Most events are converging around Freedom Plaza and the Capitol.

Aloha LE,

National Capital Region Threat Intelligence Consortium (NTIC) Executive Director Donell Harvin and the National Fusion Center Association held a nationwide conference call this morning to discuss the coordination of real-time open source analysis (ROSA) to identify potential threats to the upcoming Electoral Vote in Congress on January 6 and the Inauguration on January 20.

NTIC related they are seeing on-line communications citing violence in DC on 1-6-21 from groups they are not very familiar with. NTIC asked the countries FC's to provide input of the groups and any knowledge of TTP's for criminality in DC.

Specific on-line messaging cited by NTIC include;

- Occupying the Capitol to influence lawmakers to change election results
- Call to come with guns. NOTE: DC has strict gun laws.
- · Be prepared to battle
- Exercise 2nd amendment rights
- Protest without face masks

The purpose of the event is to carpool from Texas and arrive in Washington, DC on 01/05/21. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 0 are interested.
- 3. From 01/05/21 at 6:00 AM to 01/07/21, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 8 people are going, and 27 are interested.
- 4. On 01/05/21 at 6:30 AM to 01/07/21 at 7:00 AM, the group Muskegon County Republican Party (NRID) will host an event called "Muskegon Bus to DC Tyump Rally Jan 6th- Stop The Steal" at the US Capitol. The purpose of the event is to take a bus from Muskegon to Washington, DC to support President Trump. There is no indication of civil disobedience. According to Facebook, 19 people are going, and 51 are interested.
- 5. From 01/05/21 at 07:00 AM to 01/07/21 at 7:00 AM the group Oakland County
 Republican Party (NRID) will host a demonstration called "March For Trump" in

- 6. On 01/05/21 at 9:00 AM to 01/12/20 at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Protect the POTUS" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad

actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, 3 people are going, and 8 are interested.

- 7. From 01/05/21 at 10:00 AM to 01/06/21 at 08:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC from Florida and support the United Stated and free and fair elections. There is no indication of civil disobedience. According to Facebook, 8 people are going, and 6 are interested.

There is no indication of civil disobedience. According to Facebook, 10 people are going, and 49 are interested.

On 01/05/21 at 6:00 PM to 01/06/21 at 9:00 PM, the group Wisconsin Salt & Light Brigade (NRID) and individual (b)(6); (b)(7)(C) NRID) will host a demonstration called "Stop the Steal!" in Washington, DC. The purpose of the event is to "save our country from Biden/China tyranny!" There is no indication of civil disobedience. According to Facebook, 3 person is going, and 5 are interested.
- 10. On 01/05/20 at 10:00 PM to 01/07/21 at 10:00 AM, the individual (b)(6); (b)(7)(C)

 (NRID) will host an event called "FREE bus trip DC for the Jan 6 protest!" in Washington, DC. The purpose of the event is to bus to Washington, DC to participate in the protest to support President Trump. There is no indication of civil disobedience. According to Facebook, 14 people are going, and 82 are interested.
- 11. On 01/05/21 at 11:30 PM to 01/06/21 at 8:00 PM, the individual (b)(6); (b)(7)(C)
 (NRID) will host an event called "Charter Bus to Trump Rally, DC" at the US
 Capitol. The propose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook 21 people are going, and 120 are interested.
- 12. On 01/06/21, at an unknown time, **Proud Boys (RID)** will host an unnamed demonstration in Washington DC. The purpose of this demonstration is to join the pro-Trump demonstrations. There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current

numbers of planned participants was not indicated, but the group stated they will "turn out in record numbers." **Proud Boys** is of record for numerous demonstrations at the White House and temporarily protected sites. Their demonstrations have concluded without arrests.

- 13. On 01/06/21, at an unknown time, **Refuse Fascism (RID)** will host a demonstration in Washington DC called "**Opposing Trump's Moves to Overturn the Election**." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There was no indication of civil disobedience. Current numbers of planned participants was not indicated at this time.
 - <u>Refuse Fascism</u> is of record for protesting at the White House, Lafayette Park, and numerous temporarily protected sites. One demonstration from 2017 ended with arrests for disorderly conduct and failure to obey.
- 14. On 01/06/21, at an unknown time, the group <u>DC Protests (NRID)</u> will host a demonstration with an unknown title in Washington, DC. The purpose of the event is to form a bike line to "protect against the armed right-wing extremist groups." The group plans on forming a bike line using bikes, boards, and wheels. The specific location was not provided. There is no indication of civil disobedience. Participant numbers were not available.
- 15. On 01/06/21, at 12:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "National Caravan for Trump 'Stop the Steal' Rally" at the US Capitol. The purpose of the event is to join the caravan to protest in Washington, DC. There is no indication of civil disobedience. According to Facebook, 1 person is going and 0 are interested.

The purpose of the event is to "show up outside the senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 3 person is going, and 5 are interested.

On 01/06/21, from 1:00 AM to 12:55AM, the individual (b)(6); (b)(7)(C) (NRID) and group Patriot Party of America (The Peoples Party) (NRID) will host a demonstration called "Million MAGA Strong" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 people are going, and 14 are interested.
- 19. On 01/06/21, from 4:00 AM to 11:45PM, the individual (b)(6); (b)(7)(C) NRID) will host a demonstration called "CANTON/AKRON ELECTION PROTEST BUS TRANSPORTATION (SOLD OUT)" at the US Capitol. The group plans on leaving Canton, OH and demonstrating in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 66 people are going, and 183 are interested.
- 20. On 01/06/21, from 5:00 AM to 5:00 PM (b)(6); (b)(7)(C) NRID) and (b)(6); (b)(7)(C) NRID) will host a rally at Freedom Plaza in Washington, DC called "Bus Trip to D.C. Last Rally for Freedom." The purpose of the event is to support President Trump and Vice President Michael Pence on this momentous day in history as Congress counts the Electoral College's votes. The page did not indicate there would be any civil disobedience. The page portrayed 19 participants and 42 interested.
- 21. On 01/06/21, at 5:30 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Jan 6th DC MAGA/KAG Marchleaving from Fayetteville, NC" at the US Capitol. The group plans on leaving various places in North Carolina and arrive in Washington, DC at 10 AM. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 22 people are going, and 66 are interested.
- 22. On 01/06/21, from 5:45 AM to 4:00 PM, (b)(6); (b)(7)(C) (NRID) will be hosting an event at the United States Capitol called "Road (Bus) Trip to DC." The purpose of the event is to join in the "WILD PROTEST" in support of President Trump scheduled for the day. There is no mention of civil disobedience. All chatter on the page pertain to tickets for the bus trip. Current numbers according to Facebook, 82 going and 283 interested.

On 01/04/21, the USSS discovered a threatening post toward President-Elect Biden by Parler user Patriots Unleashed / @unleashedpatriots.

On 01/04/2021 Parler user @unleashedpatriots posted, "We CANNOT allow #Biden to enter the white house."

Additional research of these accounts identified the following potentially threatening comments: On 01/03/21, Parler user @unleashedpatriots posted, "We're all on a mission to save America. Lone wolf attacks are the way to go. Stay anonymous. Stay alive. Guns up patriots!! #WWG1WGA".

On 01/02/21, Parler user @unleashedpatriots posted, "Biden will die shortly after being elected. Patriots are gonna tear his head off. Prison is his best case scenario."

On 12/31/20, Parler user @unleashedpatriots posted, "January 6 starts #1776 all over again!! Fight for God!! Fight for Your Freedom!! Fight for Your Children!! Fight for Trump!! Fight for America!! Fight for EVERYTHING... Enemies: #MSM #BarackObama #HillaryClinton #GeorgeSoros #JoeBiden #AndrewCuomo #GavinNewsom #NancyPelosi #BillDeBlasio".

On 12/31/20, Twitter user @UnleashPatriots posted, "TIPS FOR THE BRAVE AND COURAGEOUS PATRIOTS GOING TO DC TO FORCE CONGRESS TO REFUSE BIDEN'S RIGGED ELECTION. #STOPTHESTEAL #WWG1WGA #MAGA #PROUDBOYS #3PERCENT #FIGHTBACK". This comment was posted along with a listing of "Washington D.C. Tips" related to finding restaurants, hotel security, and transportation security in the Washington DC area.


On 11/17/20, Twitter user @UnleashPatriots posted, "Thank God Trump won the election. If and when Biden enters the white house, I'm sure his head will get torn right off. Americans don't like terrorists! Speaking of terrorists..." This comment was posted along with the picture, name, and alleged home address for the man that assaulted a Trump supporter during a pro-Trump rally in Washington DC.

It should be noted, while there may be more threatening comments or comments of protective interest posted to these accounts, a thorough review was not possible due to the volume of comments/videos/images contained. Research of these accounts revealed an email address of patriotsunleashed@pm.me. Due to lack of identifying information, this subject has not been positively identified at this time.



Washington D.C. Tips

→ There's NO indoor dining. Outdoor dining and pick up only. (Nearby Arlington/Alexandria has indoor dining). Make outdoor dining reservations in advance or call restaurants to see if they offer outdoor dining. I recommend having a food/restaurant itinerary plan, as many places are closed and there will be many visitors in town.

Hotels:

→ Keep MAGA gear hidden until AFTER checking in. Some places may unlawfully prevent you from checking in. Some don't care, but you never know.

Security

→ DC is very BLUE and a hotbed for ANTIFA/BLM. Stay with the large group, especially at night. The DC police aren't the most helpful, so be wary. If you have to leave the larger group, take off MAGA gear/flags. Put them back on when back with the larger group.

Transportation

→ The National Mall area and nearby roads will be fenced off, STRONGLY recommend walking, taking the metro (see map), or Ubering. (If using Uber, have the Uber pick you up from at least 3 blocks away from the Mall, North or South. The Uber will not be able to get to you if you're standing right at the National Mall).

Miscellaneous

→ Trump Hotel will be closed except for hotel guests // Bring portable cell chargers // Bring water // Dress Warmly // Porta Potties will be in high demand, so use restrooms before heading to rally // Check metro update for potential closures day of
