First Amendment Events—January 5&6, 2021

Multiple First Amendment demonstrations are currently scheduled to take place in downtown DC on Tuesday, January 5 and Wednesday, January 6. Unrelated events scheduled for similar times and locations and government operations in the vicinity could be affected. Anticipated overall impacts to the District—road closures and disruptions to businesses and government services located in the impacted area—are likely to resemble those observed during the Million MAGA March events in November and December. However, there is a possibility of increased impacts due to heightened public interest and amplification of the events on social media by prominent figures.

Below is a map of permitted events and street closures associated with activity during the 2-day period. Agencies with operations near impacted areas should review anticipated events for this week for potential impacts and adjust agency posture as needed to ensure safety and security of staff and residents.

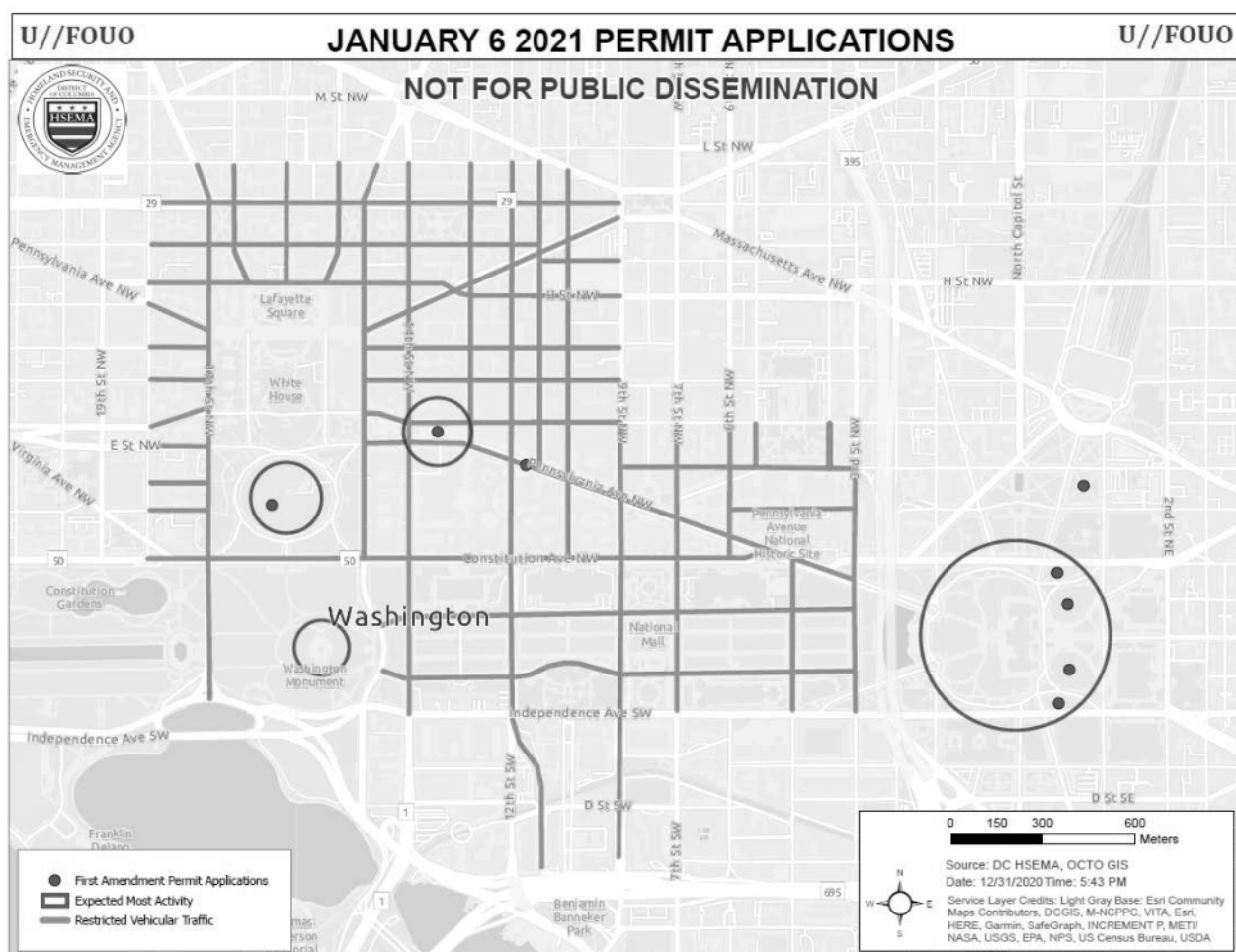

The Homeland Security and Emergency Management Agency is activating the District Emergency Operations Center (EOC) to coordinate/support crisis and consequence management efforts associated with planned demonstrations and ancillary incidents occurring January 4-6. EOC Team personnel will administer operations for this incident concurrent with the COVID-19 incident (20IE007) through extended hours of operations/expanded staffing.

Intent:

Establish a common operating picture, through situational awareness and operational coordination; coordinate resources; and, provide timely, accurate, and actionable information to incident/unified command, the Consequence Management Team, and other operational partners.

- **Youth Liberation Front**, is of record for a demonstration on 08/13/20 near Meridian Park. An unknown number of arrests were made for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows. Arrests were not indexed as there was no PI nexus.

This comment was posted along with the picture, name, and alleged home address for the man that assaulted a Trump supporter during a pro-Trump rally in Washington DC.

It should be noted, while there may be more threatening comments or comments of protective interest posted to these accounts, a thorough review was not possible due to the volume of comments/videos/images contained. Research of these accounts revealed an email address of patriotsunleashed@pm.me. Due to lack of identifying information, this subject has not been positively identified at this time.





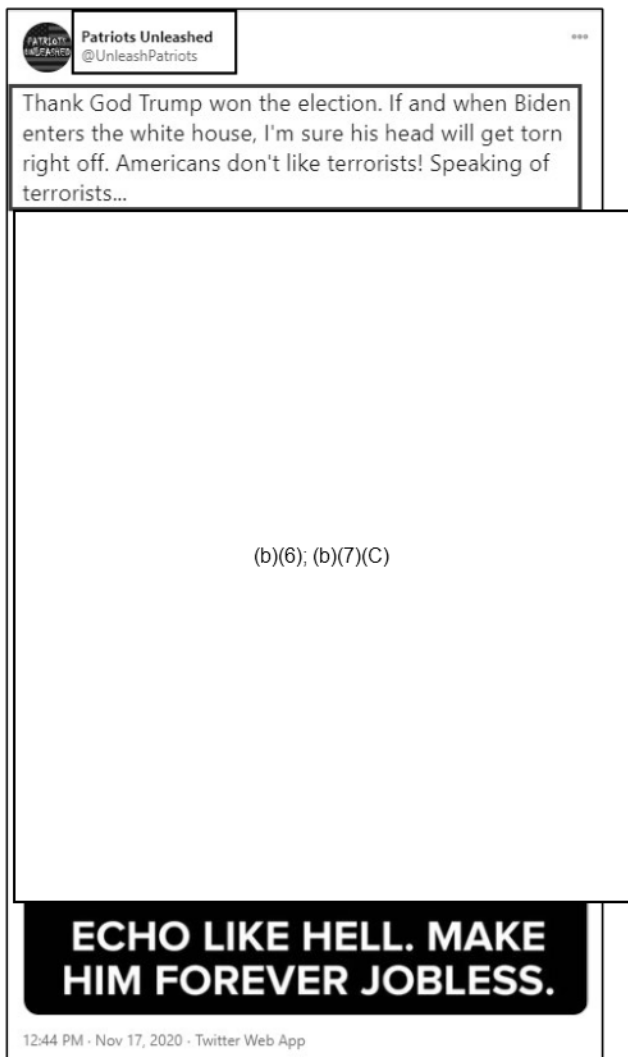

Washington D.C. Tips

Restaurants:

→ There's NO indoor dining. Outdoor dining and pick up only. (Nearby Arlington/Alexandria has indoor dining). Make outdoor dining reservations in advance or call restaurants to see if they offer outdoor dining. I recommend having a food/restaurant itinerary plan, as many places are closed and there will be many visitors in town.

Hotels:

Security
