**DACA STALLED AT SOTU:** President Donald Trump will deliver his first formal State of the Union address before a joint session of Congress at 9 p.m. tonight. He <u>told reporters</u> Monday that

immigration would be a topic, along with taxes and trade. "For many, many years they've been talking immigration, they never got anything done," Trump said following a swearing-in ceremony for Health and Human Services Secretary Alex Azar. "We're going to get something done, we hope. It's going to be bipartisan because the Republicans really don't have the votes to get it done in any other way, so it has to be bipartisan. But hopefully the Democrats will join us, or enough of them will join us, so we can really do something great for DACA and for immigration generally."

**Trump's push comes** as lawmakers continue fractious immigration talks on Capitol Hill. Several top Republicans and Democrats met Monday afternoon with White House chief of staff John Kelly, legislative affairs director Marc Short, and Homeland Security Secretary Kirstjen Nielsen to discuss the administration's <a href="legislative framework">legislative framework</a>. The White House plan, which includes a path to citizenship for nearly 2 million DREAMers, \$25 billion for a border wall, limits on family-based immigration, and a termination of the diversity visa lottery, received a cold reception last week from many Democrats and some Republicans.

**Senate Minority Whip** <u>Dick Durbin</u>(D-Ill.) reiterated his opposition to the Trump plan as he entered the meeting, citing as "one of the most serious problems" the administration's drastic reduction in family-based immigration."The strength of American families has been a pillar of our country for as long as I can remember," he said. "To literally divide families from their children is inconsistent with the values that I thought both parties embraced." (The proposal would allow citizens and permanent residents to sponsor spouses and minor children, but not parents, adult children, or other family members.)

Senate Majority Whip John Cornyn (R-Texas), also in attendance, said Democrats would need to embrace some aspects of the White House proposal. "I know the Democrats would just like to take the DACA piece and forget the rest, but we're not going to do that," he told reporters after the meeting. Nielsen, who attended the gathering with DHS legislative affairs director Ben Cassidy and other department officials, said the president's framework should guide discussions on Capitol Hill, but she wouldn't say where lawmakers had found agreement, if any. "I think president has made an offer, so we're starting from there," she said.

At least two dozen Dreamers will attend the State of Union, mostly as guests of Democrats, though Rep. <u>Carlos Curbelo</u> (R-Fla.) also invited a DREAMer. At the other pole of the immigration debate, the White House - which has repeatedly sought to link immigration and crime - will invite the mother of a teenager allegedly killed by four MS-13 gang members, the New York Times <u>reports</u>. Several Democrats, including Rep. <u>Frederica Wilson (D-Fla.)</u>, won't attend the event, CNN's Sophie Tatum <u>reports</u>. "I cannot in good consciousness attend the #SOTU address after the president went so low in his remarks about Haiti & African nations," Wilson <u>tweeted</u> in mid-January. "It would be hypocrisy to go to an event at which he is honored."

**FARM INJURIES:** Children in rural areas face a grave risk of getting injured because of dangers on the farm, raising difficult questions about when the government should intervene, Jack Healy writes for The New York Times. "At a time when industries and some rural residents have rallied behind the Trump administration's push to roll back an array of regulations, the debate over safety standards on family farms raises difficult questions about the line where personal responsibility should end and government oversight should begin."

"Questioning whether a child should be riding in a tractor or playing in the barn is no easy thing in rural communities," writes Healy. "Generations of farm children have woken before dawn to feed livestock and do chores that families call a sacrosanct part of life. It is a way of passing on lessons about hard work, responsibility and the pulse of the land that their children will someday take over. With prices plummeting for wheat, dairy and other products, smaller, struggling farms are also under intense financial pressure, and entire families are pitching in to survive." More here.

**FARM HARASSMENT:** Sexual harassment is an unseen but prevalent menace on American farms, especially for guest workers on H-2A visas, Ariel Ramchandani writes in the Atlantic. "In recent months, stories of sexual harassment and assault have been flowing on a daily basis from the entertainment, media, and tech industries. But low-wage workers, who are disproportionately women of color, are extremely susceptible to harassment in the workplace, and their stories receive far less attention. ... In a 2012 Human Rights Watch report, nearly all of the farmworkers interviewed said they had experienced sexual violence or harassment or knew someone who had. In 2010, a study found that of 150 Mexican women working in the Central Valley in California, 80 percent had experienced sexual harassment." More here.

**NLRB NOMINEE RING REPORTS INCOME:** "Morgan, Lewis & Bockius partner John Ring, the latest Trump pick for the National Labor Relations Board, on Friday reported \$2.7 million in partner and bonus income and disclosed a host of big-name clients, including Google, Amazon.com and Marriott International, as his nomination advances to the U.S. Senate," Erin Mulvaney reports in the National Law Journal. NLRB GETS WORKPLACE RULE DO-OVER: "The D.C. Circuit on Monday remanded most of a restaurant chain's appeal of a National Labor Relations Board ruling that a slew of the chain's workplace rules violated federal labor law, granting the board's request to reconsider whether several of those rules are still illegal under a new standard the NLRB created last month," Vin Gurrieri reports in Law360. "A three-judge panel remanded a majority of the NLRB's findings from a multi-pronged 2016 ruling which, among other things, held that The Daily Grill proffered a series of workplace handbook rules that were too broad and could be interpreted by employees as discouraging them against engaging in union activity." **#METOO TRICKY IN 2018:** "As they prepare for the 2018 elections, both Democrats and Republicans are dealing with dissenting opinions in their ranks over their handling of candidates or officeholders facing sexual harassment allegations," POLITICO's Maggie Severns and Marianne LeVine report.

"We're going to get something done, we hope. It's going to be bipartisan because the Republicans really don't have the votes to get it done in any other way, so it has to be bipartisan. But hopefully the Democrats will join us, or enough of them will join us, so we can really do something great for DACA and for immigration generally."

**Trump's push comes** as lawmakers continue fractious immigration talks on Capitol Hill. Several top Republicans and Democrats met Monday afternoon with White House chief of staff John Kelly, legislative affairs director Marc Short, and Homeland Security Secretary Kirstjen Nielsen to discuss the administration's <u>legislative framework</u>. The White House plan, which includes a path to citizenship for nearly 2 million DREAMers, \$25 billion for a border wall, limits on family-based immigration, and a termination of the diversity visa lottery, received a cold reception last week from many Democrats and some Republicans.

**Senate Minority Whip** <u>Dick Durbin</u>(D-Ill.) reiterated his opposition to the Trump plan as he entered the meeting, citing as "one of the most serious problems" the administration's drastic reduction in family-based immigration."The strength of American families has been a pillar of

our country for as long as I can remember," he said. "To literally divide families from their children is inconsistent with the values that I thought both parties embraced." (The proposal would allow citizens and permanent residents to sponsor spouses and minor children, but not parents, adult children, or other family members.)

Senate Majority Whip John Cornyn (R-Texas), also in attendance, said Democrats would need to embrace some aspects of the White House proposal. "I know the Democrats would just like to take the DACA piece and forget the rest, but we're not going to do that," he told reporters after the meeting. Nielsen, who attended the gathering with DHS legislative affairs director Ben Cassidy and other department officials, said the president's framework should guide discussions on Capitol Hill, but she wouldn't say where lawmakers had found agreement, if any. "I think president has made an offer, so we're starting from there," she said.

At least two dozen Dreamers will attend the State of Union, mostly as guests of Democrats, though Rep. Carlos Curbelo (R-Fla.) also invited a DREAMer. At the other pole of the immigration debate, the White House - which has repeatedly sought to link immigration and crime - will invite the mother of a teenager allegedly killed by four MS-13 gang members, the New York Times reports. "For many, many years they've been talking immigration, they never got anything done," Trump said following a swearing-in ceremony for Health and Human Services Secretary Alex Azar. "We're going to get something done, we hope. It's going to be bipartisan because the Republicans really don't have the votes to get it done in any other way, so it has to be bipartisan. But hopefully the Democrats will join us, or enough of them will join us, so we can really do something great for DACA and for immigration generally."

**Trump's push comes** as lawmakers continue fractious immigration talks on Capitol Hill. Several top Republicans and Democrats met Monday afternoon with White House chief of staff John Kelly, legislative affairs director Marc Short, and Homeland Security Secretary Kirstjen Nielsen to discuss the administration's <u>legislative framework</u>. The White House plan, which includes a path to citizenship for nearly 2 million DREAMers, \$25 billion for a border wall, limits on family-based immigration, and a termination of the diversity visa lottery, received a cold reception last week from many Democrats and some Republicans.

**Senate Minority Whip** <u>Dick Durbin</u>(D-Ill.) reiterated his opposition to the Trump plan as he entered the meeting, citing as "one of the most serious problems" the administration's drastic reduction in family-based immigration."The strength of American families has been a pillar of our country for as long as I can remember," he said. "To literally divide families from their children is inconsistent with the values that I thought both parties embraced." (The proposal would allow citizens and permanent residents to sponsor spouses and minor children, but not parents, adult children, or other family members.)

Senate Majority Whip John Cornyn (R-Texas), also in attendance, said Democrats would need to embrace some aspects of the White House proposal. "I know the Democrats would just like to take the DACA piece and forget the rest, but we're not going to do that," he told reporters after the meeting. Nielsen, who attended the gathering with DHS legislative affairs director Ben Cassidy and other department officials, said the president's framework should guide discussions on Capitol Hill, but she wouldn't say where lawmakers had found agreement, if any. "I think president has made an offer, so we're starting from there," she said.

At least two dozen Dreamers will attend the State of Union, mostly as guests of Democrats, though Rep. <u>Carlos Curbelo</u> (R-Fla.) also invited a DREAMer. At the other pole of the immigration debate, the White House - which has repeatedly sought to link immigration and crime - will invite the mother of a teenager allegedly killed by four MS-13 gang members, the New York Times <u>reports</u>. Several Democrats, including Rep. <u>Frederica Wilson</u> (D-Fla.), won't attend the event, CNN's Sophie Tatum <u>reports</u>. "I cannot in good consciousness attend the #SOTU address after the president went so low in his remarks about Haiti & African nations," Wilson <u>tweeted</u> in mid-January. "It would be hypocrisy to go to an event at which he is honored."

**BLANK NAMED ICE COS:** Thomas Blank, a former Transportation Security Administration official with 35 years of experience in the public and private sector, will be the chief of staff for U.S. Immigration and Customs Enforcement, the agency's director announced Wednesday. ICE Director Thomas Homan called Blank a "founding leader" at TSA, "helping build the agency from the ground up" after 9/11. In recent years, Blank has worked as a consultant in security technology, according to Homan.

**Homan didn't mention that** Blank has also been a lobbyist, with ties to at least one relevant project: a George W. Bush-era plan to build a virtual fence across the U.S.-Mexico border. In 2008, POLITICO reported that Blank and current TSA Chief of Staff Chad Wolf (who were both contracted by Boeing) were working on the SBInet project, which was canceled in 2011 after a \$1 billion investment. # Lawmakers say fence project comes up short

The fence that Boeing Co. is building along the U.S.-Mexico border may be virtual, but the political headaches it has generated are not. To relieve the pressure, the company appears to be relying on a time-tested Washington remedy: redefining the debate. The aerospace giant came under fire last week after the Department of Homeland Security revealed that the so-called virtual fence that is part of the effort to secure the Southern U.S. border is badly behind schedule and has failed to meet many of its goals. The first 100 miles of the high-tech barrier were supposed to be completed this year, and the rest, by 2011.

Last week, Homeland Security and Boeing, the lead contractor for part of what is ultimately expected to be a \$7.6 billion project, were put in the uncomfortable position of having to explain to two House homeland security panels why the initial phase is three years behind schedule and the completion date is uncertain.

In an attempt to assuage irritated lawmakers on both sides of the aisle, Boeing has engaged in a two-pronged lobbying and public relations strategy that is part mea culpa and part reframing expectations.

The stakes are especially high, since the project agreement allows Boeing to be replaced once its contract elapses.

"I'm sure it is an uncomfortable place for them to have such a high-profile contract on such a radioactive issue," said C. Stewart Verdery Jr., a former DHS official who now heads the Monument Policy Group, a lobbying firm that specializes in homeland security.

Boeing declined to comment, referring reporters to the DHS and to the company's earlier testimony during a House homeland security hearing.

During the hearing, Boeing's president of network and space systems, Roger Krone, said the company was trying to do better.

"While we are proud of the accomplishment of our P-28 team, we recognize the need to incorporate improvements and lessons learned into the overall SBInet program," he said. The Southern Border Initiative network, or SBInet, is the official name of the virtual fence program. The first stage is called Project 28.

Meanwhile, in meetings with lawmakers, Boeing's lobbyists argue that P-28 was never supposed to have been a fully functioning barrier — just a prototype or a demonstration project.

"It is unfair to judge it as a Berlin Wall," said a Boeing insider who spoke on the condition of anonymity. "It will be clear as this moves forward that this is a system that has great promise and that it is going to be an integral part of the overall solution to the immigration problem."

Among its many lobbyists on contract, Boeing has some well-connected advocates. Thomas Blank, former acting deputy administrator of the Transportation Security Administration, and Chad Wolf, who was the agency's assistant administrator, are working on the issue. Both are with Wexler & Walker Public Policy Associates, which was paid \$120,000 to work on the contract during the second half of last year.

Also on call is former Rep. Bill Paxon (R-N.Y.), who's managing a team of lobbyists in the law firm of Akin Gump Strauss Hauer & Feld, which Boeing paid \$300,000 during the same time period.

The real problem, say Boeing's advocates, is that the DHS oversold the project. They argue that Boeing did a lot in a very short time — only eight months — and had met its goal of a demonstration project for high-tech fencing

<u>Thomas Blank, a former</u> lobbyist and Republican official, was recently appointed to serve as the chief of staff to the U.S. Immigration and Customs Enforcement, the agency charged with investigating and enforcing immigration-related matters for the Department of Homeland Security.

There was no public press release and no announcement to mark the senior appointment. Rather, the only official acknowledgement of Blank's new post was found through a quiet update to the ICE leadership <u>website</u> this week.

"Thomas Blank's appointment as Chief of Staff for U.S. Immigration and Customs Enforcement was finalized on Wednesday, July 12," said ICE Assistant Director for Public Affairs Liz Johnson, in a statement to The Intercept.

"Information about his appointment was then sent internally to staff and posted on the ICE.gov website, as is standard practice. Since Mr. Blank did not represent clients with ICE interests and never lobbied the agency, there are no conflict of interest concerns with Mr. Blank's former employment."

Blank arrived to ICE after working for over a decade as a corporate lobbyist, helping corporate contractors secure business before the agency he now leads. As the <u>vice chairman</u> of the lobby shop Wexler & Walker, Blank "established the firm's growing Homeland Security Practice by building a base of clients with policy and business development interests on Capitol Hill, in The White House, and before the Departments of Homeland Security and Transportation."

Blank's ICE biography makes a passing reference to his 12-year lobbying career, noting that he "provided private sector consulting services in business development primarily for the security technology industry."

Records show Blank attempted to influence lawmakers and homeland security officials on behalf of a number of government contractors. His clients included <u>firms</u> such as the company <u>formerly known</u> as Taser International, the manufacturer of electronic shock weapons used by law enforcement as an alternative to firearms. Another former Blank client, Assuretec Inc., <u>specializes</u> in facial recognition and identity authentication.

Notably, Chad Wolf, another prominent Homeland Security lobbyist appointed this year by the Trump administration to the Department of Homeland Security, was Blank's colleague on a number of lobbying campaigns. The pair registered to lobby on behalf of Analogic Corp., a baggage screening company, which sought a bid for lucrative contracts with the Transportation Security Administration.

Blank, before his career as an influence peddler, worked as a staffer to then-Speaker Newt Gingrich, and after that, as a senior official in the George W. Bush administration. He assisted with the creation of the Office of Transportation Security Policy, the sub-agency that developed security procedures for the Transportation Security Administration after the attacks of September 11. Like <u>many officials</u> charged with overseeing the growth of the post-9/11 TSA, Blank transitioned afterwards to the private security industry to help business interests cash in on new contracts.

Blank has also worked for former Democratic lobbyist Dick Gephardt at his firm, Gephardt Government Affairs, and through a firm founded by Blank called Belvedere Strategies. Last year, Blank signed a <u>contract</u>, through a partnership with Gephardt Government Affairs, to lobby on behalf of the government of Turkey to assist with President Recep Tayyip Erdogan's outreach efforts in Washington.

The appointment is the latest in a long procession of revolving door hires. President Donald Trump has filled his government with former corporate lobbyists overseeing key decisions on matters from agriculture to health to financial regulation to military acquisition and beyond.

Homeland security lobbyists have played a pivotal role in shaping the administration's agenda in particular. As we've reported, lobbyists for businesses involved in immigrant detention and mass surveillance have won political appointments to <u>ICE</u> and <u>DHS</u>. Secretary John Kelly, the head of the agency, failed to publicly <u>disclose</u> his own financial ties to security contractors during the confirmation process.

DACA STALLED AT SOTU: President Donald Trump will deliver his first formal State of the Union address before a joint session of Congress at 9 p.m. tonight. He told reporters Monday that immigration would be a topic, along with taxes and trade. "For many, many years they've been talking immigration, they never got anything done," Trump said following a swearing-in ceremony for Health and Human Services Secretary Alex Azar. "We're going to get something done, we hope. It's going to be bipartisan because the Republicans really don't have the votes to get it done in any other way, so it has to be bipartisan. But hopefully the Democrats will join us, or enough of them will join us, so we can really do something great for DACA and for immigration generally."

**Trump's push comes** as lawmakers continue fractious immigration talks on Capitol Hill. Several top Republicans and Democrats met Monday afternoon with White House chief of staff John Kelly, legislative affairs director Marc Short, and Homeland Security

Secretary Kirstjen Nielsen to discuss the administration's <u>legislative framework</u>. The White House plan, which includes a path to citizenship for nearly 2 million DREAMers, \$25 billion for a border wall, limits on family-based immigration, and a termination of the diversity visa lottery, received a cold reception last week from many Democrats and some Republicans.

**Senate Minority Whip** <u>Dick Durbin(D-III.)</u> reiterated his opposition to the Trump plan as he entered the meeting, citing as "one of the most serious problems" the administration's drastic reduction in family-based immigration."The strength of American families has been a pillar of our country for as long as I can remember," he said. "To literally divide families from their children is inconsistent with the values that I thought both parties embraced." (The proposal would allow citizens and permanent residents to sponsor spouses and minor children, but not parents, adult children, or other family members.)

Senate Majority Whip John Cornyn (R-Texas), also in attendance, said Democrats would need to embrace some aspects of the White House proposal. "I know the Democrats would just like to take the DACA piece and forget the rest, but we're not going to do that," he told reporters after the meeting. Nielsen, who attended the gathering with DHS legislative affairs director Ben Cassidy and other department officials, said the president's framework should guide discussions on Capitol Hill, but she wouldn't say where lawmakers had found agreement, if any. "I think president has made an offer, so we're starting from there," she said.

At least two dozen Dreamers will attend the State of Union, mostly as guests of Democrats, though Rep. <u>Carlos Curbelo</u> (R-Fla.) also invited a DREAMer. At the other pole of the immigration debate, the White House - which has repeatedly sought to link immigration and crime - will invite the mother of a teenager allegedly killed by four MS-13 gang members, the New York Times <u>reports</u>. Several Democrats, including Rep. <u>Frederica Wilson</u> (D-Fla.), won't attend the event, CNN's Sophie Tatum <u>reports</u>. "I cannot in good consciousness attend the #SOTU address after the president went so low in his remarks about Haiti & African nations," Wilson <u>tweeted</u> in mid-January. "It would be hypocrisy to go to an event at which he is honored."

"A three-judge panel remanded a majority of the NLRB's findings from a multi-pronged 2016 ruling which, among other things, held that The Daily Grill proffered a series of workplace handbook rules that were too broad and could be interpreted by employees as discouraging them against engaging in union activity." **#METOO TRICKY IN 2018:** "As they prepare for the 2018 elections, both Democrats and Republicans are dealing with dissenting opinions in their ranks over their handling of candidates or officeholders facing sexual harassment allegations," POLITICO's Maggie Severns and Marianne LeVine report.

"While most Republican officeholders interviewed by POLITICO over the past two weeks expressed the view that voters, not lawmakers, should decide whether a lawmaker accused of sexual harassment loses his or her seat, the GOP lawmakers charged with increasing their party's majorities in Congress say they're ready to take action if credible allegations against a candidate surface in the future," the pair write. "Meanwhile, Democrats, who moved quickly to withdraw support for Sen. Al Franken, Rep. John Conyers and Kansas congressional candidate Andrea Ramsey based on allegations from many years earlier, are facing some complaints over what some perceive to be a rush to judgment." **DEMS CALL FOR BETTER DATA:** "Twenty-two Democratic senators sent a letter to the top federal labor officials on Monday demanding their department collect more and better data concerning sexual harassment in the United States workforce," Lam Thuy Vo reports in BuzzFeed. "The senators are requesting the Labor Department collect data on the 'prevalence and cost of sexual harassment," the outlet reports. "In particular, the senators want the department to do a study on the economic impact of sexual harassment on the labor force broadly and on workers themselves on a national level." CATO ON WHITE HOUSE PLAN: David Bier and Stuart Anderson of the libertarian Cato Institute write in a blog post that the Trump immigration plan "calls on Congress to enact draconian restrictions on legal immigrants. Members of Congress will have to flesh out the details, but in the most likely scenario, the new plan would cut the number of legal immigrants by up to 44 percent or half a million immigrants annually-the largest policy-driven legal immigration cut since the 1920s." CHAMBER BACKS DACA, TPS PROTECTIONS: The U.S. Chamber of Commerce urged the federal government to safeguard immigrants in a post ahead of Trump's State of the Union address. "We're calling on Congress to quickly take action to protect the roughly 200,000 TPS beneficiaries, the over 30,000 spouses of high-skilled visa holders, and the some 690,000 Dreamers in our country," Executive Vice President Neil Bradley wrote Monday.
