PLAINTIFF'S SUPPLEMENTAL STATUS REPORT

Pursuant to this Court's order the parties in this case filed a Joint Status Report on July 31, 2020 (ECF 15) ("July 31 JSR"). As part of that report, CREW noted that the State Department effectively was seeking an open-ended stay of its court-ordered processing obligations, but had failed to demonstrate an inability to process any records on its classified system. July 31 JSR ¶¶ 17, 18. CREW further noted that while State has claimed an inability to process the classified documents at issue here, it has found the necessary personnel to provide Republican members of Congress with thousands of pages of documents, including classified information. *Id.* ¶ 19.

On August 6, 2020, the Court entered a minute order scheduling a telephonic status conference for August 26, 2020. The Court's Order noted that "[t]he State Department should be prepared to address its timeline for processing of classified documents."

Recent reporting has brought to light an internal State Department memorandum dated August 17, 2020, concerning a congressional request for documents from the Chairs of the Senate Committee on Homeland Security and Governmental Affairs and the Senate Committee

on Finance. *See* Natasha Bertrand, Andrew Desiderio and Kyle Cheney, <u>Pompeo aid orders State</u>

ClassNet and OpenNet, respectively." Plaintiff submits this report to supplement the information

provided in the Joint Status Report on the ability of the State Department to marshal resources to

comply with document requests from Republican members of Congress.

SUMMARY AND BACKGROUND

The Senate Finance Committee (SFC) and Senate Homeland Security and Government Affairs Committee (HSGAC) have written a request for records as follow up to their investigatory letters of November 6, 2019 and April 30, 2020. Some items in the attached letter have already been tasked and this tasker will encompass items numbered 3 and 4. The timeframe for this collection is January 1, 2016 and December 31, 2017.

Action bureaus, please provide:

- All records from 2016 through 2017 related to communications between former Deputy Secretary of State Strobe Talbott or any other employee of the Brookings Institution and any then-current State Department official about Christopher Steele or the Trump campaign.
 - O Suggested terms are combinations of the above individuals' names as well as searching with the Brookings Institute's email domain: "@brookings.edu"
- All records from 2016 through 2017 related to communications between Sidney Blumenthal or Cody Shearer and any then-current State Department official about Russia, Christopher Steele, or the Trump campaign.
 - O Searches conducted should include keyword searches of the above three individuals' names as well as "Trump."
- Please also refer to at the attached letter when considering searches.

Please ensure that all records in the custody of your office or bureau that may be responsive are searched and provided. As some of these records may be retired, action bureaus should work with the A bureau to identify retired records of the named individuals.

<u>Info bureau(s)</u>, please notify Bill Killion in H and Ken Thomas in L/M if you are aware of responsive documents with your bureau that would not be duplicative of those in the action bureau(s). Please be advised that your bureau may be tasked in the future for documents responsive to this request.

INSTRUCTIONS

Please review this memorandum to ensure all records in the custody of your office or bureau containing potentially relevant materials are searched.

The Committee on Homeland Security and Governmental Affairs (HSGAC) and the Committee on Finance are investigating matters related to the Federal Bureau of Investigation's (FBI) Crossfire Hurricane investigation, and potential conflicts of interest relating to the Obama administration's policy decisions with respect to Ukraine and Burisma Holdings. On June 4, 2020, HSGAC authorized the issuance of a subpoena for all records relevant to our investigation of Crossfire Hurricane.
