Dear Mr. Sus:

The Department of Defense (“DoD”), Office of Information Counsel, is providing a fifteenth response to your January 10, 2021 Freedom of Information Act (“FOIA”) request to DoD. You requested, in part, “All records reflecting the parameters for the National Guard’s deployment to D.C. on January 6, 2021, including any limitations imposed on the number of personnel deployed, their movement within the District, or their use of force.”

One hundred and forty five (145) pages are enclosed, all of which contain information that has been withheld from release in part or in full under Title 5 U.S.C. § 552 (b)(5), which pertains to certain inter- or intra-agency communications protected by the deliberative process and/or attorney-client or attorney work product privileges; (b)(6), which allows for withholding information, that if disclosed, would result in a clearly unwarranted invasion of the personal privacy of individuals; and (b)(7)(E), which allows for withholding information that if disclosed, would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law

In addition, we have conducted a foreseeable harm analysis under the FOIA Improvement Act of 2016 and, after consulting with appropriate subject matter experts, 1) we do not reasonably foresee that disclosure of some of this information would harm an interest that the FOIA's exemptions were designed to protect and/or 2) disclosure would not be prohibited by law. Therefore, we are releasing this information in part. Please be aware that our decision to release this information does not mean that we have waived our ability to invoke applicable FOIA exemptions for similar or related information in the future. For the remainder of this material, we reasonably foresee that disclosure would harm an interest protected by one or more of the nine exemptions to the FOIA’s general rule of disclosure and/or disclosure would be prohibited by law.
