Dear Mr. Sus:

As we noted in our letter dated June 9, 2022, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department of State has identified an additional five responsive records subject to the FOIA. We have determined all five records may be released in part.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made redactions, the applicable FOIA exemptions are marked on each record. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed.

For your information, we have partially redacted the e-mail addresses of Secretaries Pompeo and Mnuchin in these records. The e-mail address belonging to Secretary Mnuchin appears only in Document No. 511483 as "S," specifically in (1) the "To" section of the e-mails dated January 7, 2021, at 18:36:15 and at 7:13:49 PM, and January 5, 2021, at 4:15:15 AM, (2) the "From" section of the e-mails dated January 7, 2021, at 1:31 PM and January 5, 2021, at 10:52 AM, and (3) the "Recipient" section in the last page of that document. All other instances of e-mail addresses redacted as "S" in these records belong to Secretary Pompeo.

We will keep you informed as your case progresses. GENERAL LICENSE NO. 1

Authorizing Transactions Involving Securities of Certain Communist Chinese Military Companies

(a) Except as provided in paragraph (b) of this general license, all transactions and activities prohibited by section 1(a)(i) of Executive Order (E.O.) 13959 involving publicly traded securities, or any securities that are derivative of, or are designed to provide investment exposure to such securities, of an entity whose name closely matches the name of a Communist Chinese military company identified in the Annex to E.O. 13959 but that has not been listed on the Office of Foreign Assets Control's Non-SDN Communist Chinese Military Companies List, **are authorized through 9:30 a.m. eastern standard time, January 28, 2021.**

(b) This general license does not authorize any transactions or activities otherwise prohibited by E.O. 13959, any other E.O. or statute, or any part of 31 C.F.R. part V.
