Political News:

Rada Updates: Office of the President Head Andriy Bohdan believes the new Rada will not meet before September 1. "Given that I'm a lawyer, I understand the timeline for the work of the Verkhovna Rada, it probably won't have time to start work before September

1," he said at a press briefing in Kyiv July 30. The start date depends on a large number of lawsuits that do not allow the Central Election Commission of Ukraine to form the final convocation of the future parliament, Bohdan said. (<u>UkrPravda</u>) In other Rada news, media reported Oleksandr Dubinsky of Servant of the People, also associated with TV channel 1+1, declared the creation of an MP group in the Verkhovna Rada on his Telegram channel. "We decided to create an MP group of deputies elected in first-past-the-post constituencies under the provisional title 'Justice' in the new parliament. There are five of us already. Join in," he wrote. Dubinsky posted photos from Truskavets also featuring blogger Oleksandr Kunitsky and 1+1 journalist Olga Vasilevska-Smahliuk. Another possible MP to join the group is Maxim Buzhanskiy, who won in the 25th single-mandate constituency in Dnipropetrovsk region, media reported. (<u>Hromadske</u>)

Update on Russian Tanker Detained Last Week: A Ukrainian court has analyzed the legitimacy of actions taken by military prosecutors and Security Service investigators in searching the Russian tanker Neyma at the Izmayil port in Odesa region July 25 and put both the tanker and the documents found during the search under arrest, Ukrainian Chief Military Prosecutor Anatoliy Matios wrote on Facebook. He dismissed arguments that the investigative procedures on board the vessel were illegitimate without permission from the Russian consul. In addition, he noted: "The existing international treaties ratified by both Russia and Ukraine do not envision the need to obtain consent or permission from a diplomatic or consular official of a foreign state to conduct investigative procedures on board a sea or river vessel in Ukrainian territory." (Ukr Pravda) Media also reported the Russian Foreign Ministry commented on the arrest of the tanker Neyma. Russian Deputy Foreign Minister Grigoriy Karasin, said, in an interview to Russian radio Kommersant FM, that it is the owner of Neyma tanker who should challenge the decision of Ukrainian authorities to arrest the tanker. "The most important thing for us was to get the people released. Our citizens, sailors, are at home now. The vessel is privately owned, so all must be resolved through court,"Karasin said. According to him, the Russian MFA will follow the situation with the tanker. (Ukr Pravda)

Plans for Ukrainian Independence Day: The Office of the President announced a new format for Independence Day celebrations. "Instead of a traditional Soviet-style parade with an expensive demonstration of military equipment on the capital's central street, a March of Dignity will take place. This European-style event intends to begin a new tradition of honoring everyone Ukraine is proud of. The plan is that representatives of various branches of troops and the Armed Forces of Ukraine will march along Khreshchatyk Street. ATO veterans will be able to join in with members of their brigades," Office of the President Head Andriy Bohdan said at a press conference in Kyiv July 30. According to Bohdan, medics, teachers, athletes, diplomats and civil volunteers, as well as the head of the Ukrainian state will also join the march. "This will be a modern event in ideological and technical aspects. President of Ukraine Volodymyr Zelenskyy and other leaders of the state will take part in the march. After that, the head of state will address the Ukrainian people," Bohdan said. (1+1 TSN 19.30 Broadcast)

Commentary from PM Groysman on Poroshenko: Media quoted Prime Minister Groysman's reaction to former President Petro Poroshenko's interview to Ukrainska Pravda. Groysman said: "It is a pity that he [Poroshenko] subverted people's big hopes and support [in support of] his private interests. Eventually, given his approaches, I was unable to realize all that I had intended to do. That's why we have different paths to

follow. Well, for him it's all over. But, I am sure, for Ukraine all lies ahead!" (<u>Ukr</u> Pravda)

Economic News:

Deputy Head of Presidential Office outlines Ukraine's free-market path: Deputy Head of the Presidential Administration Oleksiy Honcharuk said that the new President's economic team intends on taking the free-market path that proved successful for Ukraine's western neighbors – Poland, Hungary, and Slovakia – in the 1990s. President Zelenskyy is committed to strategic partnership with the IMF and World Bank and plans to implement an aggressive program of selling state-owned enterprises. According to Honcharuk, who is a widely considered a leading candidate for Prime Minister, the new government will be formed in August and the Rada will convene in early September. Finance Minister Oksana Markarova and the current central leadership are to be retained as the new government moves toward a fiscal surplus and renegotiates the IMF program.

The ban on farmlands sales may be lifted before end-2019: Honcharuk also said the Presidential team believes that the moratorium on sales of agricultural land hampers economic growth and should be lifted in 2019. The President's Office is holding talks with the World Bank on the best model for opening up the agricultural market in Ukraine. According to different scenarios, lifting the moratorium may accelerate Ukraine's economic growth by 0.5 percent to 3 percent per year.

Finance Ministry sold a record amount of hryvnia bonds on July 30: The Ministry of Finance placed UAH 17.2 billion (\$690 million) in sovereign bonds on July 30 - 150 percent more than at last week's bond auction. The bond maturity also increased and interest rates dropped by 20 to 50 basis points compared to last week.

Hryvnia strengthens to its highest position against the U.S. dollar in three years: OnJuly 30, the hryvnia exchange rate reached UAH 25 to the U.S. dollar, strengthening 10.7 percent from January 2019. According financial market experts, the main reason for hryvnia strengthening against the dollar is regular sales of foreign currency at Ukraine's interbank market by non-residents preparing to purchase hryvnia-denominated bonds.

Ukrainian Social Media Commentary:

Ukrainian social media users are discussing a conflict between Kyiv City Mayor Vitaliy Klitschko and the Office of the President of Ukraine. At a July 30 press conference, Andriy Bohdan, Head of the Office of the President, <u>said</u> that in a private conversation, Klitschko told him he lost control over the Kyiv City Council and "there are a couple of 'supervisors' controlling the groups of deputies [in the City Council]." Bohdan also said some of those 'supervisors' contacted him and tried to convince him to leave Klitschko in the office and offered Bohdan a bribe for this.

Some social media users expressed <u>concerns</u> over attempts to get rid of Klitschko. "If the new government listens to the opinion of the people, and this is how it positions itself, then let's hold early elections of the Mayor of the capital, see who wins and appoint him the head of Kyiv City State Administration. This is the ideal democratic, fair option. Moreover – let's change the Law On the Capital and merge the offices of Mayor and head of the Kyiv City State Administration, getting rid of Yanukovych's usurpation legacy. Otherwise, it turns out that the right to elect the local government is being taken away from the residents of Kyiv," wrote blogger Serhiy Naumovich.

Blogger and columnist Olexiy Minakov <u>wrote</u> that he thinks Bohdan's press conference was a massive information attack on Klitschko, which serves only as the groundwork for an upcoming "bigger media campaign against him aimed at his weakening and removal from real affairs."

Klitschko himself wrote on Facebook that Bohdan's allegations are "[HBO's] Tales from the Crypt – all he said is a collection of gossip, manipulative speculation and nothing more." Klitschko contined: "When the head of the Office of the President says such things it looks, at least, strange and incompetent. Mr. Bogdan, hand over all your "horror stories" to law enforcement. And don't embarrass yourself with such "informative speeches"! You are also manipulating laws and the Constitution. Reminder: Kyiv residents elect a government that is responsible for everything that happens in the city. And the attempt to divide the offices of mayor and chairman of the Kyiv City State Administration is an attempt to deprive the community of the right to influence the processes of managing the capital, it is also an attack on local self-government." The next day, July 31, Klitschko posted pictures of a meeting with lawyer Rudy Giuliani, calling him "an old friend" and "one of the most reputable mayors in the world." Some Ukrainian social media users viewed Klitschko's step as trolling in retaliation for Bohdan's accusations. Some social media users criticized Klitschko for pursuing personal goals, while others appreciated his action.






- The Embassy's implied message to Ukraine's prosecutors: Don't target Antac in the middle of a U.S. presidential election, in which Soros was backing Clinton.
- The Embassy applied pressure because it did not want Americans to see who was being funded with U.S. tax dollars.
- The State Department said last week there was not a do-not-prosecute list. But Kent's letter shows Embassy pressure on what would normally be a sovereign country's internal law enforcement matter. This was not the only case in which American officials exerted pressure on Ukrainian investigators in 2016.
- After the Obama Justice Department launched its <u>Kleptocracy Asset Recovery Initiative</u> a decade ago to prosecute corruption in other countries, the State Department, Justice Department and FBI outsourced some of its work in Ukraine to groups funded by Soros. AntAC, which received 59 percent (or \$1 million) of its nearly \$1.7 million budget since 2012 from U.S. budgets tied to State and Justice, and nearly \$290,000 from Soros's International Renaissance Foundation, <u>according to the group's donor disclosure records</u>.
- The U.S.-Soros collaboration was visible in Kiev. Several senior Department of Justice (DOJ) officials and FBI agents appeared in pictures as participants or attendees at Soros-sponsored events and conferences. One of those was Karen Greenaway.

FBI response was in the article: The FBI confirmed Greenaway's contacts with the Soros group, saying they were part of her investigative work: "In furtherance of the FBI's mission and in the course of their duties, FBI employees routinely travel and participated in public forums in an official capacity. At a minimum, all such travel and speaking engagements are authorized by the employee's direct supervisor and can receive further authorization all the way up to the relevant division head, along with an ethics official determination."

• In one event during 2016, Greenaway and Ambassador Yovanovitch participated alongside AntAC's executive director, Daria Kaleniuk, and Lutsenko was present. The message was clear: the embassy supported AntAC.


