1. Embassy is requested to deliver the following message from ENR Assistant Secretary Francis R. Fannon to Ukrainian Prime Minister Volodymyr Groysman. The Department does not plan to release the text. No signed original will follow.

## 2. Begin text:

# Dear Prime Minister Groysman:

As you know, the United States is deeply committed to the energy security of Ukraine and the prosperity of the Ukrainian people. For that reason, I am writing out of concern for the future of Naftogaz. I understand you plan to make a decision about whether to permit an extension of the current Executive Board's tenure in the next few days. I urge you to maintain the continuity of the Board through 2019.

In a few short years, Naftogaz has gone from being an enormous drain on Ukraine's budget to now annually contributing 15 percent of budget revenues. Stability in Naftogaz operations and management are critical to Ukraine's fiscal solvency, its reputation in Europe, and its attractiveness to international investors.

Improvement in Naftogaz's earlier reputation for enabling corruption are testimony both to your dedication to reform and to the competence and dedication of the current Executive Board. CEO Andriy Kobolyev, the Executive Board, and the Supervisory Board have turned around Ukraine's largest enterprise. Their experience, competence, and professionalism will be hard to replace quickly.

Changing the Naftogaz leadership now also risks reducing Ukraine's effectiveness in the trilateral transit negotiations. Removal of the entire Board would also disrupt the needed corporate governance and gas sector reforms underway, including the unbundling of Naftogaz's gas transmission system. We are concerned that this could also set Ukraine on the path to an energy emergency—and therefore a national security crisis.

In the absence of a gas transit contract between Gazprom and Naftogaz that can take effect January 1, 2020, Ukraine runs the risk of being unable to access to enough natural gas next winter to provide adequate heat for the Ukrainian people. If Ukraine is unprepared, Russia will have more influence once the gas for heating runs out. The current Naftogaz leadership can best ensure the extensive preparations are in place to avoid this scenario. It is my understanding that even a one-month disruption of Naftogaz operations to accommodate a recruitment and selection process could make it difficult to prepare adequately for winter.

If such a supply crisis develops, Russia will be the only beneficiary. Ukraine will be at a serious disadvantage and the Ukrainian people will bear the cost. We believe there will likely be geopolitical consequences and humanitarian fallout.

The United States remains ready to assist Ukraine to ensure its energy future and its national security. We continue to work diplomatically with the European Commission and international donors towards an actionable unbundling plan and to provide technical assistance to Naftogaz to advance corporate governance reforms and increase domestic gas production.

I strongly urge you to come to an agreement in your current discussions with the Supervisory Board and ensure continuity of Naftogaz leadership at this pivotal moment for Ukraine's future.

The United States welcomes the opportunity to advance shared principles and is committed to working with Ukraine to prepare for a winter gas shortage. U.S. experts can share policy and technical insights with Naftogaz and other relevant entities based on our prior experience helping Ukraine with the Winter Action Plan between 2014 and 2016. We welcome future discussions on how the United States can assist over the coming months.


