As we noted in our letter dated January 27, 2023, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. Thus far, the Department of State has identified four additional responsive records subject to the FOIA. We have determined that all four records may be released in part.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made redactions, the applicable FOIA exemptions are marked on the record. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed.

I'm confused over all the entries in Tab B for the Ministerial to Advance Religious Freedom. You have:

Lunch – Whole Foods, Amazon -- \$482.13 (Day 2)  
Waitstaff – Day 2 Lunch -- \$4,894.00  
Waitstaff – Day 1 lunch -- \$3,175.50  
Lunch – Costco, The Market -- \$225.19 (Day 1)  
Reception Day 2 – Ridgewells -- \$108,635.00 (Day 1)  
Reception Day 3 – Ridgewells -- \$83,700.00 (Day 2)  
Lunch – Costco – 1,330.12 (Day 1)

It appears that Ridgewells actually provided all day refreshments, lunch and reception on Day 1, and all-day refreshments and lunch on Day 2. I assume that the items purchased from Whole Foods, Costco and The Market go along with the items served by Ridgewells, and were not completely separate events from the Ridgewells events. Is that correct? I am trying to combine these expenses to go with the event they were for. Here is what I came up with based on the dates on the invoices:

Day 1 All-day refreshments, lunch and reception – Ridgewells, Costco, The Market --  
\$110,190.31  
Day 1 Waitstaff -- \$3,175.50

Day 2 All-day refreshments and lunch – Ridgewells, Whole Foods, Amazon -- \$84,182.13  
Day 2 Waitstaff -- \$4,894.50
