Dear Mr. Meginley:

Citizens for Responsibility and Ethics in Washington (“CREW”) makes this request for records pursuant to Title 44 of the Louisiana Public Records Law and Article XII, Section 3 of the Louisiana Constitution.

First, CREW requests copies of any communications, dated (1) January 1, 2022 through February 28, 2022 and (2) January 1, 2023 through March 31, 2023 pertaining to or mentioning (1) the Electronic Registration Information Center (ERIC) or (2) David Becker, former board member of ERIC, between the Office of the Secretary of State and any of the following individuals:

- Chrissy Peters, Missouri Senior Director of Elections;
- John (Jay) Ashcroft, Missouri Secretary of State;
- Brittany Westfall, West Virginia Director of Elections; or
- Mac Warner, West Virginia Secretary of State;
- Wes Allen, Alabama Secretary of State;
- Jeff Elrod, Alabama Director of Elections;
- Frank LaRose, Ohio Secretary of State;
- Amanda (Mandi) Grandjean, Ohio Director of Elections and Deputy Assistant Secretary of State;
- Cord Byrd, Florida Secretary of State;
- Maria Matthews, Director, Florida Division of Elections; or
- Thomas Fitton, President of Judicial Watch.

Second, CREW requests copies of any communications, dated (1) November 1, 2020 through January 31, 2021 and (2) December 1, 2021 through January 31, 2022 pertaining to or mentioning (1) ERIC or (2) David Becker, former board member of ERIC, between Secretary of State R. Kyle Ardoin and any of the following individuals:

- Sherri Wharton Hadskey, Louisiana Commissioner of Elections; or
- Shane Hamlin, Executive Director, ERIC.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes

without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to emails and other records, as well as emails to which the subjects of this request were cc'ed or bcc'ed.

If it is your position that any portion of the requested records is exempt from disclosure, you are required to state the basis of the exemption you contend is applicable. LA Rev. Stat. § 44:35. CREW further requests that you state in writing and with particularity the reasons for any conclusion that a record is exempt or confidential. LA Rev. Stat. § 44:35. If some portions of the requested records are properly exempt from disclosure, you are required to redact those portions and produce the remainder of the requested records. LA Rev. Stat. § 44:32(B). If this public record is not within your custody, you are required to certify on writing the absence of the record, as well as either the reason for the records' absence or its location. LA Rev. Stat. § 44:34.

CREW agrees to pay up to \$100 for copies of the requested records. If copying fees are expected to exceed this amount, please contact me.

If you believe this request is ambiguous or overly broad such that the requested information cannot be reasonably identified, please inform me so that the request can be revised or negotiated in accordance with how records are maintained and accessed in the ordinary course of the office's duties. Where possible, please produce records in electronic format. Please send the requested records to kfarchadi@citizensforethics.org and foia@citizensforethics.org, or to 1331 F Street, NW, Suite 900, Washington, DC 20004.

Please contact me if you have any questions about this request or foresee any problems in fully releasing the requested records. We anticipate you will fulfill your obligations under the law. If it is necessary to file an action to enforce LA Rev. Stat. § 44:31 the court may award reasonable costs of enforcement, including attorneys' fees. LA Rev. Stat. § 44:35 D (1).
