#### I. ALLEGATION.

I am alleging that, Department of the Navy, Office of the Judge Advocate General (DON JAG) destroyed or may be about to destroy:

- 1 FOIA Appeal case processing records and notes of my administrative appeal to DON JAG (dated July 27, 2013 but sent by confirmed fax of August 19, 2013 at 4:51) of my June 29, 2013 FOIA/PA Request FOIA Request #13 19 and Department of the Navy Office of the Judge Advocate General (DON JAG) appellate determination letter "ser 14/396; Subject: Freedom of Information Act (FOIA) Appeal 2013 dated 18 Sep 13"
- 2. FOIA Appeal case processing records of my subsequent January 18, 2014 administrative appeal to DON JAG and DON JAG's February 4, 201 2014 final appellate determination thereto (sought under my January 15, 2017 FOIA request **DON 18-AR** to DON On administrative appeal of my **DON 18-**AR, DON JAG affirmed for the second time that DON JAG could not locate case records required to be maintained in its very own office, which must therefore have been destroyed.
- 3 Else records are at risk of actual, impending, or threatened damage, alienation, or unauthorized destruction.

The "Case records" of my administrative appeal to DON JAG (dated July 27, 2013 but sent by confirmed fax of August 19, 2013 at 4:51) of my June 29, 2013 FOIA/PA Request FOIA Request #13-19 may be in immediate, eminent danger of being destroyed IAW Navy's claimed disposition schedule of 7 years, despite the records being sought in subsequent FOIA requests. The Department of the Navy Office of the Judge Advocate General falsely stated by letter (DON JAG letter 5720 2014Y000054, ser 14/06 dated February 4, 2014) that I had not appealed my June 29, 2013 FOIA/PA Request FOIA Request #13-19 (when I had done

so by confirmed fax), leading the presumption that DON JAG has destroyed records of that appeal or are about to destroy them.

DOJ JAG's February 4, 2014 letter also contains materially false statements. While the matters relating to the alleged improper FOIA requests/appeals processing are not matters for NARA, the impending or actual unauthorized disposition of records is NARA's responsibility

This complaint specifically and **only** addresses records in the custody of **Department of Navy** not those of any other entity

#### II. ACTION SOUGHT.

- 1 Notify Department of Navy within 5 working days
- 2. Provide me a point of contact by return email to discuss this matter.
- 3 Permit me to discuss the Agency's reply prior to deciding on this complaint to preclude the likely provision of misinformation, as has been done in the past.
- 4 If records have not been destroyed, seek that the Agency provide them to you along with a record count and page number count for each record.

#### III. <u>IDENTIFICATION OF RECORDS</u>

#### Background.

- 1 I appealed my FOIA/Privacy Act request #13 19 (related to a DVD of my medical records) to DON JAG by letter dated July 27, 2013 but sent by confirmed faxes to DON JAG of Aug 19 4:51AM & Aug 19 5 05AM That Appeal addressed my FOIA requests 13 01 to 13 24, including my FOIA request 13-19.
- 2 Department of the Navy Office of the Judge Advocate General (DON JAG) letter ser 14/396; subject Freedom of Information Act (FOIA) Appeal 2013 dated 18 Sep 13 combined multiple distinctly different appeals, but acknowledged my August 19 Appeal, stating

"This responds to your FOIA appeal dated July 20, 2013, received in our office on July 26, 2013; three separate appeals dated July 22, 2013, also received on July 26, 2013; an appeal dated July 27, 2013, received August 19, 2013; and an appeal dated and received August 19, 2013"

3. I submitted a subsequent appeal on January 18, 2014 to DON JAG.

- 4 DON JAG replied in an appellate determination letter of February 4, 201 2014, falsely stating that I had not appealed my FOIA request #13-19 (and errantly citing a July 20, 2013 appeal vice the correct appeal dated July 27, 2013 but sent by confirmed faxes to DON JAG of Aug 19 4 51AM & Aug 19 5:05AM):
- 5 Thereafter on January 15, 2017, I submitted a FOIA request **DON 18 AR (DON NAVY 2018** 003238) to DON JAG seeking records FOIA appeals records related to "Hammond Appeal letter regarding unanswered PA/FOIA requests dated July 27, 2013 but received in your office on August 19, 2013" and "Hammond appeal letter subject FOIA/Privacy Act Request Appeal; Requestor Number # 13 19 Medical Records; Copy of DVD Containing PDF files of records received as of May 14, 2012, dated January 18, 2014."
- 6 On June 9, 2018 I submitted an administrative appeal (DON NAVY 2018 008414) to my FOIA request DON 18-AR identifying (among other things) specific records that had not been released and are now presumed destroyed DON JAG closed that appeal on January 25, 2019 without sending me any appellate determination letter nor posting such appellate determination letter to FOIAonline. Notwithstanding that DON did not send me the appellate determination letter, FOIAonline affirms that DOJ JAG could not locate records required to be retained in DON JAG's own office. The records identified in that closed appeal have not been released and must be presumed <u>destroyed</u> Those records are identified in paragraph B below.

In any case in which the head of a Federal agency does not initiate an action for such recovery or other redress within a reasonable period of time after being notified of any such unlawful action described in subsection (a), or is participating in, or believed to be participating in any such unlawful action, the Archivist shall request the Attorney General to initiate such an action, and shall notify the Congress when such a request has been made.

Each DoD Component shall preserve all correspondence pertaining to the requests that it receives under this part, as well as copies of all requested records, until disposition or destruction is authorized pursuant to title 44 of the United States Code or the General Records Schedule 4.2 of the National Archives and Records Administration (NARA). Records shall not be disposed of or destroyed while they are the subject of a pending request, appeal, or lawsuit under the FOIA.

#### VII. 36 CFR § 1230.3

Unlawful or accidental destruction (also called unauthorized destruction) means disposal of an unscheduled or permanent record; disposal prior to the end of the NARA-approved retention period of a temporary record (other than court-ordered disposal under § 1226.14(d) of this subchapter); and disposal of a record subject to a **FOIA request**, litigation hold, or any other hold requirement to retain the records.

# NARA Complaint ICO Navy DOJ JAG Destruction of Records. Appeal Records of WRNMMC 13-19 etc. Corrected/Streamlined

#### I. ALLEGATION.

I am alleging that, **Department of the Navy**, **Office of the Judge Advocate General (DON JAG)** destroyed or may be about to destroy:

- 1. FOIA Appeal <u>case processing records</u> and notes of my administrative appeal to DON JAG (dated July 27, 2013 but sent by confirmed fax of August 19, 2013 at 4:51) of my June 29, 2013 FOIA/PA Request FOIA Request #13-19 and Department of the Navy Office of the Judge Advocate General (DON JAG) appellate determination letter "ser 14/396; Subject: Freedom of Information Act (FOIA) Appeal 2013 dated 18 Sep 13."
- 2. FOIA Appeal <u>case processing records</u> of my subsequent January 18, 2014 administrative appeal to DON JAG and DON JAG's February 4, 201 2014 final appellate determination thereto (sought under my January 15, 2017 FOIA request **DON 18-AR** to DON On administrative appeal of my **DON 18-AR**, DON JAG affirmed for the second time that DON JAG could not locate case records required to be maintained in its very own office, which must therefore have been destroyed.
- 3. Else records are at risk of actual, impending, or threatened damage, alienation, or unauthorized destruction.

The "Case records" of my administrative appeal to DON JAG (dated July 27, 2013 but sent by confirmed fax of August 19, 2013 at 4:51) of my June 29, 2013 FOIA/PA Request FOIA Request #13-19 may be in immediate, eminent danger of being destroyed IAW Navy's claimed disposition schedule of 7 years, despite the records being sought in subsequent FOIA requests. The Department of the Navy Office of the Judge Advocate General falsely stated by letter (DON JAG letter 5720 2014Y000054, ser 14/06 dated February 4, 2014) that I had not appealed my June 29, 2013 FOIA/PA Request FOIA Request #13-19 (when I had done so by confirmed fax), leading the presumption that DON JAG has destroyed records of that appeal or are about to destroy them.

  - "This responds to your FOIA appeal dated July 20, 2013, received in our office on July 26, 2013; three separate appeals dated July 22, 2013, also received on July 26, 2013; an appeal dated July 27, 2013, received August 19, 2013; and an appeal dated and received August 19, 2013."
- 3. I submitted a subsequent appeal on January 18, 2014 to DON JAG.
- 4. DON JAG replied in an appellate determination letter of February 4, 201 2014, falsely stating that I had not appealed my FOIA request #13-19 (and errantly citing a July 20, 2013 appeal vice the correct appeal dated <u>July 27, 2013</u> but sent by confirmed faxes to DON JAG of Aug 19 4:51AM & Aug 19 5:05AM):
- 5. Thereafter on January 15, 2017, I submitted a FOIA request DON 18-AR (DON-NAVY 2018-003238) to DON JAG seeking records FOIA appeals records related to "Hammond Appeal letter regarding unanswered PA/FOIA requests dated July 27, 2013 but received in your office on August 19, 2013" and "Hammond appeal letter subject FOIA/Privacy Act Request Appeal; Requestor Number # 13-19 Medical Records; Copy of DVD Containing PDF files of records received as of May 14, 2012, dated January 18, 2014."
- 6. On June 9, 2018 I submitted an administrative appeal (DON-NAVY-2018-008414) to my FOIA request DON 18-AR identifying (among other things) specific records that had not been released and are now presumed destroyed. DON JAG closed that appeal on January 25, 2019 without sending me any appellate determination letter nor posting such appellate determination letter to FOIAonline. Your report should include a description of the records; the records schedule disposition citation that covers the files; details regarding the records destruction incident and recovery efforts; and a statement of the safeguards that have been or will be implemented to prevent future unauthorized disposals of such records.
