Dear Mr. Sus:

As we noted in our letter dated July 31, 2023, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. Thus far, the Department of State ("Department") has identified an additional 11 responsive records subject to the FOIA. We have determined that all 11 records may be released in part.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made redactions, the applicable FOIA exemptions are marked on each record. Where applicable, the Department has considered the foreseeable harm standard when reviewing these records and applying FOIA exemptions. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed. We will keep you informed as your case progresses. Please refer to the case number, FL-2020-00134, and the civil action number, 20-cv-02076, in all correspondence about this case.

Sean,

I was able to meet with Mike about our Madison Dinners before he flew back out today. Here are action items to pass along to you and the team:

Spreadsheets

#1, <u>What does "pending" mean on the dinner spreadsheets?</u> Does it mean invited by phone and waiting for reply? Or, phone and postal invitations extended and waiting for reply? Or, planning to invite but haven't yet? Could we clarify that and indicate that in the legend? (We think it should mean phone and postal invitations extended and we're waiting for a reply.)

#2, <u>What is the "Master Dinner List"?</u> Names on that list appear on other lists—it's confusing. The "Madison Dinner Attendees—Historic Record" list should be every person who attends a dinner (with full information), but name added ONLY after they have attended. And, any name on the Madison Dinner Attendee list should NOT appear on the "Potential Madison Dinner Guest" list.

#3, <u>Who is the person maintaining these spreadsheets?</u> As we fine tune these lists and provide more potential guest names and note information, we need to know with whom to work.

#4, <u>The Potential Madison Dinner Guest List.</u> We'll continue to add names to this list, so see #3 above.

Guest List/Invitation Timeline for Each Madison Dinner

Mike asked me to convey the following timelines for this dinner program, to better accommodate the schedules of these Dinner guests and our ability to avoid last minute scrambling:

<u>One Month Prior to Dinner, Phone and Postal Madison Dinner Invitations are out (Keep Susan</u> informed as you receive responses; she will flood new names to you for regrets; ^{(b)(6)} as we've discussed before—just shoot me a text or fast email when you log a regret)

Two Weeks Before Dinner, Fourteen persons are committed to attend Dinner.

July 26 Madison Dinner

Seating: Mike requests one small change: ^{(b)(6)} That is, starting at the end of the table (closest to hallway door) and moving toward me: Mrs. Mulhall (on end), Ambassador Mulhall, Veronica Cowher, Bill Cowher, Susan P.

Physical Arrangement in Monroe Room: looks A-OK.

Dinner Menu: On the draft menu, ^{(b)(6)} (kitchen would know, as they have all his diet information). Just to give him a bit more to eat, could we change out the dessert and serve what we had for dessert at the July 17 Madison Dinner (chocolate pudding cake). This dessert is a nod to the Madison-era of pudding desserts. (Should we note that on the printed program? ie: make up a name, even just "Madison era chocolate pudding cake"?)

Guest Favors: Love the journals. Would like to provide each guest with a journal and pen.

Guest List: ^{(b)(6)} Mike asked if LT Tosi and Alessandra are unable to attend the July 26 dinner?

September Madison Dinners

Tabs for both of our September Madison Dinners are missing guest list names and attendance confirmations that I have already provided. Separately, I will forward the email that I sent on July 12 at 5:13pm with guests lists and confirmed responses for both dinners. Please get these updated ASAP, so you can get the invites out. Baiers and Ghoorahs are confirmed for September 13. Need to get the invitation extended to Nadellas ASAP.

Overall Comments

<u>Communication</u>. I am genuinely confused and need your counsel on improving our communications in writing, meetings and conversations. I know everyone is moving fast and working hard, but we were stunned to have our first little dinner group gathering in the Jefferson Room, not the Monroe Room for the reception.

I articulated the Monroe Room reception location anytime I wrote about this Dinner Series (see my original "Event Concept Outline for the SoS Madison Dinner Series" that read "All guests to be brought up^{[D)(7)(E)} enabling us to walk them thru multiple (beautiful) rooms en route to the Monroe Room..." and delineation of the Monroe Room as the reception room in other parts of the outline; see also my email sent to entire planning team on July 6 at 2:11pm that read "I will talk about one artifact—as a good way to quiet the group and ask them to move from the Monroe Room to the Madison Room for dinner.") and on the "Run of Show" provided to me the afternoon of the July 17 Dinner, it repeatedly noted the Monroe Room as the location for our reception. For my planning participation-- whether in our meetings or in writing—we never spoke about any other reception site than the Monroe Room.

There are other pieces of dinner business that have been communicated in writing that we have to reiterate. So, if there is just too much being put in writing—please tell me how to handle the information flow in an efficient manner that gets the job done. These errors are not life ending, but I know the standards that you have—that we share—so, please don't be shy to tell me your team's preferred comms method.

<u>Dinner Walk Thru.</u> I would like to do this. Mike and I both dislike his schedule showing us walking out of his office to the dinner at 6pm (the start time of the reception that we are hosting)—as it did on the day of the last dinner; insuring that . While Mike's schedule may not allow for him to take a "sneak peek," surely I can hop up before guests begin arriving? ^{[b)(6)} will you please coordinate this with Sean/staff for 7/26?

Dozens of GOP donors invited to Pompeo's taxpayer-funded 'Madison Dinners'

Of 360 invitees, at least 150 were from groups that are overtly conservative, formally affiliated with the Republican Party or from right-wing media.

WASHINGTON â€" The invitation list for Secretary of State Mike Pompeo's <u>taxpayer-funded "Madison</u> <u>Dinners,"</u> now under scrutiny by two congressional committees, included dozens of donors to Republican candidates and causes, campaign finance records show.

In May, NBC News <u>revealed that Pompeo</u> had held some two dozen of the dinners at the State Department â€" lavish private affairs that official invitations described as a chance to gather "thinkers and leaders to share ideas on the future of America and the world."

Now, an analysis of Federal Election Commission data and internal State Department documents shows that out of a total of 360 people sent invitations, at least 150 were from groups that are overtly conservative, formally affiliated with the Republican Party or right-wing media outlets. Most of the others were from the private sector, with a smaller number from the diplomatic world.

Pompeo's Madison Dinners are among the topics multiple congressional committees are investigating as they interview fired State Department Inspector General Steve Linick on Wednesday. NBC News has previously reported that Linick, shortly before Pompeo had him fired, was looking into the State Department's Office of the Chief of Protocol, which planned and executed the Madison Dinners. The heavy concentration of Republican donors and power brokers who were invited or attended marks a significant departure from the practice of past secretaries of state.

Former officials from administrations of both parties said Pompeo's predecessors, when they entertained on the government's dime, were careful to ensure that the events were bipartisan, focused on a specific issue or theme and coordinated closely with other parts of the State Department whose work could be affected. None of those things happened with the Madison Dinners, current State Department officials said.

Cross-referencing that list against federal campaign data revealed that 33 invitees have donated more than \$10,000 apiece to Republican candidates and causes and that 17 have donated more than \$50,000

apiece. Eleven donated to Pompeo's campaigns when he served as a member of Congress from Kansas, including Adam Beren, chairman and president of Kansas-based Berexco, who contributed money to Pompeo, as well as more than \$225,000 to President Donald Trump's campaign committees. Every member of Congress invited to one of the dinners over a year and a half is a Republican, according to a master guest list obtained by NBC News.

There also were invitees from right-leaning advocacy groups such as the American Conservative Union and the Taxpayers Protection Alliance, as well as conservative luminaries such as Oliver North and Karl Rove. Ten Republican members of the House and the Senate were invited, as was Robert Kraft, the billionaire owner of the New England Patriots.

In some cases, Pompeo's ambitions to convene a star-studded event seemed larger than what he was able to pull off.

Champion golfer Jordan Spieth, Hall of Fame golfer Phil Mickelson, Duke University men's basketball coach Mike Krzyzewski and former player and NFL coach Tony Dungy all were invited but declined to attend. After six emails and two phone calls, Clint Eastwood's staff ultimately told the State Department that the Hollywood titan was tied up on a film shoot, according to State Department documents. Invitations to the media skewed heavily to the right, with more than 15 invitations going to journalists from conservative-leaning media outlets such as Fox News' Laura Ingraham and Brian Kilmeade. Other media attendees included CBS News' Norah O'Donnell, CNN's Jamie Gangel and CNBC's Joe Kernen, the documents show.

The three Supreme Court justices who got invitations â€" Neil Gorsuch, Brett Kavanaugh and Samuel Alito â€" were nominated by Trump or a previous Republican president, George W. Bush. Only Alito was listed as attending, according to the documents.

Now, Democrats in Congress are raising questions about the rationale for the dinners, <u>demanding</u> that the administration produce extensive documents and communications about the events.MAY 20, 202002:44

The State Department has defended the dinners as entirely appropriate and in keeping with American diplomatic tradition. Spokeswoman Morgan Ortagus said Pompeo "has benefited greatly from these gatherings as he has gained knowledge listening to his guests from all across the political spectrum and all around the world."

In a separate statement, a State Department spokesperson said: "NBC News has found that more than half of the dinner guests were not affiliated with the Republican Party thus confirming the bipartisan nature of these dinners. The Madison Dinners will continue to bring foreign diplomats together with American political, business, and media leaders to help advance U.S. national security interests and diplomacy."

Under previous secretaries of state, in advance of a dinner, relevant officials inside the department were consulted and weighed in with briefing papers depending on the agenda or which foreign diplomats were attending, former officials said.

But that has not been the case with Pompeo's dinners, with regional bureaus and in-house experts not informed or sought out beforehand, current State Department officials told NBC News.

Secretaries of state have tended to steer clear of domestic politics, and federal law prohibits them from engaging in campaigning while in office. Inviting lawmakers from only one party to State Department functions and hosting partisan activists from mostly only one side of the spectrum pose a risk to that tradition, former officials said.

"I think most secretaries are very careful to avoid partisan political activities, to make sure that they aren't involved in domestic politics," a former senior official familiar with how past dinners were organized said. "They understood politics as a fact of life, but they always thought that the national security was not to be mixed in with politics at the State Department."

The test for any State Department event held at taxpayers' expense is whether it bolsters U.S. foreign policy. "If the motive is to advance U.S. national interests, it's OK. If the motive is to advance personal interest, it's not OK," the former official said.

Pompeo is seen in Republican circles as a potential presidential candidate in 2024. To his critics, the taxpayer-funded dinners give Pompeo access to influential and wealthy figures in the political and corporate realms who would be useful for any future run for office. To others, the dinners are merely standard Washington fare.

David Ignatius, a Washington Post columnist and MSNBC contributor who attended one of the dinners, defended the events in a column. Ignatius noted he has harshly criticized Pompeo over his handling of the Ukraine-related impeachment inquiry and other issues, but he said the dinner he attended was a constructive, harmless gathering.

"Our democracy faces some severe threats under President Trump. But social events at the State Department with the secretary and his wife are not among them," he wrote.

The Kansas City Star disagreed, writing in an editorial that "Mike Pompeo's gaudy, taxpayer-funded dinners should make him damaged goods in Kansas." The Leavenworth, Kansas, Times called it "not a good look."

The dinners are named after James Madison, America's fourth president and fifth secretary of state, and are held in an opulent reception room named after Madison and decorated to evoke early 19th-century America.

In a letter to Pompeo in late May, the chairs of the House Oversight and Reform Committee and the House Foreign Affairs Committee raised questions about the use of the Diplomatic Reception Rooms for the dinners. Under federal regulations, the rooms are not to be used for events "that have a partisan, political, sectarian, or similar nature" or "a personal nature, such as private parties or other social events which are not affiliated with, or in support of, official U.S. Government business," the lawmakers wrote. 'Regretted due to filming'

For the dinners, Pompeo and his wife, Susan, sought out a Who's Who of the top corporate leaders in America, including the CEOs of IBM, JetBlue, oil giant ConocoPhillips and Google subsidiary Jigsaw, who were all invited, according to State Department records.

The CEOs of Walmart, consulting firm Booz Allen Hamilton and Snap Inc., which owns Snapchat, all were invited to one or more dinners but ultimately did not attend, people familiar with their invitations confirmed.

At least 15 of the people who were invited lead companies that have received government contracts over the past three years. The companies included heavyweights such as General Electric, General Dynamics, Raytheon and Lockheed Martin. Raytheon, in particular, has benefited from Trump's push for arms sales to Saudi Arabia.

Dinner invitations also went to several high-profile guests from the worlds of sports and entertainment, including Eastwood, who is listed in the State Department document as having "regretted due to filming."

Top-ranked U.S. tennis star John Isner said he was unable to attend because of a busy calendar. "I declined because of scheduling and was honored by the invite and hope to be invited again. I am a big fan of the Secretary of State and think he is doing an amazing job," an emailed statement provided by Isner's representative said.

Some guests from the business community described the dinners as opportunities to participate in "commercial diplomacy." CIA Director Gina Haspel said through a spokesperson that the event she attended was "an excellent opportunity to hear perspectives from a diverse group of people on current foreign policy."

Some prominent Republicans were not invited, however. Senate Majority Leader Mitch McConnell, R-

Ky., and his wife, Transportation Secretary Elaine Chao, did not make the cut, nor did the Republican chair of the Senate Foreign Relations Committee, James Risch of Idaho. Also missing were any other members of the Senate Republican leadership.

Before Democrats in Congress started asking questions about the Madison Dinners, Pompeo's use of taxpayer-funded resources was the subject of an inquiry by Linick, the inspector general, whom Trump fired in May. Among other things, Linick was looking into allegations that the secretary enlisted a political appointee to carry out personal errands for him, like picking up dry cleaning, NBC News previously <u>reported</u>. Linick is voluntarily submitting to a private virtual interview Wednesday with Democratic and Republican members of the House Foreign Affairs Committee, the House Oversight Committee and the Senate Foreign Relations Committee, all of which are investigating Linick's firing. Pompeo has denied any wrongdoing or that he pushed for Linick's sacking as retaliation for any pending investigations.

Former intelligence officials say similar questions were raised during his tenure as CIA director, including whether he used government facilities for purely recreational purposes.

Two current and two former U.S. officials said Pompeo, who led the CIA from January 2017 to April 2018, would occasionally invite friends to weekend gatherings at Scattergood-Thorne House, a fourstory Georgian Revival home on the agency's Langley, Virginia, campus that is used as a conference center.

The receptions, which included Sunday gatherings to watch NFL football, required government employees to open and staff the property, the officials said.

One current and one former official said Pompeo wanted a big-screen television installed at Scattergood-Thorne so he and his friends could better enjoy the games. CIA officials expressed concerns that it was inappropriate and should not be paid for with agency funds, the officials said.

But a source close to Pompeo denied that account, saying: "That is false.�

The current and the former officials said Pompeo also made a number of weekend visits with his wife to the agency's training facility at Camp Peary, Virginia, known as the Farm. The training campus is on the York River next to Colonial Williamsburg.

"It wasn't anything that broke the law, but it raised eyebrows," a U.S. official said.

In response to inquiries from The Washington Post, the CIA acknowledged in 2018 that Pompeo stayed with his wife and adult son at the Farm during Christmas 2017.

A former U.S. intelligence official familiar with the matter said that during the visit, Pompeo's son participated in skeet shooting with agency personnel.

The CIA said the Pompeos "stayed at an Agency-owned facility for three days over Christmas 2017." But the agency said they opted to do so instead of traveling out of state and incurring additional costs to protect the family.

In a statement to NBC News, CIA press secretary Timothy Barrett said, "During his time here, former Director Pompeo unapologetically advanced the Agency's mission while making it a top priority to engage CIA Officers to express his deep appreciation and respect for their work."

"As director of the CIA, the Secretary spent time at the facility over Christmas in an effort to allow staff to spend time with their families,� said the source close to Pompeo.

Unlike his predecessors at Foggy Bottom, Pompeo lives in government housing $\hat{a} \in "$ a stately home usually reserved for flag officers in the military. Pompeo pays an undisclosed amount to rent the property, and when the arrangement was made in 2018, officials said it would save taxpayers money by reducing significant security costs associated with a private residence. The State Department has said Pompeo pays fair market value to rent the home.

Pompeo's â€~Madison Dinners' aren't scandalous. I went to one.

When assessing the Trump administration, letâ€[™]s make sure that our outrage meters are wellcalibrated, so that we donâ€[™]t waste time on trivial topics. A case in point is the recent uproar over the "<u>Madison Dinners</u>� held by Secretary of State Mike Pompeo and his wife, Susan.

I have an unusual personal perspective on this latest "scandal,� because my wife and I were among the guests at a dinner hosted by the Pompeos on Nov. 18.

Critics have argued that the secretary was misusing public funds at this dinner and a handful of others, but it didnâ€[™]t feel that way sitting in the room. It seemed like the many other times lâ€[™]ve been with previous secretaries at events like these. The only surprising thing was that I was invited, given what I had written about Pompeo. But lâ€[™]II get to that later.

There were about 20 guests, as I remember, mostly couples. We had cocktails in the lavish, main Diplomatic Reception Room where the State Department holds big events and then retreated to a smaller room, known as the <u>James Madison Dining Room</u>.

This was supposed to be a social event, as opposed to a business dinner. But in Washington, let's be honest, it's all business, all the time. The other guests included an ambassador and his wife, a senator, a member of the House, a former baseball commissioner and his wife, and several prominent businesspeople.

Similar events take place nearly every night in some embassy or think tank, when the city isnâ€[™]t shut down by a pandemic. The idea is that people will do their jobs better if they know each other, have a drink, socialize. I think thatâ€[™]s probably true, including for journalists. One reason Washington is such a nasty, partisan place these days is that people donâ€[™]t see each other outside work.

On the way to dinner, Susan Pompeo gathered the guests for a talk about some of the heirlooms â€" the fine china and porcelain that have been assembled over the years, thanks to private donations that began during the Kennedy administration. She spoke without notes and with detailed knowledge of the items in the collection. Sheâ€[™]s an active, engaged spouse now, as she was when Pompeo headed the CIA. That strikes me as a positive, not a negative.

Each guest was asked to say a few words. I said something about how, in covering the State Department since the 1980s, lâ€[™]d learned that U.S. foreign policy is more powerful when it has bipartisan support, and when the news media are able to cover it freely. Bland, maybe, but thatâ€[™]s what I think.

The secretary nodded; so did others around the table. On to the next set of bromides. Some of the comments had a political edge, but for Trump-era Washington, it was mostly pretty tame stuff. It was genial, but it felt like work: People were trying â€" hard â€" to be friendly and get to know each other.

The only surprise about the dinner for me was that I was there at all. My wife and I had received our invitations in October. Two weeks before the event, on Nov. 5, I had published a column with the headline: "Where is Mike Pompeo? He's hiding in fear of Donald Trump.� The Ukraine investigation was unfolding then, and I wrote that while Trump was attacking former ambassador Marie

Yovanovitch, Pompeo "has essentially been in hiding, protecting himself while his subordinates took the hit.�

I didn't mince words: "Pompeo has badly tarnished his reputation in accommodating Trump. He joins the long list of those damaged by their service to this president.�

After that column appeared, I called one of Pompeoâ€[™]s top aides and said that if he preferred to withdraw his dinner invitation, I would understand: Nobody should have to socialize with someone if itâ€[™]s going to be uncomfortable. But the aide, after consultation, said no problem, come ahead. Pompeo and his wife were gracious throughout the evening.

lâ€[™]ve criticized Pompeo since that dinner, <u>noting</u>, for example, "he has a belligerent streak that even his supporters have long recognized is a severe liability.� lâ€[™]ve also endorsed policies of his that I thought were sensible. Thatâ€[™]s the way itâ€[™]s supposed to work. We tell the truth, upside and down. This is journalism, not war.

To be clear: Our democracy faces some severe threats under President Trump. But social events at the State Department with the secretary and his wife are not among them.
