Yes. The \$3 million is the amount we received from the administration that we communicated to legislative leadership to include in HB19.

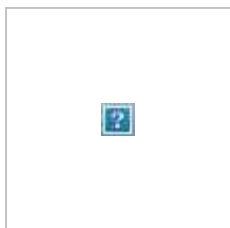
