## **<u>Re: Public Information Act Request</u>**

Dear FOIA Officer:

Citizens for Responsibility and Ethics in Washington ("CREW") submits this request for records from the Office of the Governor pursuant to the Texas Public Information Act, Texas Government Code Chapter 552.

Specifically, CREW requests:

- 1. All communications between the Office of Governor Greg Abbott and the Office of Florida Governor Ron DeSantis relating to Gov. DeSantis' February 1, 2024 interstate deployment of Florida National Guard and Florida State Guard troops to the southern U.S. border between Texas and Mexico ("the Deployment").
- 2. All communications between the Office of Gov. Abbott and the Texas National Guard relating to the Deployment.
- 3. All communications between the Office of Gov. Abbott and the Florida National Guard relating to the Deployment.
- 4. All communications between the Office of Gov. Abbott and the Florida State Guard relating to the Deployment.
- 5. Records sufficient to identify the total cost of the Deployment.
- 6. Records sufficient to identify the source(s) of all money used to fund the Deployment
- 7. All records reflecting any complaint, inquiry, analysis, consideration, or determination by the Office of Gov. Abbott, DOD, the Texas National Guard, or any other federal or state entity regarding any legal restrictions applicable to the Deployment.
- 8. All records reflecting the parameters of the Deployment, including any instructions or other communications to Texas National Guard members

about the nature of the Deployment, whether participation is mandatory or voluntary, and the source of funding for the Deployment.

The above request <u>excludes</u> agency records consisting <u>solely</u> of news articles, press clippings, and other publicly-available material, so long as the records include no accompanying discussion by agency officials.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to emails and other records, and anyone who was cc'ed or bcc'ed on any emails.

If it is your position any portion of the requested records is exempt from disclosure, CREW requests that you provide it with an index of those documents as required under *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973). If some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. *See* 5 U.S.C. § 552(b). If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. *See Mead Data Central v. U.S. Dep't of the Air Force*, 566 F.2d 242, 261 (D.C. Cir. 1977).

Please be advised that CREW intends to pursue all legal remedies to enforce its rights under FOIA. Accordingly, because litigation is reasonably foreseeable, the agency should institute an agencywide preservation hold on all documents potentially responsive to this request.

## Fee Waiver Request

CREW requests a waiver of fees associated with processing this request for records. Disclosure of the requested records is in the public interest because it will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Furthermore, the request is primarily and fundamentally for non-commercial purposes.

By way of Background, on February 1, 2024, Florida Governor Ron DeSantis announced he would deploy members of the Florida National Guard and Florida State Guard to Texas to help the state "in its efforts to stop the invasion at the southern border" with Mexico.<sup>1</sup> In a press release DeSantis said that 1,000 soldiers would be deployed to help install razor wire along the border.<sup>2</sup> DeSantis is one of many Republican Governors who announced their support of Governor Abbott after he flouted a Supreme Court decision ruling against

the use of razor wire barriers on the border.<sup>3</sup> The requested records will show the reasoning behind DeSantis' decision and the costs associated with the deployment, both of which are matters of substantial public interest.

The requested documents may also indicate if private companies are benefiting from the Child Identification Program. Obtaining this information will address government ethics concerns by revealing if the program creates any potential conflicts of interest for government officials.

The request is not in CREW's financial interest.

CREW routinely and systematically disseminates information to the public in several ways. CREW's website receives tens of thousands of page views every month. The website includes investigations that report on and analyze newsworthy developments regarding government ethics, corruption, and money in politics, as well as numerous reports CREW has published to educate the public about these issues. In addition, CREW posts the documents it receives through public records requests on its website.

Under these circumstances, CREW satisfies fully the criteria for a fee waiver.
