Dear Requester:

This is the twenty-fifth interim response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on January 21, 2021, for information pertaining to:

1. All records from December 1, 2020 to January 6, 2021 reflecting any plans for demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021 that were identified by any DHS component—including without limitation the Office of Intelligence & Analysis (“I&A”) and the Federal Protective Service (“FPS”)—or other agencies through social media monitoring, threat assessments, or other means.
2. All records from December 1, 2020 to January 6, 2021 reflecting any tips, complaints, referrals, allegations, or reports submitted to any DHS component—including without limitation I&A and FPS—regarding planned demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021.
3. All records from December 1, 2020 to January 6, 2021 reflecting DHS’s communication to other agencies—including without limitation the U.S. Capitol Police, the D.C. Metropolitan Police Department, the Federal Bureau of Investigation, the Department of Justice, or the Department of Defense—of the risks or threats posed by planned demonstrations, gatherings, disruptions, attacks, or riots in Washington, D.C. on January 6, 2021.
4. All records from December 1, 2020 to January 6, 2021 relating to any DHS component—including without limitation I&A and FPS—providing assistance or support to the U.S. Capitol Police, the D.C. Metropolitan Police Department, or any other agency in connection with the January 6, 2021 congressional session to count electoral votes.

After a detailed review of all potentially responsive records, 139 page(s) were released in part and or in full. Exemptions under the FOIA Statute, Title 5 U.S.C. § 552, and/or the PA Statute, Title 5 U.S.C. § 552a, have been applied where deemed appropriate after considering the foreseeable harm standard outlined in the 2016 amendment to 5 U.S.C. § 552 (a)(8)(A)(i) and DOJ guidance.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.

FREEDOM OF INFORMATION ACT
SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

Provisions of the Freedom of Information Act do not apply to matters that are:

- (b) (1) (A) specifically authorized under criteria established by an Executive Order to be kept Secret in the interest of national defense or foreign policy; and (B) are in fact properly classified pursuant to such Executive Order;
- (b) (2) related solely to the internal personnel rules and practices of any agency;

- (b) (8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for regulation or supervision of financial institutions; and
- (b) (9) geological and geophysical information and data, including maps, concerning wells.

- (k) (6) testing or examination material used solely to determine individual qualifications for appointment or promotion in the Federal service-the disclosure of which would compromise the objectivity or fairness of the testing or examination process.

Protective Intelligence Brief

March for Trump

Background

Since the 2020 election, demonstrations have been organized nationwide advocating for President Trump and speaking out against the election results. In November 2020, a pro-Trump gathering in Washington, DC, resulted in an estimated **11,000** participants at Freedom Plaza, who marched to the Capitol and Supreme Court, and in December 2020, another pro-Trump gathering in Washington, DC, resulted in approximately **3,000** participants. The Pro-Trump protesters split between Freedom Plaza, the National Mall, the Capitol and the Supreme Court, with some individuals marching from one place to another, while others protested in one spot. The November and December demonstrations resulted in verbal and physical altercations between pro and anti-Trump demonstration groups, as well as numerous arrests. During the November 14, 2020, demonstration the Metropolitan Police Department (MPD) reported 21 arrests for assault, assault on a Police officer, possession of a weapon, disorderly conduct, and inciting violence. There were also seven firearms recovered by MPD during this event. The December 12, 2020, demonstration resulted in 33 arrests for assault on a police officer, simple assault, riotous acts, possession of a prohibited weapon (taser) and crossing a police line. MPD also reported during this event there were four people stabbed during an altercation, which included one MPD officer. All of the victims received non-life-threatening injuries and were treated and released.

Individuals continue to speak out against the 2020 presidential election results, and pro-Trump supporters have begun to organize another large-scale demonstration to occur on January 6, 2021. This is the day Congress is scheduled to certify the Electoral College vote for President-elect Joe Biden. As momentum for the demonstrations increased, President Trump tweeted to encourage his supporters to come to DC and protest, writing, "Be there, will be wild!" Individuals chose this tagline for the upcoming protest, naming it the "Wild Protest." The hashtag #WildProtest has been widely used to discuss and promote the event. President

Trump tweeted again on December 27, 2020, promoting the protest. As of December 30, 2020, social media indicated **4,280** participants plan to attend, and an additional **12,621** are interested.

Organizers

Stop The Steal (NRID), *Million MAGA March (NRID)*, *Women for America First (NRID)*, *March for Trump (NRID)*, *Proud Boys (RID)*, and other pro-Trump groups, along with private citizens, have promoted event pages for the event.

Stop The Steal is a loosely organized group which emerged on November 7, 2020, with the belief the election is being stolen from President Trump due to election fraud. The group began organizing demonstrations nationwide called "Stop The Steal." According to the website, invited speakers and featured guests for the January 6, 2021 event include Rep. Paul Gosar, Ali Alexander, Roger Stone, Rep-Elect Marjorie Greene, Rep. Lance Gooden, Rep-Elect Lauren Boebert, State Rep. Vernon Jones, State Rep. Mark Finchem, State Sen. Doug Mastriano, State Rep. Anthony Kern, and several others. One spokesperson from Stop The Steal, Ali Alexander (NRID), has encouraged followers to bring tents, sleeping bags, food, and water. Alexander claimed, "if DC escalates...so do we. Do not wear a mask. Stand with others bullied by staff." Twitter removed this tweet as it violated the spread of COVID-19 harmful information.

The Million MAGA March has been involved in organizing both large protests in November and December. The website was created early November prior to the first Million MAGA March, which spurred several social media groups and pages supporting this movement.

Women for America First is a pro-Trump, female led group. The group was the center of organization for both the November and December protests. The group plans to host a "March for Trump" bus tour from California to Washington, DC, arriving on the January 6, 2021.

Although March for Trump is listed as a group, several different smaller factions are listed under this name. The group name is considered more of a movement than an organization.

Proud Boys is a right-wing group founded in 2016 by Gavin McInnes as a "pro-Western fraternal organization." They are of record with USSS for demonstration activity since 2017; no civil disobedience or arrests have been recorded. Hotel Harrington, an alleged hangout/hotel for the Proud Boys, made a statement on December 28, 2020, announcing their closure from January 4-6, 2021, for "safety of visitors and employees." According to news media, four individuals were stabbed outside the hotel during the protests on December 12, 2020, when Proud Boys members clashed with counter protesters. Proud Boys' self-proclaimed chairman, Enrique Tarrio (NRID), made a statement on Parler regarding the closing of Hotel Harrington, claiming the Proud Boys outgrew the hotel and are planning on protesting during the January 4-6, 2021, time frame and will be staying at various other locations.

Call to Protest

On January 6, 2021, a consortium of private citizens and pro-Trump groups reportedly will host the Wild Protest in Washington, DC. The groups intend to demonstrate in support of President Trump and speak

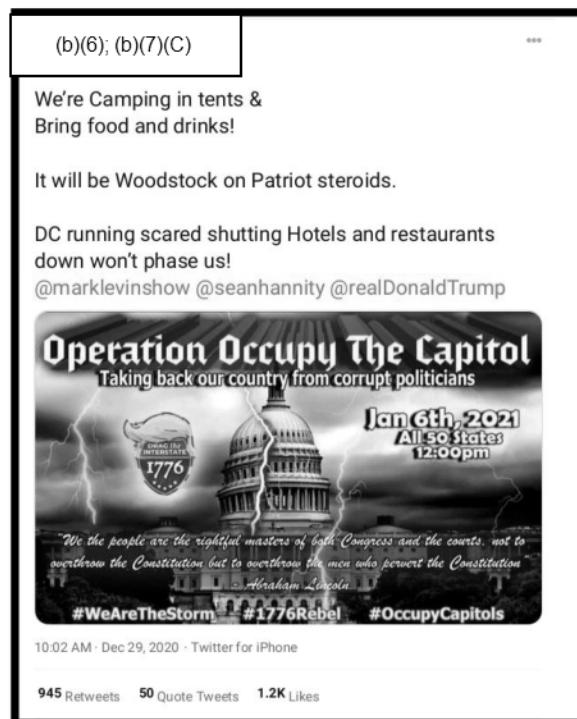

out against the 2020 election results. Numerous groups have claimed to be protesting at the US Capitol, with other groups protesting at the White House.

The hashtags #WeAreTheStorm, #1776Rebel, and #OccupyCapitols have gained attention as the protest on January 6, 2021 approaches. Commenters argue that other individuals were able to occupy other areas, including Black Lives Matter Plaza and the Capitol Hill Organized Protest/Capitol Hill Autonomous Zone, during separate protests, so President Trump supporters have proposed a movement to occupy Capitol Hill. This movement is supported by Ali Alexander's video requesting individuals to bringing tents, food, sleeping bags, and water (which has received over 300 comments and 2.5K retweets). Individuals who cannot come to Washington, DC, are encouraged to occupy their local capitols.

A website was located for chats and events related to the January 6th, 2021 DC Protest, titled *Maga Drag the Interstate*. Through this site, users are able to submit/create event caravan pages. All events are currently in reference to car and motorcycle caravans. There are currently 511 members for the "Jan 6 DC Caravan Planning" group with 47 events starting from all over the United States and reportedly ending in Washington, DC.



From January 5, 2021, at 6:00 AM, to January 7, 2021, at 4:30 PM, the individual (b)(6); (b)(7)(C)) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 7 people are going, and 25 are interested.

From January 5, 2021, at 10:00 AM, to January 6, 2021, at 08:00 PM, the individual (b)(6); (b)(7)(C)) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC, from Florida, and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 5 people are going, and 5 are interested.

On January 5, 2021, at 10:00 AM to January 7, 2021 at 2:00 AM, the group *The First Heavy Metal Church of Christ* (NRID) will host an event called, "Patriots Part 2020 in D.C." in Washington, DC. The group plans to caravan to DC, stay at the Grand Hyatt, and protest all day. The purpose of the event is to show support for the nation. There is no indication of civil disobedience. According to Facebook, 6 people are going, and 39 are interested.

On January 5, 2021, at 10:00 PM, the individual (b)(6); (b)(7)(C)) (NRID) and the group *New Jersey Patriot Events* (NRID) will host a demonstration called "Washington DC 5th - 6th Trip" at the National Mall. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 89 people are going, and 250 are interested.

On January 6, 2021, at an unknown time, the *Proud Boys (RID)* will host an unnamed demonstration in Washington, DC. The purpose of this demonstration is to join the other pro-Trump demonstrations. There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire, and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers."

On January 6, 2021, at 1:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "We the people need transparency!" at the US Capitol. The purpose of the event is to "show up outside the senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 1 person is going, and 6 are interested.

On January 6, 2021, from 1:00 AM to 12:55 AM, the individual (b)(6); (b)(7)(C) (NRID) and group *Patriot Party of America (The Peoples Party) (NRID)* will host a demonstration called "Million MAGA Strong" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 people are going, and 14 are interested.

On January 6, 2021, from 4:00 AM to 11:45 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "CANTON/AKRON ELECTION PROTEST BUS TRANSPORTATION (SOLD OUT)" at the US Capitol. The group plans on leaving Canton, OH, and demonstrating in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 59 people are going, and 182 are interested.

On January 6, 2021, at 5:30 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Jan 6th DC MAGA/KAG March-leaving from Fayetteville, NC" at the US Capitol. The group plans on arriving in Washington, DC, at 10 AM. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 15 people are going, and 32 are interested.

On January 6, 2021, at 6:00 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "#StopTheSteal Rally for America -Bus trip" in Washington, DC. The purpose of the demonstration is to petition Congress to follow the constitution and the will of the people. There is no indication of civil disobedience. According to Facebook, 21 people are going, and 30 are interested.

On January 6, 2021, from 6:00 AM to 11:00 PM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Fight for Trump van from Winston Salem NC to DC" in Washington, DC. The purpose of the demonstration is to march for President Trump. There is no indication of civil disobedience. According to Facebook, 28 people are going, and 91 are interested.

On January 6, 2021, at 7:00 AM, the group *American Conservatism (NRID)* will host a demonstration at the US Capitol called "March on Congress." The purpose of this demonstration is to speak out against election fraud and in support of President Trump. There was no indication of civil disobedience. Facebook currently indicates 799 people are going and 4.5K are interested.

On January 6, 2021, at 7:00 AM, the group *The Republican Mandate (NRID)* will host a demonstration called "Wild Protest for Donald Trump" in Washington, DC. The purpose of the event is to demand the politicians to confirm Donald Trump as President. There is no indication of civil disobedience. According to Facebook, 76 people are going, and 116 are interested.

On January 6, 2021, at 07:00 AM, the group *RI Warriors for Trump (NRID)* will host a demonstration called "TRUMP RALLY DC" in Washington DC. The specific location has not been released. The purpose of the event is to "demand transparency and protect election integrity." There is no indication of civil disobedience. Post permissions for the group's discussion section have been turned off, hiding any discussions regarding the event from the public. According to Facebook, 10 people are going, and 17 are interested.

On January 6, 2021, at 7:00 PM, the group *New Jersey Patriots Event Page (NRID)* and the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Million MAGA March, March for Trump, StopTheSteal." The purpose of the demonstration is "President Trump has called for all of his supporters to be in Washington, D.C. January 6th – This will be the biggest protest in American History. The time to take a stand is now!" There is no indication of civil disobedience. According to Facebook, 660 people are going, and 1.9K are interested.

On January 6, 2021, from 7:00 AM to 10:00 AM, the group *Trumpaign (NRID)* will host a demonstration called "March on Congress" at the US Capitol. The purpose of the event is to demand the politicians to confirm Donald Trump as President. There is no indication of civil disobedience. According to Facebook, 28 people are going, and 65 are interested.

On January 6, 2021, from 07:00 AM to 09:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Support Trump MAGA..." in Washington DC. The specific location has not been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. Post permissions for the group's discussion section have been turned off, hiding any discussions regarding the event from the public. According to Facebook, 1 person is going and 1 is interested.

On January 6, 2021, from 7:00 AM to 11:55 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *Focus on Forsyth Country GA (NRID)* will host a demonstration called "MARCH FOR TRUMP" in Washington, DC. The purpose of the demonstration is to march for President Trump. There is no indication of civil disobedience. According to Facebook, 4 people are going, and 24 are interested.

On January 6, 2021, at 8:00 AM, the individuals (b)(6); (b)(7)(C) (NRID), (b)(6); (b)(7)(C) (NRID), and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "March to D.C., Be There, Will Be Wild" at the US Capitol. The purpose of the demonstration is to march for President Trump. There is no indication of civil disobedience. According to Facebook, 57 people are going, and 163 are interested.

On January 6, 2021, at 8:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Southern MD Stop the Steal MAGA March" at the National Mall. The purpose of this event is to support President Trump and not allow the liberals to steal the election. There is no indication of civil disobedience. According to Facebook, 29 people are going, and 43 are interested.

On January 6, 2021, at 8:00 AM, the individuals (b)(6); (b)(7)(C) (NRID), (b)(6); (b)(7)(C) (NRID), and *We heart DJT* (NRID) will host an event called "March For Trump" at Freedom Plaza. The purpose of the event is to stop the steal and march for President Trump. There is no indication of civil disobedience. According to Facebook, 14 people are going, and 30 are interested.

On January 6, 2021, from 8:00 AM to 11:55 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Trumps MAGA rally stop the steal" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 70 people are going, and 131 are interested.

On January 6, 2021, from 9:00 AM to 3:30 PM, the group *Frederick County Conservative Club* (NRID) will host a demonstration in Washington, DC, called "Million MAGA March." The purpose of this demonstration is to show support for President Trump. The group plans on arriving at Freedom Plaza from Frederick, MD, at 9:00 AM, and departing DC at 3:30 PM. There is no indication of civil disobedience. According to Facebook, 68 people are going, and 168 are interested.

On January 6, 2021, at 9:00 AM, the group *ACActual Reality Report* (NRID) will host a demonstration called "Fight for Trump Washington, D.C." The purpose of the demonstration is "President Trump invites you to Washington DC for a Wild Time (aka) Fight for your country." There is no indication of civil disobedience. According to Facebook, 28 people are going, and 45 are interested.

On January 6, 2021, at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) and group *TheSilent No MORE* (NRID) will host a demonstration called "FIGHT FOR PRESIDENT TRUMP & YOUR RIGHTS" in Washington, DC. The purpose of the demonstration is to support President Trump and let others know the people will not tolerate a fraudulent election. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 2 are interested.

On January 6, 2021, from 9:00 AM to 06:00 PM, the group *Prime Time Patriots* (NRID) will host a demonstration called "MARCH FOR TRUMP" in 213 Pennsylvania Ave SE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 67 people are going, and 367 are interested.

On January 6, 2021, at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Stand For Trump January 6th" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 4 people are going, and 7 are interested.

On January 6, 2021, at 9:00 AM, the group *We Are Washington Page* (NRID) will host a demonstration called "WA Patriots going to DC for the Million MAGA March on Jan 6th!" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 31 people are going, and 56 are interested.

On January 6, 2021, from 9:00 AM to 7:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Calling all Patriots! We have been called to DC to the Nation's Capital for a Peaceful protest to save #America #StopTheSteal" in Washington, DC. The purpose of the

demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 41 people are going, and 73 are interested.

From January 6, 2021, at 9:00 AM to January 7, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Patriot Protest March" in Washington, DC. The purpose of the event is to "protest the election fraud, tyranny and corrupt politicians." There is no indication of civil disobedience. According to Facebook, 5 people are going, and 11 are interested.

The purpose of the event is to "protest against corruption, demanding transparent elections where our leaders are elected, not selected." There is no indication of civil disobedience. According to Facebook, 5 people are going, and 17 are interested.

On January 6, 2021, at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Patriot Gathering" in Washington, DC. The purpose of the event is to "join together on this day. In support of our election." There is no indication of civil disobedience. According to Facebook, 1 person is going, and 1 is interested.

On January 6, 2021, at 9:00 AM, private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the National Mall called "President Trump's Calling on Patriots to Protest in Washington D.C. January 6th @ the National Mall." The purpose of this demonstration is to join the pro-Trump demonstrations as a contingency from Texas. There was no indication of civil disobedience. According to Facebook, 85 people are going, and 86 are interested.

On January 6, 2021, from 10:00 AM to 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Trump Rally Jan 6" in Washington, DC. The purpose of the event is to "come to DC Jan 6 when Congress counts electoral votes and objections are raised." There is no indication of civil disobedience. According to Facebook, 60 people are going, and 108 are interested.

On January 6, 2021, from 10:00 AM to 4:00 PM, the group *Stop the Steal* (NRID) will host a demonstration at the US Capitol called "Wild Protest." The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 8 people are going, and 37 are interested.

On January 6, 2021, at 10:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "COVID+ Freedom March" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 109 people are going, and 198 are interested.

On January 6, 2021, at 11:00 AM, the individuals (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Stop The Steal Jan 6 Capitol Hill" at First St NE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 375 people are going, and 2.7K are interested.

On January 6, 2021, at 11:00 AM, the individual (b)(6); (b)(7)(C) (NRID) and the group *THE BASKET OF DEPLORABLE* (NRID) will host an event called "Jan 6th D.C. Maga March" in Washington, DC. The purpose of the event is to join "the largest Maga March Ever!" There is no indication of civil disobedience. According to Facebook, 10 people are going, and 19 are interested.

On January 6, 2021, at 12:00 PM, the group *Eat Pray Kill* (NRID) will host a demonstration called "Election Fraud and Electoral College Protest" at First St NE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 4 people are going, and 11 are interested.

On January 6, 2021, at 12:00 PM, the group *Fight for Freedom and Trump Rally* (NRID) will host a demonstration called "Fight For Freedom Trump Rally" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 People are going, and 5 are interested.

On January 6, 2021, at 12:00 PM, the group *Washington State March for Trump in DC 01/06/2020* (NRID) will host a demonstration called "MARCH FOR TRUMP" in Washington DC. The specific location has not been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. According to Facebook, there are 0 going, and 1 interested.

On January 6, 2021, at 12:00 PM, the group *Million MAGA March* (NRID) will host a demonstration at the National Mall in Washington, DC, called "Million MAGA March – Round III." The purpose of this demonstration is to show support for President Trump and speak out against the election results. The group is utilizing hashtags #millionmagamarch, #millionmagamarch2021, and #stopthesteal. There was no indication of civil disobedience. Their website currently indicates 1,090 people are going.

On January 6, 2021, at 12:00 PM, the group *Patriot Party* (NRID) and private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the US Capitol called "Patriots United March on Congress." The purpose of the demonstration is to speak out for election integrity while Congress meets to confirm the Electoral College votes. The group indicates plans to meet at the Capitol, but has not indicated potential routes. There is no indication of civil disobedience. According to Facebook, 34 people are going, and 212 are interested.

According to the website, confirmed speakers include Roger Stone, Julio Gonzalez, George Papadopoulos, Mark Burns, Greg Locke, and Bernard Kerik. There is no indication of civil disobedience. According to Facebook, 6 people are going, and 7 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and groups *Virginia Women for Trump (NRID)*, *Keep Georgia Red (NRID)*, *TRUMPS FREEDOM FIGHTERS (NRID)*, *PRESIDENT DONALD TRUMPS SOLID SUPPORT WORLDWIDE (NRID)*, *Women United for Trump (NRID)*, *Trump/Pence Reelection Group (NRID)*, *Trump Daily Report (NRID)*, *TRUMP ~ The Next Four Years (NRID)*, and *GA Women for Trump (NRID)* will host a demonstration called "MARCH FOR TRUMP JANUARY 6TH WASHINGTON DC" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 13 people are going, and 23 are interested.

On January 6, 2021, at 12:00 PM, an unknown group will host a demonstration titled "Operation Occupy The Capitol" in Washington, D.C. The purpose of the event is to "peacefully protest the election fraud." Participants are encouraged to protest at their state capitol if they are unable to travel to Washington D.C. There is no indication of civil disobedience at this time. The Twitter event hashtags are #WeAreTheStorm, #1776Rebel and #OccupyCapitols. Participant numbers are unknown as the event was located through flyer.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Stop the Steal March #BeThere" in Washington, DC. The purpose of the event is to "make politicians listen." There is no indication of civil disobedience. According to Facebook, 192 people are going, and 732 are interested.

On January 6, 2021, at an unknown time, the groups *Women for America First (NRID)* and *March for Trump (NRID)* will host a demonstration in Washington DC called "March for Trump." The purpose of this demonstration is to "demand transparency & protect election integrity." There is no indication of civil disobedience. Current numbers of planned participants are unavailable at this time.

Counter Demonstrations

There are several counter-demonstrations planned for January 6, 2021. OSB has observed less social media activity and chatter for these counter-demonstrations than during previous pro-Trump demonstrations. The themes emerging from social media chatter amongst the counter protestors is similar to the rhetoric espoused during prior protests; the groups are attempting to keep Proud Boys and other Pro-Trump groups out of Washington, DC.

Several local groups have shared the news regarding Hotel Harrington closing from January 4-6, 2021, and have encouraged followers to contact other local hotels to encourage them to shut down as well. Although *ShutDownDC (RID)*, *All Out DC (RID)*, and *Black Lives Matter DC (RID)*, have shared the news regarding Hotel Harrington on social media, they have not publicly announced any details regarding plans to protest.

On January 6, 2021, at an unknown time, the group *Refuse Fascism (RID)* will host a demonstration in Washington, DC, called "Opposing Trump's Moves to Overturn the Election." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, at an unknown time, the groups *They Them Collective (RID)*, *Total Liberation Collective (NRID)*, *DC Protests (NRID)*, *Good TroubleCo.op (NRID)*, *Smash the Fash NOVA (NRID)*, and *DC Youth Liberation Front/DCYLF (RID)* will host a demonstration in Washington, DC, called "Alert: Terrorists in Town Jan 3-6, 17-23." The purpose of this demonstration is to counter demonstrate during the Proud Boys and Stop the Steal demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, from 12:00 PM to 3:00 PM, the group *I Approve This Message (NRID)* will host a demonstration at the US Capitol Building called "Donald, You're Fired! March on DC." The purpose of the demonstration is to "witness this momentous occasion. Upon the declaration of the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There is no indication of civil disobedience. According to Facebook, 7 people are going, and 20 are interested.

On January 6, 2021, at 1:00 PM, the groups *Insurgence USA (NRID)* and *Protest Live (NRID)* will host a demonstration in Washington, DC, called "No Fascist in DC – March Against Fascism." The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There is no indication of civil disobedience. According to Facebook, 7 people are going, and 63 are interested.

Refuse Fascism has demonstrated on numerous occasions at the White House and temporary protected sites. One demonstration in 2017, held near Trump Tower in New York City, ended with arrests for disorderly conduct and failure to obey.

TheyThem Collective is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.

DC Youth Liberation Front is of record with the USSS for a demonstration in August 2020 near Meridian Park. The group utilized sound equipment and MPD made several arrests for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows.

ShutDownDC has demonstrated on numerous occasions in relation to social justice in Washington, DC, as well as outside Acting DHS Secretary Chad Wolf's home. A ShutDownDC demonstration on June 2, 2020, resulted in one arrest for possession of an imitation pistol and a BB gun.

All Out DC is of record with the USSS for numerous demonstrations at the White House. During an All Out DC demonstration in June 2020, protestors were observed using fireworks, obstructing roads, and throwing debris at officers. MPDC used smoke to clear the area and the demonstration concluded with one arrest for threats.

Black Lives Matter has demonstrated on numerous occasions at the White House and temporary protected sites. The group has previously used sound equipment. One demonstration on June 4, 2020,

concluded with one arrest after gas cans and fireworks were observed inside a subject's vehicle. Two arrests were made during a demonstration on June 2, 2020, for possession of an imitation pistol and possession of a BB gun.

Dark Web

No organization efforts for events on January 6, 2021, have been identified on the dark web at this time.

Road Closures

MPDC has not made an official announcement regarding any road closures at this time.

Assessment

Many of the groups planning to engage in demonstration activities on January 6, 2021, are the same which participated in demonstration activities on November 14, 2020, and December 12, 2020. Verbal and physical altercations ensued between pro-Trump and anti-Trump supporters during both events. (b)(7)(E)

U.S. Officials Warn of Potential for Iran-Linked Attack on American Interests in Iraq as Anniversary IRGC General Soleimani's Death Approaches

On December 30, media sources citing defense officials reported that the U.S. military is bracing for a possible attack on American interests in Iraq, days before the first anniversary of the U.S. military unmanned aerial vehicle (UAV) strike that killed Islamic Revolutionary Guard Corps (IRGC) Major General Qassem Soleimani on January 3, 2020. The officials spoke as two B-52 bombers carried out a round-trip, 30-hour mission from North Dakota to the Middle East—a show of force reportedly intended to deter Iran. General Kenneth “Frank” McKenzie, chief of U.S. Central Command said, “We do not seek conflict, but no one should underestimate our ability to defend our forces or to act decisively in response to any attack.” A senior U.S. defense official noted that leaders of Iran-backed militias in Iraq met with Quds Force leaders and that a “fair amount of advanced conventional weaponry” has been transported from Iran to Iraq. He said that “the threat streams are very real,” adding that the situation is “the most concerning” he has seen since Soleimani’s killing. As a precautionary measure, the U.S. has reduced the number of staff at the U.S. Embassy in Baghdad. After militants launched rockets at the compound housing the embassy on December 20, President Trump posted on social media: “If one American is killed, I will hold Iran responsible. Think it over.” ([WASHINGTON POST](#)) *Analyst Comment: Adding to tensions between the U.S. and Iran, on December 30 Iranian President Hassan Rouhani stated in a press conference that it was the right of the Iranian people to avenge the death of Soleimani, placing direct blame on President Trump and Secretary of State Mike Pompeo.*

Security Official of Hizballah Brigades Reportedly Advises Against Targeting U.S. Embassy

A statement issued on December 26 by the security official for Hizballah Brigades, an Iraq-based Shi'a militant group backed by Iran, warned other factions against targeting the U.S. Embassy in Baghdad. The message by Abu Ali al-Askari argued that such strikes end up only benefiting the interests of the Trump Administration and they should avoid “being the party that triggers” a war. Al-Askari reportedly recommended restraint as the best tactic instead. Additionally, al-Askari maintained the Hizballah Brigades’ support for local resistance factions, stating: “Our alliance with the brothers in the resistance factions, whether local or foreign, is a strong alliance; what affects them affects us, and we are committed to defending them within the defined and established framework between us.” In October, militia groups calling themselves the “Iraqi Resistance Coordination Commission” published a statement suggesting they would suspend attacks in return for a clear plan for U.S. troops to leave, just one month after the U.S. threatened to shut its embassy unless the Iraqi government curbed the Iran-aligned militias responsible for attacks on U.S. interests with rockets and roadside bombs. While the group presented no deadline, the move came amidst criticism from Iraqis who accused the pro-Iran militias of putting the country at risk of a proxy war between Iran and the Americans. ([SITE/REUTERS](#)) *Analyst Comment: As the January 3 anniversary of IRGC Major General Qassem Soleimani's targeted killing by the U.S. approaches, the Hizballah Brigades may be publicly attempting to distance itself from specific violent actions against the U.S. embassy, affording it some measure of plausible deniability, the traditional hallmark of Iran-sponsored proxy operations. This public posture may also be aimed at avoiding any significant action that could potentially jeopardize current and future ceasefire agreements with other Iran-sponsored militia groups.*

Far-Right Members Allude to Threats of Planned Violence for Upcoming Pro-Trump Rally in January

On December 29 and 30, social media posts by far-right extremist supporters issued vague threats referencing planned violence during the upcoming pro-Trump rally set to take place on January 6 in Washington, D.C. On December 29, the highest ranking member of the Proud Boys, chairman Enrique Tarrio, posted on Parler, that group members would not

wear their signature colors or organize centrally. Typically, Proud Boys don black and yellow to distinguish themselves in crowds. Tarrio warned “We will be incognito and we will spread across downtown DC in smaller teams,” adding that members may even choose to wear all-over black clothes, a color traditionally worn by activists viewed as adversaries by the group. Tarrio’s post was in reaction to an article in the *Washington Post* that alleged the Proud Boys repeatedly use the Hotel Harrington to organize while in D.C. causing the hotel to close for three days during the rally. Similarly, a thread begun on December 30, 2020 on 4chan described the rally as having “the potential of getting dangerous,” with one user responding that during the rally “some of us are taking direct action” and that “biden and harris both have quite a surprise coming.” Additionally, users on a well-known militia forum recently discussed the upcoming January 6 protest, with one user stating “I will be at our state Capitol January 6th in full body armor with my right to bear arms! I hope all attend as I’m sure antifa will be there.” Members of the thread were generally sympathetic to the Proud Boys and expressed contempt for Black Lives Matter (BLM) and the U.S. government, arguing that they are aligned in their hostility to right-wing movements in the U.S. (SITE) *Analyst Comment: A pro-Trump rally earlier in December resulted in four individuals being stabbed near a gathering point for the Proud Boys and 33 arrested after clashes between far-right supporters and counter-protesters. Racially/Ethnically/Politically Motivated Violent Extremists have also employed social media to publicize their weaponized preparation for the upcoming rally.*

Salafi-Jihadist Extremist Unit “Al-Zarqawi Battalion” Glorifies Lone Offender Attacks, Belittles Non-Fighters

A statement by the Salafi-Jihadist extremist unit, the Al-Zarqawi Battalion, issued on December 30 urged followers to “wage jihad” drawing inspiration from recent attackers, praising Vienna gunman Kujtim Fejzulaj among them. The statement manipulated excerpts from Islamic holy texts to promote attacks by homegrown violent extremists (HVEs) to “attain one of the best outcomes [victory or martyrdom], with the strength and power of Allah,” and shamed those followers who refrain from fighting. It stated in part: “Prepare an answer if you can, O you who have abandoned jihad and did not follow the trail of Companions, preferring to love dishonor and sail through the life of humiliation. You will not escape, and will receive the tidings of being exchanged, and they will not be your likes [sic].” (SITE)

Indonesia Outlaws “Islamic Defenders Front” Vigilante Group

Indonesian law enforcement authorities banned the Islamic Defenders Front vigilante group on December 30, with a government statement saying its members engaged in terrorist and criminal acts and that activities organized by the group disturbed public order. The group, commonly known by its Indonesian acronym, F.P.I., was ordered to cease all activities just days after its leader, Rizieq Shihab, was arrested and six of his bodyguards were shot and killed by police. The shooting occurred after the suspects allegedly attacked officers in an unmarked car they believed to be following them. A controversial figure who claims to be descended from the Prophet Muhammad, Shihab recently returned to Indonesia in November from a three-year, self-imposed exile in Saudi Arabia. Shihab turned himself into police earlier this month for violating coronavirus protocols by holding gatherings of thousands of people; he faces up to six years in prison. According to government authorities, 29 members of the Islamic Defenders Front were previously convicted of committing acts of terrorism, while 100 were convicted of other crimes. A spokesperson for the group said the prohibition has no legal standing and will not deter followers from continuing their “struggle in defending the country and religion” under a different name. 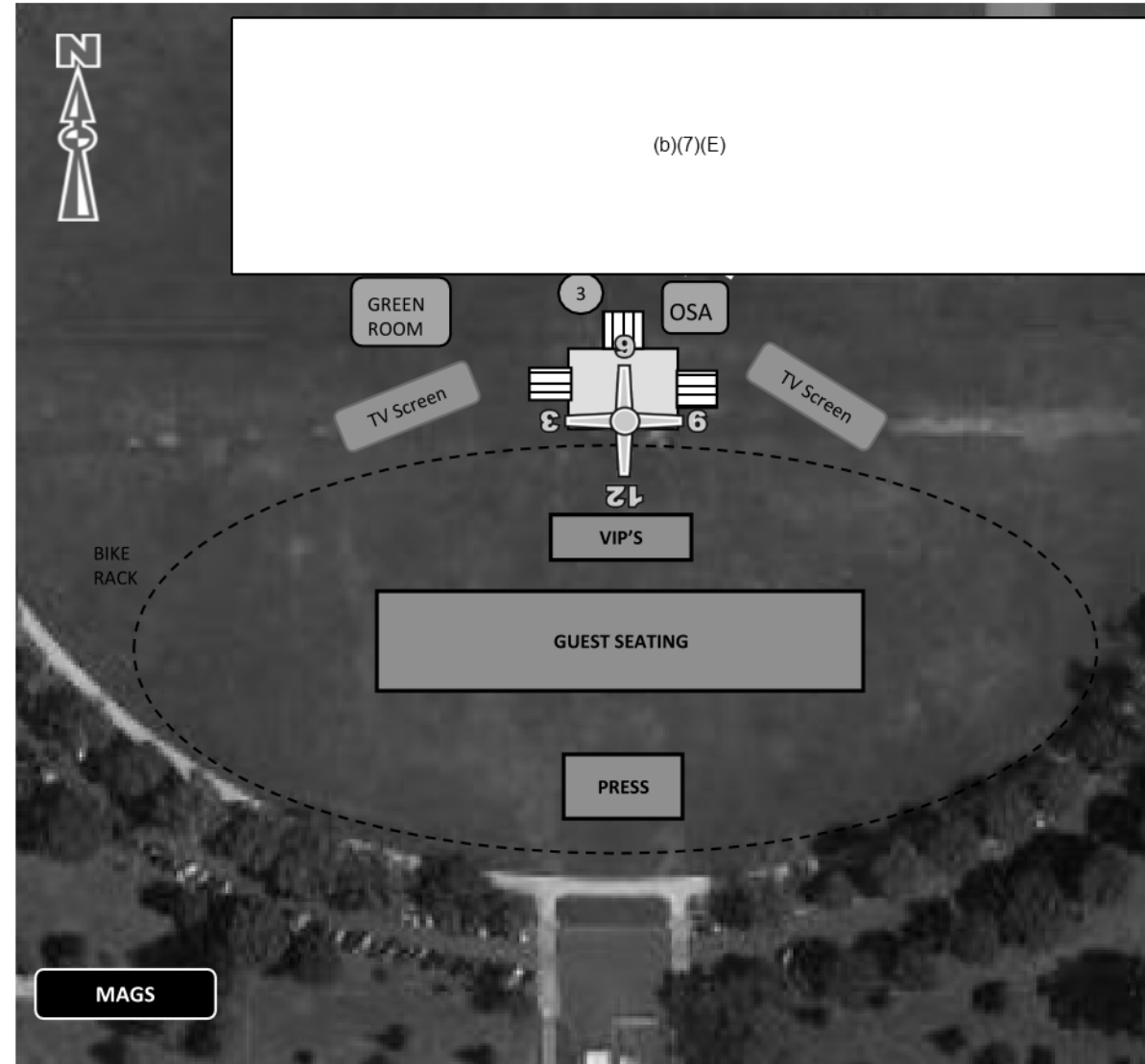

On 01/06/21, Congress will vote to certify the electoral college results. Approximately fifty different groups have indicated they will demonstrate in Washington, DC. Past encounters between opposing protest groups have occasionally led to violence between them and against law enforcement personnel. Attached is an overview of notable trends and tactics recently observed, which should be considered ahead of potential civil unrest in the National Capital Region. PID has issued multiple Protective Intelligence products since June 6, 2020, concerning threats to law enforcement personnel

(U) Executive Summary

On January 6th, 2021, a joint session of Congress will meet on Capitol Hill to certify the votes of the Electors to the Electoral College from each state in the Union. Large groups of demonstrators are anticipated to travel to Washington, DC in advance of the vote. Past encounters between opposing protest groups have occasionally led to violence between them and against law enforcement personnel, as well as damage to private and government property. Roughly 26 demonstration permits have been approved by the US Park Police for January 5-7, including Freedom Plaza, Washington Monument, the National Mall Area and the Capitol, and several hotels are sold out on January 5-6, both indicators of large crowds. Permit application estimates indicate there could be approximately 28,000 people in attendance for these events. At least 55 additional demonstrations have been mentioned on social media for January 6, but it is unclear whether any are permitted.

The Proud Boys (RID), a group who is of record for numerous demonstrations at the White House and temporarily protected sites, have advised they will not wear their traditional black and yellow attire and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers." The group has not been known to engage in civil disobedience and their demonstrations have ended without incidents or arrests.

(U) Recent Events Featuring Violent Tactics

On Saturday, 12/12/20, at least eight officers sustained injuries during violent altercations after a Million MAGA March rally in DC as objects were thrown and officers were assaulted. Multiple assaults took place between protestors and four individuals were stabbed after an argument escalated. Shields, eye gear, helmets, armor, pepper spray, and a variety of weapons were utilized by the opposing sides.

- In Sacramento, individuals threw objects at officers and some deployed pepper spray. Individuals from opposing protest groups wore gas masks, helmets, and armor.
- In Olympia, WA, officers were assaulted by objects including rocks, a baton, and a paintball gun. Individuals from opposing groups possessed firearms and one individual was arrested in connection to a shooting. Additionally, a large firework IED that failed to detonate was found in the area which had to be rendered safe by the state bomb squad.

On Saturday, 12/05/20, three Sacramento officers suffered minor injuries during dueling protests which saw thrown objects and lasers shone into officers' eyes.

On Saturday, 11/14/20, during clashes after the Million MAGA March rally between pro-Trump supporters and counter protesters, four DC police officers were injured while intervening in fights and keeping the opposing sides separate. There were reports of objects being thrown, including rocks and bottles. One protestor was stabbed and transported to the hospital.

On Saturday, 10/31/20, two San Francisco officers were assaulted with caustic chemicals during a free speech rally when counter protesters threw bottles filled with the substance. Officers reported trouble breathing and burning sensations. Glass bottles, cans, and eggs were also thrown.

In addition, the source reports that (b)(6); (b)(7)(C) previously made threats against President-Elect Biden. The source also reported that (b)(6); (b)(7)(C) was driving to DC with gear and weapons, to include ballistic helmets, armored gloves and vests, rifles, and suppressors. The items are reported to be loaded in "black plastic tubs with master locks." (b)(6); has two vehicles registered. It is not clear at this time which vehicle he is driving (descriptions of both are attached).

> USSS/BAL interviewed the (b)(6); (b)(7)(C) upon arrival at BWI. The subjects claimed that they are in the area to protest election fraud, support President Trump, and acknowledged the possibility of violence if approached by counter-protestors. The subjects denied making any threats towards USSS protectees. The subjects refused to provide any information about where they were staying or any information regarding (b)(6); (b)(7)(C). They did confirm that they will be departing the area on 1/7/21 via flight from IAD.

- This is a super-spreader event.
- MPD will be flexible because of the presence of the National Guard holding down the check points and perimeter points.

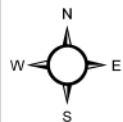

Protective Intelligence Brief

March for Trump

Background

Since the 2020 election, demonstrations have been organized nationwide advocating for President Trump and speaking out against the election results. In November 2020, a pro-Trump gathering in Washington, DC, resulted in an estimated **11,000** participants at Freedom Plaza, who marched to the Capitol and Supreme Court, and in December 2020, another pro-Trump gathering in Washington, DC, resulted in approximately **3,000** participants. The Pro-Trump protesters split between Freedom Plaza, the National Mall, the Capitol and the Supreme Court, with some individuals marching from one place to another, while others protested in one spot. For additional information, please refer to the PID After Action Talking Points the Million MAGA March After Action Nov 16 2020 (dhs.gov) and PID Briefing Document - March for Trump 12-12 Event (After Action).docx (dhs.gov) for additional information regarding these previous demonstrations.

The November and December demonstrations resulted in verbal and physical altercations between pro and anti-Trump demonstration groups, as well as numerous arrests. During the November 14, 2020, demonstration the Metropolitan Police Department (MPD) reported 21 arrests for assault, assault on a Police officer, possession of a weapon, disorderly conduct, and inciting violence. There were also seven firearms recovered by MPD during this event. The December 12, 2020, demonstration resulted in 33 arrests for assault on a police officer, simple assault, riotous acts, possession of a prohibited weapon (taser) and crossing a police line. MPD also reported during this event there were four people stabbed during an altercation, which included one MPD officer. All of the victims received non-life-threatening injuries and were treated and released.

Individuals continue to speak out against the 2020 presidential election results, and pro-Trump supporters have begun to organize another large-scale demonstration to occur on January 6, 2021. This is the day Congress is scheduled to certify the Electoral College vote for President-elect Joe Biden. As momentum for the demonstrations increased, President Trump tweeted to encourage his supporters to come to DC and protest, writing, "Be there, will be wild!" Individuals chose this tagline for the upcoming protest, naming it the "Wild Protest." The hashtag #WildProtest has been widely used to discuss and promote the event. President

Trump tweeted again on December 27, 2020, promoting the protest. As of December 30, 2020, social media indicated **5,989** participants plan to attend, and an additional **15,684** are interested.

Organizers

Stop The Steal (NRID), *Million MAGA March (NRID)*, *Women for America First (NRID)*, *March for Trump (NRID)*, *Proud Boys (RID)*, and other pro-Trump groups, along with private citizens, have promoted event pages for the event.

Stop The Steal is a loosely organized group which emerged on November 7, 2020, with the belief the election is being stolen from President Trump due to election fraud. The group began organizing demonstrations nationwide called "Stop The Steal." According to the website, invited speakers and featured guests for the January 6, 2021 event include Rep. Paul Gosar, Ali Alexander, Roger Stone, Rep-Elect Marjorie Greene, Rep. Lance Gooden, Rep-Elect Lauren Boebert, State Rep. Vernon Jones, State Rep. Mark Finchem, State Sen. Doug Mastriano, State Rep. Anthony Kern, and several others. One spokesperson from Stop The Steal, Ali Alexander (NRID), has encouraged followers to bring tents, sleeping bags, food, and water. Alexander claimed, "if DC escalates...so do we. Do not wear a mask. Stand with others bullied by staff." Twitter removed this tweet as it violated the spread of COVID-19 harmful information.

The Million MAGA March has been involved in organizing both large protests in November and December. The website was created early November prior to the first Million MAGA March, which spurred several social media groups and pages supporting this movement.

Women for America First is a pro-Trump, female led group. The group was the center of organization for both the November and December protests. The group plans to host a "March for Trump" bus tour from California to Washington, DC, arriving on the January 6, 2021.

Although March for Trump is listed as a group, several different smaller factions are listed under this name. The group name is considered more of a movement than an organization.

Proud Boys is a right-wing group founded in 2016 by Gavin McInnes as a "pro-Western fraternal organization." They are of record with USSS for demonstration activity since 2017; no civil disobedience or arrests have been recorded. For more information on the Proud Boys, please see the [Protective Intelligence Brief Proud Boys Talking Points](#).

Hotel Harrington, an alleged hangout/hotel for the Proud Boys, made a statement on December 28, 2020, announcing their closure from January 4-6, 2021, for "safety of visitors and employees." According to news media, four individuals were stabbed outside the hotel during the protests on December 12, 2020, when Proud Boys members clashed with counter protesters. Proud Boys' self-proclaimed chairman, Enrique Tarrio (NRID), made a statement on Parler regarding the closing of Hotel Harrington, claiming the Proud Boys outgrew the hotel and are planning on protesting during the January 4-6, 2021, time frame and will be staying at various other locations.

Call to Protest

On January 6, 2021, a consortium of private citizens and pro-Trump groups reportedly will host the Wild Protest in Washington, DC. The groups intend to demonstrate in support of President Trump and speak

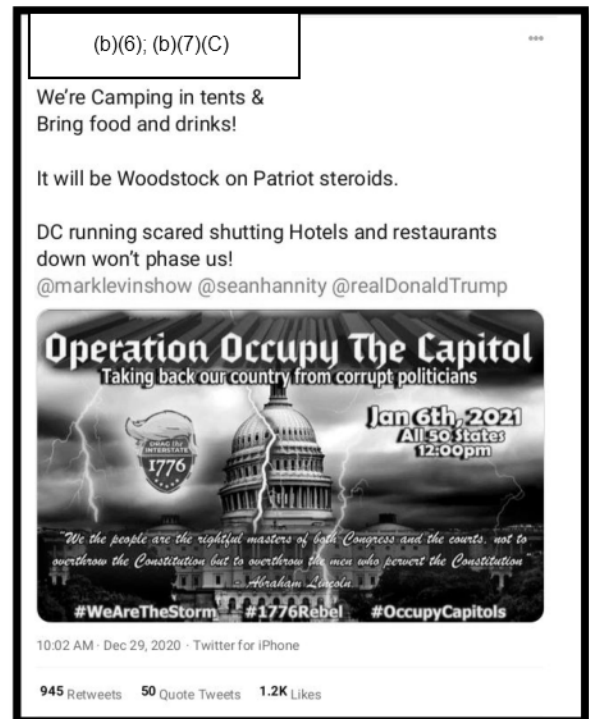

out against the 2020 election results. Numerous groups have claimed to be protesting at the US Capitol, with other groups protesting at the White House.

The hashtags #WeAreTheStorm, #1776Rebel, and #OccupyCapitols have gained attention as the protest on January 6, 2021 approaches. Commenters argue that other individuals were able to occupy other areas, including Black Lives Matter Plaza and the Capitol Hill Organized Protest/Capitol Hill Autonomous Zone, during separate protests, so President Trump supporters have proposed a movement to occupy Capitol Hill. This movement is supported by Ali Alexander's video requesting individuals to bringing tents, food, sleeping bags, and water (which has received over 300 comments and 2.5K retweets). Individuals who cannot come to Washington, DC, are encouraged to occupy their local capitols.

A website was located for chats and events related to the January 6th, 2021 DC Protest, titled *Maga Drag the Interstate*. Through this site, users are able to submit/create event caravan pages. All events are currently in reference to car and motorcycle caravans. There are currently 511 members for the "Jan 6 DC Caravan Planning" group with 47 events starting from all over the United States and reportedly ending in Washington, DC.



From January 4, 2021, at 10:00 AM to January 6, 2021, at 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "Carpool to Washington, DC" at the White House. The purpose of the event is to carpool from Texas and arrive in Washington, DC on 01/05/21. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 0 are interested.

From January 5, 2021, at 6:00 AM, to January 7, 2021, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 7 people are going, and 26 are interested.

On January 5, 2021, at 6:30 AM to January 7, 2021, at 7:00 AM, the group *Muskegon County Republican Party (NRID)* will host an event called "Muskegon Bus to DC – Tyump Rally Jan 6th- Stop The Steal" at the US Capitol. The purpose of the event is to take a bus from Muskegon to Washington, DC to support President Trump. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 32 are interested.

From January 5, 2021, at 07:00 AM to January 7, 2021 at 7:00 AM, the group *Oakland County Republican Party (NRID)* will host a demonstration called "March For Trump" in Washington, D.C. The group plans to leave from Michigan on January 5th to arrive in Washington D.C. at 9:00 AM on January 6th. The purpose of this event is to join the pro-Trump demonstrations. Post

permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Participants are encouraged to bring flags and signs. Bus tickets are being sold for \$125 through Eventbrite. The group plans to stay in DC until 6:00 PM on January 6th. Facebook indicates 8 going and 16 interested.

On January 5, 2021, at 9:00 AM to January 12, 2021, at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Protect the POTUS" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, 3 people are going, and 8 are interested.

From January 5, 2021, at 10:00 AM, to January 6, 2021, at 08:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC, from Florida, and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 5 people are going, and 5 are interested.

On January 5, 2021, at 10:00 AM to January 7, 2021 at 2:00 AM, the group *The First Heavy Metal Church of Christ* (NRID) will host an event called, "Patriots Part 2020 in D.C." in Washington, DC. The group plans to caravan to DC, stay at the Grand Hyatt, and protest all day. The purpose of the event is to show support for the nation. There is no indication of civil disobedience. According to Facebook, 7 people are going, and 44 are interested.

On January 5, 2021, at 03:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *Trump-News-Joe Biden/Corruption-Watch* (NRID) will host a demonstration called "Maga Million Trump March Washington DC January 6th 2021" in Washington, D.C. Location specifics have not yet been released. The purpose of this event is to join the pro-Trump demonstrations. Post permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Facebook indicates 3 going and 3 interested.

On January 5, 2021, at 6:00 PM to January 6, 2021, at 9:00 PM, the group *Wisconsin Salt & Light Brigade* (NRID) and individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Stop the Steal!" in Washington, DC. The purpose of the event is to "save our country from Biden/China tyranny!" There is no indication of civil disobedience. According to Facebook, 1 person is going, and 2 are interested.

There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire, and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers."

On January 6, 2021, at 12:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "National Caravan for Trump 'Stop the Steal' Rally" at the US Capitol. The purpose of the event is to join the caravan to protest in Washington, DC. There is no indication of civil disobedience. According to Facebook, 1 person is going and 0 are interested. (#MidnightRide)

On January 6, 2021, at 1:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "We the people need transparency!" at the US Capitol. The purpose of the event is to "show up outside the US Senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 2 person is going, and 5 are interested.

The purpose of the event is to "join together on this day. In support of our election." There is no indication of civil disobedience. According to Facebook, 1 person is going, and 1 is interested.

On January 6, 2021, at 9:00 AM, private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the National Mall called "President Trump's Calling on Patriots to Protest in Washington D.C. January 6th @ the National Mall." The purpose of this demonstration is to join the pro-Trump demonstrations as a contingency from Texas. There was no indication of civil disobedience. According to Facebook, 112 people are going, and 131 are interested.

On January 6, 2021, at 12:00 PM, the group *Million MAGA March (NRID)* will host a demonstration at the National Mall in Washington, DC, called "Million MAGA March – Round III." The purpose of this demonstration is to show support for President Trump and speak out against the election results. The group is utilizing hashtags #millionmagamarch, #millionmagamarch2021, and #stopthesteal. There was no indication of civil disobedience. Their website last indicated 1,522 people are going. The website has since removed the number of participants.

On January 6, 2021, at 12:00 PM, the group *Patriot Party (NRID)* and private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the US Capitol called "Patriots United March on Congress." The purpose of the demonstration is to speak out for election integrity while Congress meets to confirm the Electoral College votes. The group indicates plans to meet at the Capitol, but has not indicated potential routes. There is no indication of civil disobedience. According to Facebook, 34 people are going, and 212 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *Eighty Percent Coalition (NRID)* will host an event called "Rally to Save America" at Freedom Plaza. The purpose of the demonstration is to support President Trump. According to the website, confirmed speakers include Roger Stone, Julio Gonzalez, George Papadopoulos, Mark Burns, Greg Locke, and Bernard Kerik. There is no indication of civil disobedience. On January 6, 2021, at 12:00 PM, *The Patriot Party* (NRID) will host an event called "Maga Rally" in Washington, DC. The purpose of the event is to support President Trump. There is no chatter on the page, nor any indication of civil disobedience. Current numbers per Facebook, 6 going with 10 interested.

Counter Demonstrations

There are several counter-demonstrations planned for January 6, 2021. OSB has observed less social media activity and chatter for these counter-demonstrations than during previous pro-Trump demonstrations. The themes emerging from social media chatter amongst the counter protestors is similar to the rhetoric espoused during prior protests; the groups are attempting to keep Proud Boys and other Pro-Trump groups out of Washington, DC.

Several local groups have shared the news regarding Hotel Harrington closing from January 4-6, 2021, and have encouraged followers to contact other local hotels to encourage them to shut down as well. Although *ShutDownDC* (RID), *All Out DC* (RID), and *Black Lives Matter DC* (RID), have shared the news regarding Hotel Harrington on social media, they have not publicly announced any details regarding plans to protest.

On January 6, 2021, at an unknown time, the group *Refuse Fascism* (RID) will host a demonstration in Washington, DC, called "Opposing Trump's Moves to Overturn the Election." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, at an unknown time, the groups *They Them Collective* (RID), *Total Liberation Collective* (NRID), *DC Protests* (NRID), *Good TroubleCo.op* (NRID), *Smash the Fash NOVA* (NRID), and *DC Youth Liberation Front/DCYLF* (RID) will host a demonstration in Washington, DC, called

"Alert: Terrorists in Town Jan 3-6, 17-23." The purpose of this demonstration is to counter demonstrate during the Proud Boys and Stop the Steal demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On 01/06/21, at an unknown time, the group *DC Protests (NRID)* will host a demonstration with an unknown title in Washington, DC. The purpose of the event is to form a bike line to "protect against the armed right-wing extremist groups." The group plans on forming a bike line using bikes, boards, and wheels. The specific location was not provided. There is no indication of civil disobedience. Participant numbers were not available.

On January 6, 2021, from 12:00 PM to 3:00 PM, the group *I Approve This Message (NRID)* will host a demonstration at the US Capitol Building called "Donald, You're Fired! March on DC." The purpose of the demonstration is to "witness this momentous occasion. Upon the declaration of the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There is no indication of civil disobedience. According to Facebook, 8 people are going, and 26 are interested.

On January 6, 2021, at 1:00 PM, the groups *Insurgence USA (NRID)* and *Protest Live (NRID)* will host a demonstration in Washington, DC, called "No Fascist in DC – March Against Fascism." The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 80 are interested.

Refuse Fascism has demonstrated on numerous occasions at the White House and temporary protected sites. One demonstration in 2017, held near Trump Tower in New York City, ended with arrests for disorderly conduct and failure to obey.

TheyThem Collective is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.

DC Youth Liberation Front is of record with the USSS for a demonstration in August 2020 near Meridian Park. The group utilized sound equipment and MPD made several arrests for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows.

ShutDownDC has demonstrated on numerous occasions in relation to social justice in Washington, DC, as well as outside Acting DHS Secretary Chad Wolf's home. A ShutDownDC demonstration on June 2, 2020, resulted in one arrest for possession of an imitation pistol and a BB gun.

All Out DC is of record with the USSS for numerous demonstrations at the White House. During an All Out DC demonstration in June 2020, protestors were observed using fireworks, obstructing roads, and throwing debris at officers. MPDC used smoke to clear the area and the demonstration concluded with one arrest for threats.

Black Lives Matter has demonstrated on numerous occasions at the White House and temporary protected sites. The group has previously used sound equipment. One demonstration on June 4, 2020, concluded with one arrest after gas cans and fireworks were observed inside a subject's vehicle. Two

arrests were made during a demonstration on June 2, 2020, for possession of an imitation pistol and possession of a BB gun.

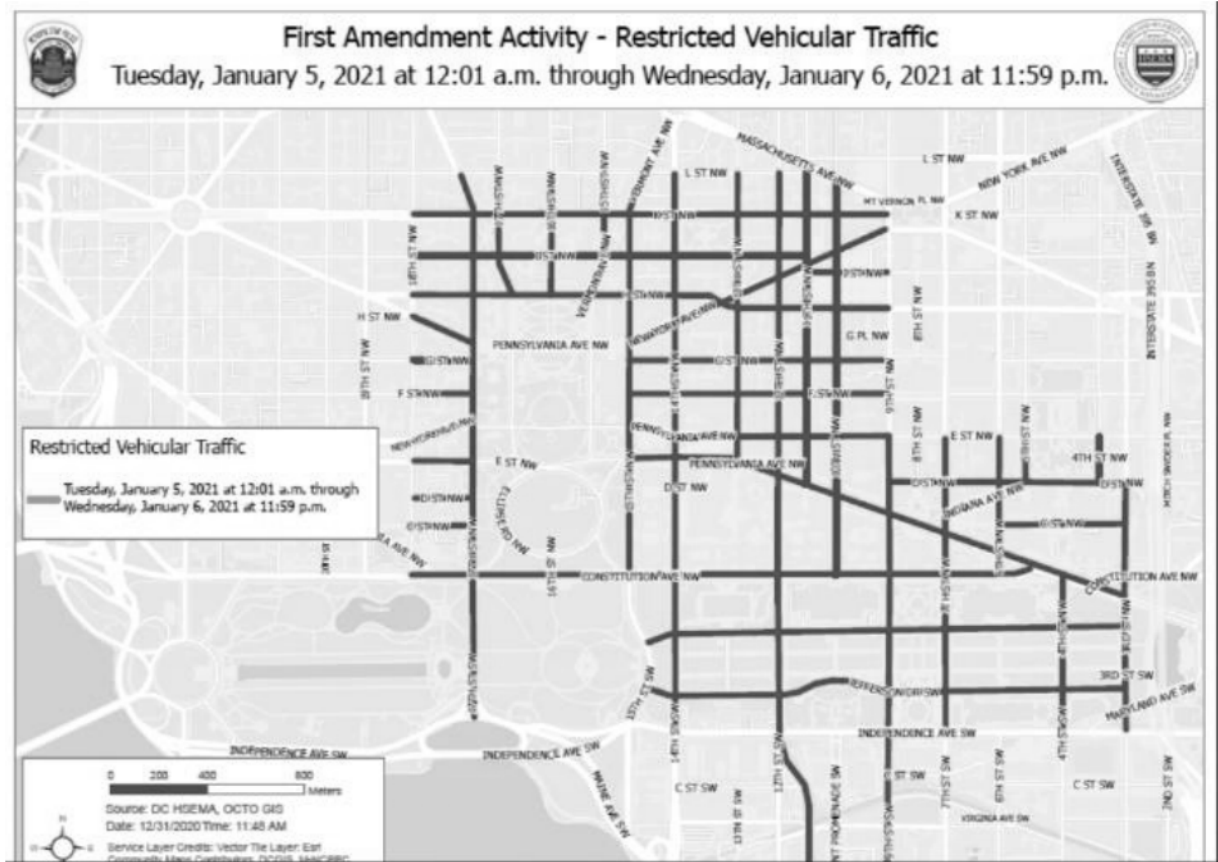

Background

Since the 2020 election, demonstrations have been organized nationwide advocating for President Trump and speaking out against the election results. In November 2020, a pro-Trump gathering in Washington, DC, resulted in an estimated **11,000** participants at Freedom Plaza, who marched to the Capitol and Supreme Court, and in December 2020, another pro-Trump gathering in Washington, DC, resulted in approximately **3,000** participants. The Pro-Trump protesters split between Freedom Plaza, the National Mall, the Capitol and the Supreme Court, with some individuals marching from one place to another, while others protested in one spot. For additional information, please refer to the PID After Action Talking Points the [Million MAGA March After Action Nov 16 2020 \(dhs.gov\)](#) and [PID Briefing Document - March for Trump 12-12 Event \(After Action\).docx \(dhs.gov\)](#) for additional information regarding these previous demonstrations.

The November and December demonstrations resulted in verbal and physical altercations between pro and anti-Trump demonstration groups, as well as numerous arrests. During the November 14, 2020, demonstration the Metropolitan Police Department (MPD) reported 21 arrests for assault, assault on a Police officer, possession of a weapon, disorderly conduct, and inciting violence. There were also seven firearms recovered by MPD during this event. The December 12, 2020, demonstration resulted in 33 arrests for assault on a police officer, simple assault, riotous acts, possession of a prohibited weapon (taser) and crossing a police line. MPD also reported during this event there were four people stabbed during an altercation, which included one MPD officer. All of the victims received non-life-threatening injuries and were treated and released.

Individuals continue to speak out against the 2020 presidential election results, and pro-Trump supporters have begun to organize another large-scale demonstration to occur on January 6, 2021. This is the day Congress is scheduled to certify the Electoral College vote for President-elect Joe Biden. As momentum for the demonstrations increased, President Trump tweeted to encourage his supporters to come to DC and protest, writing, "Be there, will be wild!" Individuals chose this tagline for the upcoming protest, naming it the "Wild Protest." The hashtag #WildProtest has been widely used to discuss and promote the event. President

Trump tweeted again on December 27, 2020, promoting the protest. As of December 30, 2020, social media indicated **5,989** participants plan to attend, and an additional **15,684** are interested.

Organizers

Stop The Steal (NRID), *Million MAGA March (NRID)*, *Women for America First (NRID)*, *March for Trump (NRID)*, *Proud Boys (RID)*, and other pro-Trump groups, along with private citizens, have promoted event pages for the event.

Stop The Steal is a loosely organized group which emerged on November 7, 2020, with the belief the election is being stolen from President Trump due to election fraud. The group began organizing demonstrations nationwide called "Stop The Steal." According to the website, invited speakers and featured guests for the January 6, 2021 event include Rep. Paul Gosar, Ali Alexander, Roger Stone, Rep-Elect Marjorie Greene, Rep. Lance Gooden, Rep-Elect Lauren Boebert, State Rep. Vernon Jones, State Rep. Mark Finchem, State Sen. Doug Mastriano, State Rep. Anthony Kern, and several others. One spokesperson from Stop The Steal, Ali Alexander (NRID), has encouraged followers to bring tents, sleeping bags, food, and water. Alexander claimed, "if DC escalates...so do we. Do not wear a mask. Stand with others bullied by staff." Twitter removed this tweet as it violated the spread of COVID-19 harmful information.

The Million MAGA March has been involved in organizing both large protests in November and December. The website was created early November prior to the first Million MAGA March, which spurred several social media groups and pages supporting this movement.

Women for America First is a pro-Trump, female led group. The group was the center of organization for both the November and December protests. The group plans to host a "March for Trump" bus tour from California to Washington, DC, arriving on the January 6, 2021.

Although March for Trump is listed as a group, several different smaller factions are listed under this name. The group name is considered more of a movement than an organization.

Proud Boys is a right-wing group founded in 2016 by Gavin McInnes as a "pro-Western fraternal organization." They are of record with USSS for demonstration activity since 2017; no civil disobedience or arrests have been recorded. For more information on the Proud Boys, please see the [Protective Intelligence Brief Proud Boys Talking Points](#).

Hotel Harrington, an alleged hangout/hotel for the Proud Boys, made a statement on December 28, 2020, announcing their closure from January 4-6, 2021, for "safety of visitors and employees." According to news media, four individuals were stabbed outside the hotel during the protests on December 12, 2020, when Proud Boys members clashed with counter protesters. Proud Boys' self-proclaimed chairman, Enrique Tarrio (NRID), made a statement on Parler regarding the closing of Hotel Harrington, claiming the Proud Boys outgrew the hotel and are planning on protesting during the January 4-6, 2021, time frame and will be staying at various other locations.

Call to Protest

On January 6, 2021, a consortium of private citizens and pro-Trump groups reportedly will host the Wild Protest in Washington, DC. The groups intend to demonstrate in support of President Trump and speak

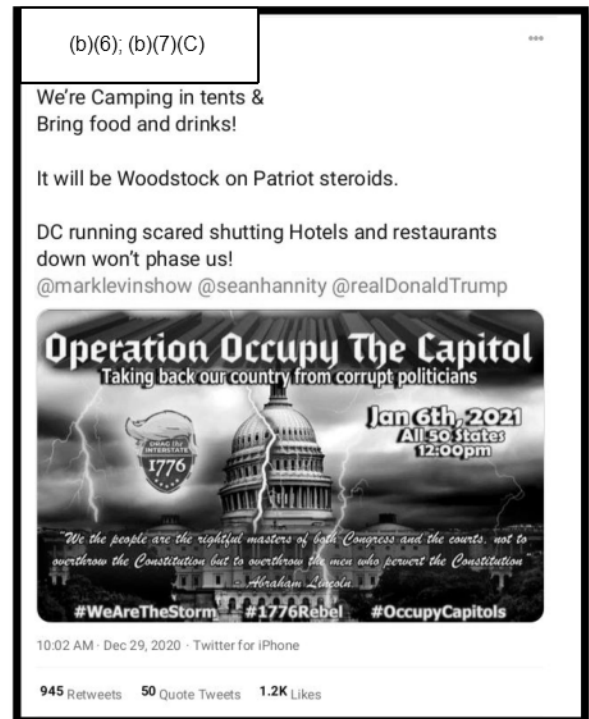

out against the 2020 election results. Numerous groups have claimed to be protesting at the US Capitol, with other groups protesting at the White House.

The hashtags #WeAreTheStorm, #1776Rebel, and #OccupyCapitols have gained attention as the protest on January 6, 2021 approaches. Commenters argue that other individuals were able to occupy other areas, including Black Lives Matter Plaza and the Capitol Hill Organized Protest/Capitol Hill Autonomous Zone, during separate protests, so President Trump supporters have proposed a movement to occupy Capitol Hill. This movement is supported by Ali Alexander's video requesting individuals to bringing tents, food, sleeping bags, and water (which has received over 300 comments and 2.5K retweets). Individuals who cannot come to Washington, DC, are encouraged to occupy their local capitols.

A website was located for chats and events related to the January 6th, 2021 DC Protest, titled *Maga Drag the Interstate*. Through this site, users are able to submit/create event caravan pages. All events are currently in reference to car and motorcycle caravans. There are currently 511 members for the "Jan 6 DC Caravan Planning" group with 47 events starting from all over the United States and reportedly ending in Washington, DC.



From January 4, 2021, at 10:00 AM to January 6, 2021, at 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "Carpool to Washington, DC" at the White House. The purpose of the event is to carpool from Texas and arrive in Washington, DC on 01/05/21. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 0 are interested.

From January 5, 2021, at 6:00 AM, to January 7, 2021, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 7 people are going, and 26 are interested.

On January 5, 2021, at 6:30 AM to January 7, 2021, at 7:00 AM, the group *Muskegon County Republican Party (NRID)* will host an event called "Muskegon Bus to DC – Tyump Rally Jan 6th- Stop The Steal" at the US Capitol. The purpose of the event is to take a bus from Muskegon to Washington, DC to support President Trump. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 32 are interested.

From January 5, 2021, at 07:00 AM to January 7, 2021 at 7:00 AM, the group *Oakland County Republican Party (NRID)* will host a demonstration called "March For Trump" in Washington, D.C. The group plans to leave from Michigan on January 5th to arrive in Washington D.C. at 9:00 AM on January 6th. The purpose of this event is to join the pro-Trump demonstrations. Post

permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Participants are encouraged to bring flags and signs. Bus tickets are being sold for \$125 through Eventbrite. The group plans to stay in DC until 6:00 PM on January 6th. Facebook indicates 8 going and 16 interested.

On January 5, 2021, at 9:00 AM to January 12, 2021, at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Protect the POTUS" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, 3 people are going, and 8 are interested.

From January 5, 2021, at 10:00 AM, to January 6, 2021, at 08:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC, from Florida, and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 5 people are going, and 5 are interested.

Current numbers per Facebook depict 0 going with 1 interested.

On January 6, 2021, from 9:00 AM, the group *Frederick County Conservative Club* (NRID) will host a demonstration in Washington, DC, called "Million MAGA March." The purpose of this demonstration is to show support for President Trump. The group plans on arriving at Freedom Plaza from Frederick, MD, at 9:00 AM, and departing DC at 3:30 PM. There is no indication of civil disobedience. According to Facebook, 97 people are going, and 251 are interested.

On January 6, 2021, from 9:00 AM to 06:00 PM, the group *Prime Time Patriots* (NRID) will host a demonstration called "MARCH FOR TRUMP" in 213 Pennsylvania Ave SE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 106 people are going, and 534 are interested.

On January 6, 2021, from 9:00 AM to 7:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Calling all Patriots! We have been called to DC to the Nation's Capital for a Peaceful protest to save #America #StopTheSteal" in Washington, DC. The purpose of the

demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 85 people are going, and 139 are interested.

From January 6, 2021, at 9:00 AM to January 7, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Patriot Protest March" in Washington, DC. The purpose of the event is to "protest the election fraud, tyranny and corrupt politicians." There is no indication of civil disobedience. According to Facebook, 11 people are going, and 28 are interested.

On January 6, 2021, from 10:00 AM to 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Trump Rally Jan 6" in Washington, DC. The purpose of the event is to "come to DC Jan 6 when Congress counts electoral votes and objections are raised." There is no indication of civil disobedience. According to Facebook, 97 people are going, and 163 are interested.

On January 6, 2021, from 10:00 AM to 4:00 PM, the group *Stop the Steal (NRID)* will host a demonstration at the US Capitol called "Wild Protest." The purpose of this demonstration is to speak out against the 2020 presidential election results. There is no indication of civil disobedience. According to Facebook, 148 people are going, and 206 are interested.

On January 6, 2021, at 11:00 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Fight for Trump" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 6 people are going, and 13 are interested.

The specific location has not been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. According to Facebook, there are 0 going, and 2 interested.

On January 6, 2021, at 12:00 PM, the group *Million MAGA March (NRID)* will host a demonstration at the National Mall in Washington, DC, called "Million MAGA March – Round III." The purpose of this demonstration is to show support for President Trump and speak out against the election results. The group is utilizing hashtags #millionmagamarch, #millionmagamarch2021, and #stopthesteal. There was no indication of civil disobedience. Their website last indicated 1,522 people are going. The website has since removed the number of participants.

On January 6, 2021, at 12:00 PM, the group *Patriot Party (NRID)* and private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the US Capitol called "Patriots United March on Congress." The purpose of the demonstration is to speak out for election integrity while Congress meets to confirm the Electoral College votes. The group indicates plans to meet at the Capitol, but has not indicated potential routes. There is no indication of civil disobedience. According to Facebook, 34 people are going, and 212 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *Eighty Percent Coalition (NRID)* will host an event called "Rally to Save America" at Freedom Plaza. The purpose of the demonstration is to support President Trump. According to the website, confirmed speakers include Roger Stone, Julio Gonzalez, George Papadopoulos, Mark Burns, Greg Locke, and Bernard Kerik. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 11 are interested.

On January 6, 2021, at 12:00 PM, an unknown group will host a demonstration titled "Operation Occupy The Capitol" in Washington, D.C. The purpose of the event is to "peacefully protest the election fraud." Participants are encouraged to protest at their state capitol if they are unable to travel to Washington D.C. There is no indication of civil disobedience at this time. The Twitter event hashtags are #WeAreTheStorm, #1776Rebel and #OccupyCapitols. Participant numbers are unknown as the event was located through flyer.

On January 6, 2021, at 12:00 PM, the group *Moore County Citizens for Freedom* (NRID) will host an event called "10 million MAGA MARCH" at Freedom Plaza. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 2 people are going, and 3 are interested.

On January 6, 2021, at 12:00 PM, the group *RiseUP Revolution: Welcome To The Patriot Party* (NRID) will host an event called "Fight For America" at 1455 Pennsylvania Ave SE. The purpose of the event is to Rally to fight for America. There is no indication of civil disobedience. According to Facebook, 0 people are going, and 3 are interested.

On January 6, 2021, at 12:00 PM, *The Patriot Party* (NRID) will host an event called "Maga Rally" in Washington, DC. The purpose of the event is to support President Trump. There is no chatter on the page, nor any indication of civil disobedience. Current numbers per Facebook, 6 going with 10 interested.

Counter Demonstrations

There are several counter-demonstrations planned for January 6, 2021. OSB has observed less social media activity and chatter for these counter-demonstrations than during previous pro-Trump demonstrations. The themes emerging from social media chatter amongst the counter protestors is similar to the rhetoric espoused during prior protests; the groups are attempting to keep Proud Boys and other Pro-Trump groups out of Washington, DC.

Several local groups have shared the news regarding Hotel Harrington closing from January 4-6, 2021, and have encouraged followers to contact other local hotels to encourage them to shut down as well. Although *ShutDownDC* (RID), *All Out DC* (RID), and *Black Lives Matter DC* (RID), have shared the news regarding Hotel Harrington on social media, they have not publicly announced any details regarding plans to protest.

On January 6, 2021, at an unknown time, the group *Refuse Fascism* (RID) will host a demonstration in Washington, DC, called "Opposing Trump's Moves to Overturn the Election." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, at an unknown time, the groups *They Them Collective* (RID), *Total Liberation Collective* (NRID), *DC Protests* (NRID), *Good TroubleCo.op* (NRID), *Smash the Fash NOVA* (NRID), and *DC Youth Liberation Front/DCYLF* (RID) will host a demonstration in Washington, DC, called

"Alert: Terrorists in Town Jan 3-6, 17-23." The purpose of this demonstration is to counter demonstrate during the Proud Boys and Stop the Steal demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On 01/06/21, at an unknown time, the group *DC Protests (NRID)* will host a demonstration with an unknown title in Washington, DC. The purpose of the event is to form a bike line to "protect against the armed right-wing extremist groups." The group plans on forming a bike line using bikes, boards, and wheels. The specific location was not provided. There is no indication of civil disobedience. Participant numbers were not available.

On January 6, 2021, from 12:00 PM to 3:00 PM, the group *I Approve This Message (NRID)* will host a demonstration at the US Capitol Building called "Donald, You're Fired! March on DC." The purpose of the demonstration is to "witness this momentous occasion. Upon the declaration of the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There is no indication of civil disobedience. According to Facebook, 8 people are going, and 26 are interested.

On January 6, 2021, at 1:00 PM, the groups *Insurgence USA (NRID)* and *Protest Live (NRID)* will host a demonstration in Washington, DC, called "No Fascist in DC – March Against Fascism." The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 80 are interested.

Refuse Fascism has demonstrated on numerous occasions at the White House and temporary protected sites. One demonstration in 2017, held near Trump Tower in New York City, ended with arrests for disorderly conduct and failure to obey.

TheyThem Collective is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.

DC Youth Liberation Front is of record with the USSS for a demonstration in August 2020 near Meridian Park. The group utilized sound equipment and MPD made several arrests for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows.

ShutDownDC has demonstrated on numerous occasions in relation to social justice in Washington, DC, as well as outside Acting DHS Secretary Chad Wolf's home. A ShutDownDC demonstration on June 2, 2020, resulted in one arrest for possession of an imitation pistol and a BB gun.

All Out DC is of record with the USSS for numerous demonstrations at the White House. During an All Out DC demonstration in June 2020, protestors were observed using fireworks, obstructing roads, and throwing debris at officers. MPDC used smoke to clear the area and the demonstration concluded with one arrest for threats.

Black Lives Matter has demonstrated on numerous occasions at the White House and temporary protected sites. The group has previously used sound equipment. One demonstration on June 4, 2020, concluded with one arrest after gas cans and fireworks were observed inside a subject's vehicle. Two

arrests were made during a demonstration on June 2, 2020, for possession of an imitation pistol and possession of a BB gun.

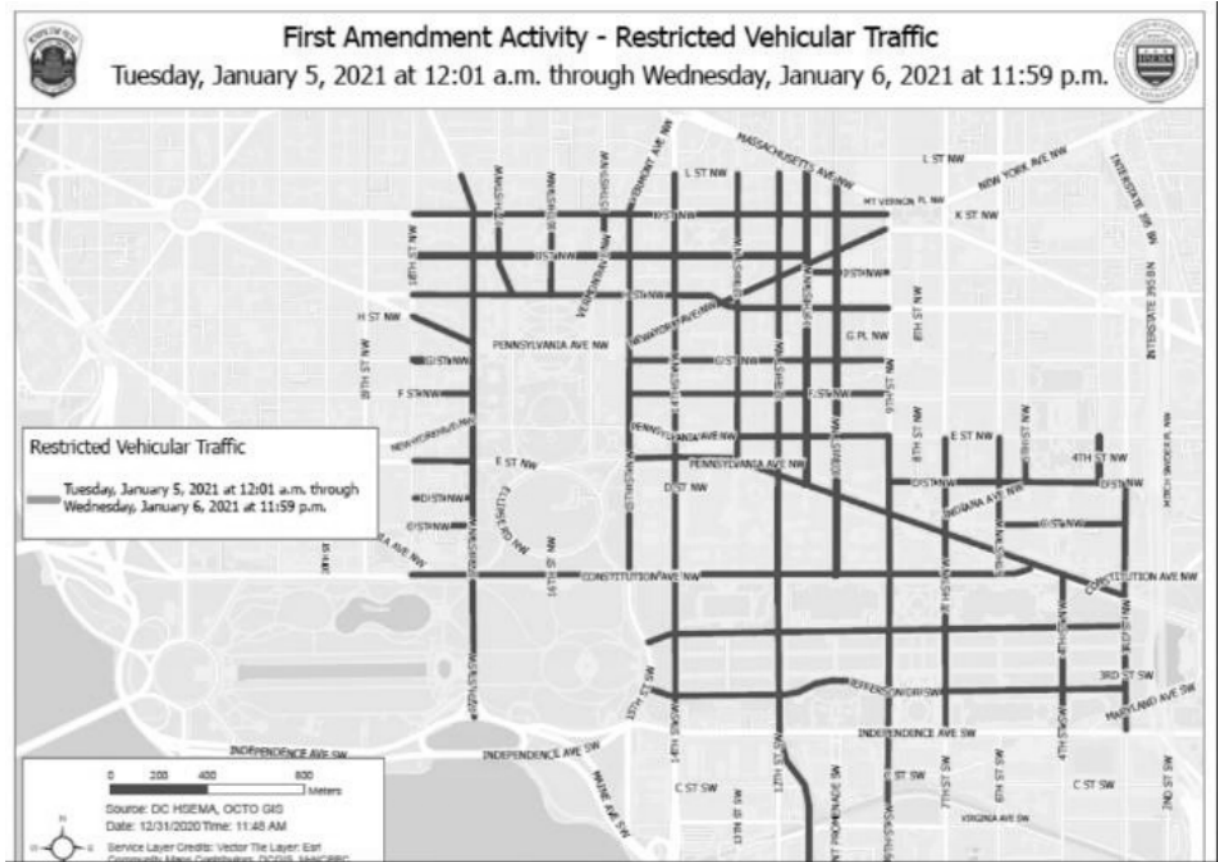

Subject: Mayor Bowser Continues Preparation for Upcoming First Amendment Demonstrations

This is an important message from the District of Columbia AlertDC system.

Mayor Bowser is continuing preparations for this week's First Amendment activities. She had previously directed the DC Homeland Security and Emergency Management Agency (HSEMA) to stand up the District's Emergency Operations Center (EOC) beginning Monday, January 4, to

coordinate the response for the upcoming First Amendment demonstrations, permitted by the National Park Service, scheduled for January 5 and January 6. The EOC serves as the coordination hub between District agencies and regional and federal partners. On Tuesday, the Metropolitan Police Department (MPD) begins its full activation with all staff reporting for response on Tuesday and Wednesday.

Mayor Bowser instructed District agencies to create a comprehensive public safety response to ensure residents' safety. Additionally, HSEMA and MPD are conducting event overviews for the Council of the District of Columbia, faith leaders, and the downtown business community. Residents are encouraged to report suspicious activity by making a report through iwatchdc.org or by calling 911 for immediate threats or emergencies.

“MPD and HSEMA are coordinating among District agencies and with federal authorities to ensure our residents and businesses remain safe,” said Mayor Muriel Bowser. “I am asking Washingtonians and those who live in the region to stay out of the downtown area on Tuesday and Wednesday and not to engage with demonstrators who come to our city seeking confrontation, and we will do what we must to ensure all who attend remain peaceful.”

Members of the public and anyone attending the events are reminded that District law prohibits anyone from carrying a firearm within 1,000 feet of any First Amendment activity. Under federal law, it is illegal to possess firearms on the U.S. Capitol grounds and on National Park Service areas, such as Freedom Plaza, the Ellipse, and the National Mall. Additionally, members of the public are reminded that the District of Columbia does not have reciprocity with other states' concealed pistol licenses; unless a person has been issued a concealed pistol license by the District of Columbia, they cannot conceal carry a firearm in the city. Finally, it is illegal to open carry firearms in the District.

Residents and commuters are encouraged to register for important alerts from the District by signing up for AlertDC at alertdc.dc.gov.

A comprehensive list of traffic adjustments and street closures in effect Tuesday, January 5, and Wednesday, January 6 can be found at <https://mpdc.dc.gov/release/traffic-advisory-first-amendment-activity-Jan5>.

While the Metropolitan Police Department does not anticipate additional street closures on Tuesday, January 5, 2021 and Wednesday, January 6, 2021, there is the potential for intermittent closures in the downtown area. Additionally, while the Metropolitan Police Department does not anticipate street closures on Thursday, January 7, 2021, there is the potential for intermittent closures in the downtown area. Any decision to close a street will be based upon public safety. For timely traffic information, visit: twitter.com/DCPoliceTraffic

The public should expect parking restrictions along the street and should be guided by the posted emergency no parking signage. All vehicles that are parked in violation of the emergency no parking signs will be ticketed and towed.

Motorists could encounter possible delays if operating in the vicinity of downtown area and may wish to consider alternative routes. The Metropolitan Police Department and the District

Department of Transportation also wishes to remind motorists in the vicinity of this event to proceed with caution as increased pedestrian traffic can be anticipated.

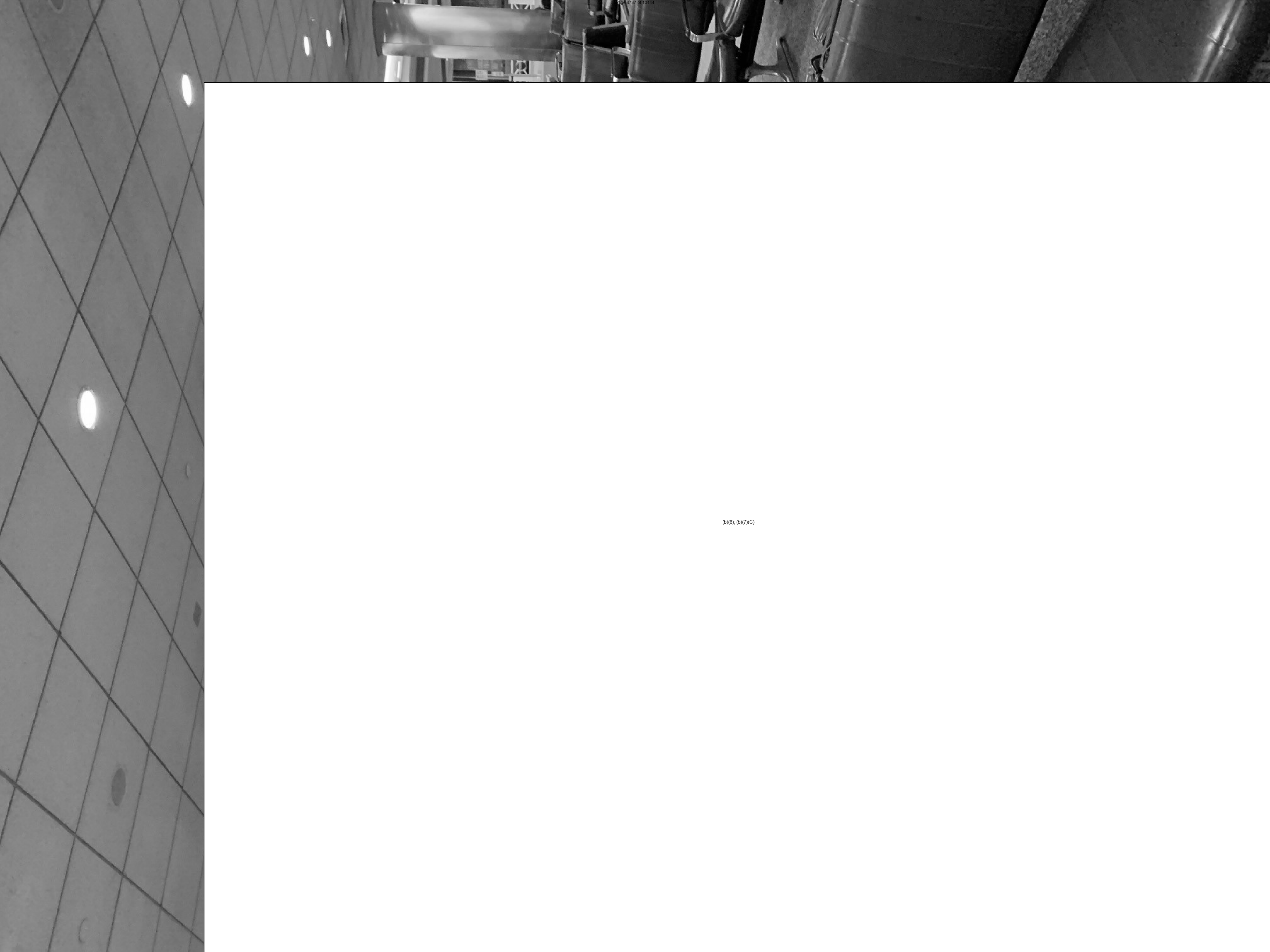

(b)(6); (b)(7)(C) arrived on United flight #2273 from (b)(6); (b)(7)(C) SA's (b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) identified themselves to (b)(6); (b)(7)(C) at the arrival gate and interviewed him and (b)(6); (b)(7)(C) at the gate area. All,

This is an FYSA/Situational awareness. There are zero indications that these individuals are traveling to Wilmington, but due to their proximity to DE, in an abundance of caution, (b)(6); (b)(7)(C) and I are pushing this out.

I spoke with the local Fusion Center this morning and they are tracking no incidents in DE, demos or threats.

Summary – attachment full incident

On 01/05/21, the PIOC was alerted that an (b)(6); (b)(7)(C) reported that the following individuals are traveling to the NCR to participate in the rally today, to incite violence with the Proud Boys and other groups. They all are Anti-Biden. The (b)(6); (b)(7)(C) travelled to the NCR via flights and (b)(6); (b)(7)(C) reportedly drove to bring tactical gear and firearms.

USSS/BAL, interviewed the (b)(6); (b)(7)(C) upon their arrival to BWI. Both confirmed they were there for the rally and did not plan on violence but if met with resistance from counter-protestors they would defend themselves. They refused to provide the location of (b)(6); (b)(7)(C)

The PIOC along with other NCR LE entities are all tracking the incident. Again, no indications that (b)(6); (b)(7)(C) is coming to DE, his friends are in DC, but it's not a far drive.

On 01/05/21, at 1340 hours EST, ATSAIC (b)(6); (b)(7)(C) USSS/DEN, contacted the PIOC to report the following incident:

On 01/05/21, ATSAIC (b)(6); (b)(7)(C) was contacted by (b)(6); (b)(7)(C) to report her (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) (NRID) (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID). (b)(6); (b)(7)(C) claimed (b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) were flying into BWI today (01/05/21) to attend tomorrow's rally and "incite violence." In addition, the source reports that (b)(6); (b)(7)(C) previously made threats against President-Elect Biden.

The source also reported that (b)(6); (b)(7)(C) was driving to DC with gear and weapons, to include ballistic helmets, armored gloves and vests, rifles, and suppressors. The items are reported to be loaded in "black plastic tubs with master locks." (b)(6); (b)(7)(C) has two vehicles registered. It is not clear at this time which vehicle he is driving.

SUBJECT INTERVIEW:

On 01/05/21, USSS/BAL interviewed (b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) upon arrival at BWI. The subjects claimed that they are in the area to protest election fraud, support President Trump, and acknowledged the possibility of violence if approached by counter-protestors. The subjects denied making any threats towards USSS protectees. The subjects refused to provide any information about where they were staying or any information regarding (b)(6); (b)(7)(C). They did confirm that they will be departing the area on 1/7/21 via flight from IAD.

CORROBORATIVE INTERVIEWS:

On 01/05/21, at 1016 hours MST, SSA (b)(6); (b)(7)(C) USSS/DEN, and (b)(6); (b)(7)(C) USSS/DEN, contacted (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) for a telephone interview. (b)(6); (b)(7)(C) told the SA's that she has been concerned about (b)(6); (b)(7)(C) behavior since Thanksgiving 2020. (b)(6); (b)(7)(C) has stopped working, become depressed, and is constantly watching right wing news sources and stating his beliefs that the United States is heading towards a communist end state.

(b)(6); (b)(7)(C) says (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) y/o, (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) younger), and (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) (approximately same age as (b)(6); (b)(7)(C) have reported to her that (b)(6); (b)(7)(C) has been stockpiling long guns, handguns, firearm suppressors, body armor, and "fighting gloves". (b)(6); (b)(7)(C) allegedly observed (b)(6); (b)(7)(C) watching the news, pointing an unloaded handgun at the T.V., and pulling the trigger every time President Elect Joe Biden appeared on the screen.

(b)(6); (b)(7)(C) reported that (b)(6); (b)(7)(C) observed (b)(6); (b)(7)(C) conducting a layout of the firearms and body armor in (b)(6); (b)(7)(C) residence in anticipation of going to Washington D.C. (b)(6); (b)(7)(C) reported that (b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) (b)(6); (b)(7)(C), planned to attend a Proud Boys rally in Washington D.C. on Jan 6, 2021.

(b)(6); (b)(7)(C) further reported that (b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) departed for Washington D.C. via plane on Jan 5, 2021 from the first flight out of (b)(6); (b)(7)(C) with the intent of staying there in a hotel for several days. According to (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) Unknown last name) left for Washington D.C. via car on Jan 4, 2021 at 1500 hours to link up with (b)(6); (b)(7)(C) and attend the Proud Boys Rally.

(b)(6); (b)(7)(C) reported to (b)(6); (b)(7)(C) that they observed the body armor and black locked tote bags being loaded into the vehicle driven by (b)(6); (b)(7)(C) When specifically questioned on if the weapons were loaded into the vehicle driven by (b)(6); (b)(7)(C) no one could confirm if the weapons were or were not in the vehicle.

(b)(6); (b)(7)(C) did not have a vehicle description for the one used by (b)(6); (b)(7)(C) to travel to Washington D.C. It should be noted that (b)(6); (b)(7)(C) said that (b)(6); (b)(7)(C) was a sympathizer with the Proud Boys, but was not necessarily a member. When asked about the reports of shooting the suppressors within the city limits of (b)(6); (b)(7)(C) to "see how loud they were", (b)(6); (b)(7)(C) could not confirm or deny those reports.

(b)(6); (b)(7)(C) confirmed that (b)(6); (b)(7)(C) states his is a veteran of the US Marine Corps, has TBI, who has bi-polar disorder. (b)(6); (b)(7)(C) stated that (b)(6); (b)(7)(C) has been more "violent" lately, but could offer no specific examples, other than to state he acted "crazy." The interview concluded at 1040 hours.

At 1103, Jan 5, 2021, SSA (b)(6); (b)(7)(C) and SA (b)(6); (b)(7)(C) interviewed (b)(6); (b)(7)(C) via telephone. (b)(6); (b)(7)(C) corroborated the same information that (b)(6); (b)(7)(C) reported to them. The interview ended at 1120.

PROSECUTORIAL PRESENTATION:

This incident has not been presented to the USAO for prosecution.

OTHER:

At 1425 hours EST, USSS/BAL was contacted to attempt to interview (b)(6); (b)(7)(C) when they arrive at BWI airport.

At 1431 hours EST, PIRS (b)(6); (b)(7)(C) USSS/PID/OSU, provided the following OSINT results:

OSINT research located an active Facebook account for (b)(6); (b)(7)(C). A review of his post did reveal the subject would be flying into the DC area to attend demonstration activities on January 6, 2020. There was no threatening language used or mention of weapons.

A review of the subject's commentary revealed the user would be meeting (b)(6); (b)(7)(C) presumably (b)(6); (b)(7)(C) who will have a "plenty of kits for everyone in his truck."

No other social media accounts were located for (b)(6); (b)(7)(C)

A Facebook account was located for (b)(6); (b)(7)(C) (b)(6); (b)(7)(C). The account was private. Nothing of PI interest was located.

No social media accounts were located for (b)(6); (b)(7)(C)

At 1644 hours EST, ATSAIC (b)(6); (b)(7)(C) notified the JOC personnel, WFO PI and USCP of this incident.

At 1725 hours EST, Lt. (b)(6); (b)(7)(C) USSS/UDW, confirmed (b)(6); (b)(7)(C) vehicle's information were placed in the LPR system.

WFO PI notified MPDC and Park Police of this incident.
