You have requested "documents detailing communications by the United States Attorney's Office for the Southern District of New York for planned warrants, subpoenas or investigative demands directed to Rudy Giuliani. The records you requested would pertain to particular individuals in the context of criminal prosecution or litigation. As such, you are seeking data pertaining to individuals. It is the policy of the Executive Office to neither confirm nor deny that records concerning living third parties exist when a request is made for a named party, without a showing by the requester that such records exist. Since you have not provided evidence of prosecution of any named, particular individuals, nor provided authorization from the individuals for access to their records, the requested information would be exempt from release pursuant to 5 U.S.C. 552(b)(6) and/or (b)(7)(C) which pertain to records whose disclosure would result in an unwarranted invasion of personal privacy. Further, any release to you of such records would be in violation of the Privacy Act. 5 U.S.C. 552a. <u>See</u> U.S. *Department of Justice v.
