June 1, 2020

ATF's role in response to the riots:

At the request of the Attorney General, ATF has deployed resources and is supporting our local, state, and federal law enforcement partners to uphold the rule of law. These resources include ATF's Special Agents from our 25 Field Divisions and Special Agent Certified Fire Investigators to assist in arson investigations and provide valuable technical and intelligence support. Enforcement Programs and Services has issued FFL Alerts to our industry partners to encourage their taking extra precautions during this time to protect both their inventory and records. St. Paul Field Division:

"We are closely monitoring the situation within the Twin Cities metro area," said Special Agent in Charge Terry Henderson, of the ATF St. Paul Field Division. "The last few evenings have been extremely volatile here and there are many in our various communities suffering right now. We stand ready to assist our local and state partners. We've invited in some of ATF's top subject matter experts in fire investigations including supervisors of our National Response Team, who are assessing the situation alongside our local agents, helping us come up with a well-thought-out plan on how to best support our law enforcement and fire investigation partners."

ATF's AOR Regarding Arson:

The Bureau of Alcohol, Tobacco, Firearms and Explosives is the Federal agency primarily responsible for administering and enforcing the criminal and regulatory provisions of the Federal laws pertaining to destructive devices (bombs), explosives, and arson.

Response to Media Inquiry Regarding an ATF-issued Text Alert to FFLs:

Kansas City Field Division received the following media inquiry from the St. Louis Post Dispatch:

Can you tell me about that ATF alert sent to license firearms dealers on Saturday, asking them to make sure guns are safely secured due to concerns about possible looting?

Text Alert to FFLs:

This is an important message from the Bureau of Alcohol, Tobacco, Firearms and Explosives. Possible civil unrest in our area may result in looting of businesses. The ATF reminds you to remain vigilant and to take appropriate steps to secure both your firearms inventory and your

required records. Please report all suspicious persons or activity to your local police department. Additionally, notify ATF at 888-930-9275 if you find any of your firearms missing, lost or stolen or if you are a victim of an attempted burglary of your business.

Response: In the interest of public safety, ATF has contacted Federal Firearms Licensees in areas that are at risk of experiencing civil unrest. We have asked licensees to be vigilant in securing their firearms inventory as well as the records that ATF relies upon to complete the tracing of firearms recovered by law enforcement. These notifications are routinely sent to FFLs across the country as the need arises.

19 cases and 112,006 deaths, according to Johns Hopkins University

- The U.S. Department of Health and Human Services (HHS) said Tuesday that it is taking additional steps to provide federal coronavirus relief funding to health care providers and hospitals that care for the poor and uninsured
 - The agency expects to distribute about \$15 billion to providers that participate in Medicaid and the Children's Health Insurance Program but have not yet received payments from a relief fund that Congress authorized
 - The money is intended to compensate those that lost revenue or had increased expenses because of the coronavirus pandemic
- HHS said on Tuesday it was awarding pharmaceutical company AstraZeneca \$23.6 million to help the company develop an antibody treatment for the new coronavirus
 - The Biomedical Advanced Research and Development Authority and the Defense Advanced Research Projects Agency said they were helping AstraZeneca to get to a phase one clinical trial of its monoclonal antibody combination
 - The trial would test the antibody cocktail for safety in people

New Jersey (Social Media)

- *New Jersey on Tuesday lifted several restrictions, including a stay-at-home order*
 - *A senior state official signed an executive order lifting the stay-at-home rule, which had been issued on March 21*
 - *All outdoor recreational and entertainment businesses that were previously closed, except for amusement parks, water parks, and arcades, can reopen June 22*
 - *Effective immediately, indoor gatherings will be permitted to either 25 percent of a building's capacity or 50 people total,*
 - *The maximum capacity on outdoor gatherings was also raised to 100 people*
- *New Jersey has reported nearly 165,000 confirmed cases and about 12,303 deaths as of Monday night*

New York

- A senior official in New York City said the percentage of people citywide who tested positive for the coronavirus is at one percent on Tuesday, a record low
 - People admitted to hospitals for suspected coronavirus was at 52, while the daily number of people in intensive care units was at 337, as of Tuesday

Texas (Social Media)

- *Texas reported a record-breaking number of COVID-19 hospitalizations Monday as state officials plan to reopen more businesses and double capacity*
 - *Figures from the Texas Department of State Health Services show 1,935 people were admitted as hospital patients for COVID-19-related treatment on Monday*
 - *Throughout Texas, more than 75,000 people have been infected and more than 1,800 others have died from COVID-19, according to Johns Hopkins University*

Washington, D.C.

- Some Washington, D.C., National Guard troops have tested positive for the coronavirus after being deployed to the city to respond to its civil unrest, the U.S. military said on Tuesday
 - The National Guard said in a statement it would not reveal how many personnel had tested positive because of "operational security"
 - About 1,300 D.C. National Guard personnel were sent to the capital

Austria

- Austria will reopen its borders to Italy and more than 20 other European countries next week, officials said on Tuesday
 - Details of the decision will reportedly be finalized at a ministerial meeting on Wednesday

China

- Doctors in China began a human trial on Monday for an antibody treatment developed by Eli Lilly and Company and Chinese company Junshi Biosciences to fight the coronavirus
 - Eli Lilly will start a complementary phase one study in the United States in the next few days, the company said
 - Scientists will first test to see if this antibody treatment is safe to be used in humans

Guatemala

- Guatemala will once again accept deportation flights of its citizens from the United States beginning Tuesday, the Guatemalan foreign ministry reported
 - A Guatemalan official indicated that the planes would arrive from the United States on Tuesday and Thursday with small groups of approximately 50 people
 - Two additional flights are scheduled next week for June 15 and June 18
- The country had confirmed a total of 7,502 COVID-19 cases and 267 related deaths, according to Johns Hopkins University as of Tuesday morning

Mexico

- The coronavirus pandemic in Mexico is advancing toward its peak level of infections, but social distancing should continue until a vaccine is made available, World Health Organization (WHO) officials said on Tuesday
 - The officials stressed that more testing is needed in Mexico before further economic re-opening, and that gatherings in the country could cause a spike of new cases

Morocco

- The Moroccan government said on Tuesday it will start easing restrictive measures imposed to curb coronavirus infections but delay a full lifting of the state of emergency until July 10
- Morocco had confirmed 8,437 coronavirus cases, including 210 deaths, by Tuesday evening

Pakistan

- The WHO has recommended Pakistani authorities reimpose "intermittent lockdowns" of targeted areas, stating the country did not meet the global body's conditions for lifting restrictions
 - A surge of new cases has hit Pakistan after the government lifted its lockdown on May 9
- A total of 108,316 cases and 2,172 deaths, have been recorded, with Monday seeing a single-day record of 105 fatalities

South Korea (Social Media)

- *South Korea's Daewoong Pharmaceutical said its anti-parasitic drug niclosamide had eliminated COVID-19 from animals' lungs during testing*

If the CGIC receives something of interest, the CGIC could send it to the Civil Unrest Group for IIC support and SIOC reporting.

I think this would be a good way for us to support the mission of the SIOC.

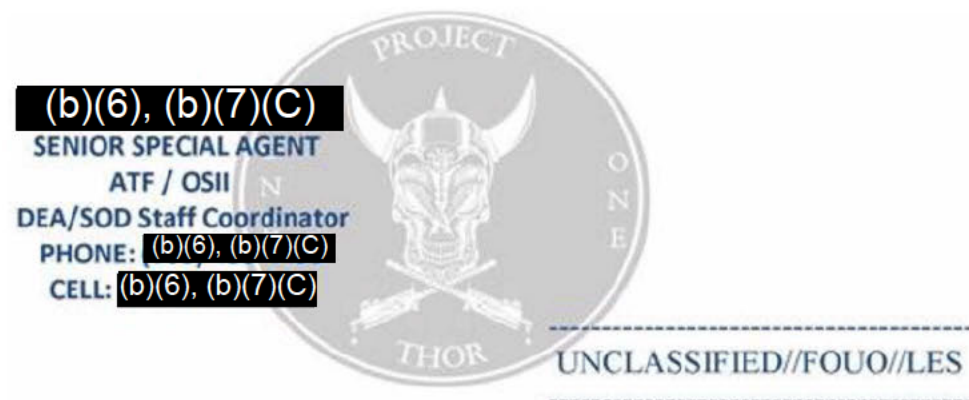

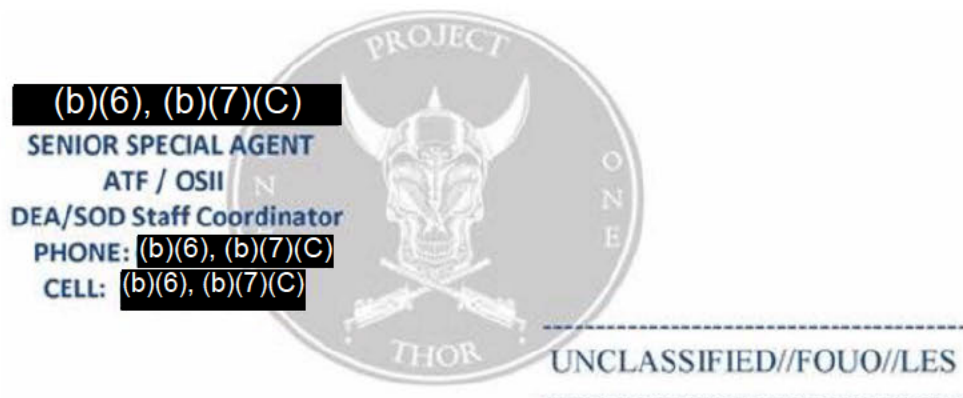

Kaepernick, Brees Trending in Opposite Directions Amid Black Lives Matter Protests

NFL fans were asked whether they have a favorable or unfavorable view of each player.

Recent Morning Consult polling shows that both New Orleans Saints quarterback Drew Brees and former San Francisco 49ers quarterback Colin Kaepernick have seen significant shifts in favorability among NFL fans in the wake of protests drawing attention to police brutality in Black communities.

Brees, who polled as the most popular skill position player among NFL fans after Super Bowl LIV in February, saw his net favorability drop from 73 to 41 percentage

points following a Yahoo interview in which he said NFL players were “disrespecting the flag” by kneeling during the national anthem.

The movement has benefited the perception of Kaepernick, the quarterback-turned-activist who started the kneeling movement back in 2016.

Week in Review

Facial recognition and surveillance

- Following similar decisions by Amazon.com Inc. and IBM Corp. in response to ongoing nationwide protests against police brutality and racism, Microsoft Corp. President Brad Smith said that the company [will not sell its facial recognition technology](#) to U.S. police departments until a national law is in place to regulate it. Smith also said the company is implementing "review factors" to help weigh whether the technology should be sold to other entities beyond law enforcement.
- A group of 35 lawmakers [sent a letter to the heads](#) of the Federal Bureau of Investigation, the Drug Enforcement Agency, Customs and Border Protection and the National Guard Bureau, urging them to stop relying on surveillance technology to monitor those peacefully protesting police brutality after the death of George Floyd. The letter, which was co-led by Reps. Anna Eshoo (D-Calif.) and Bobby Rush (D-Ill.), said the use of high-tech surveillance aircraft during protests is "significantly chilling the First Amendment rights of Americans."

Section 230

- The Trump administration has asked tech critic Sen. Josh Hawley (R-Mo.) to draft up new legislation [amending Section 230 of the Communications Decency Act](#) so that online platforms would lose their liability protections if they enforce their terms of services in an unequal or uneven way, according to a source familiar with the effort.
- Hawley, alongside Republican Sens. Marco Rubio (Fla.), Kelly Loeffler (Ga.) and Kevin Cramer (N.D.), [sent a letter to the Federal Communications Commission](#) asking the agency to "clearly" define the circumstances under which social media platforms should receive liability protections afforded by

Section 230 of the Communications Decency Act.

- Rep. Jan Schakowsky (D-Ill.), the chairwoman of the House's consumer protection subcommittee, said during a webinar with tech critics that lawmakers should [consider amending Section 230](#) so that online platforms such as Facebook Inc. have more liability for advertisements and other commercial speech on their sites. Schakowsky said in January that her staff was looking at ways to amend the law to push companies to moderate election misinformation, and a Democratic staff member familiar with the process said her staff is still on track to finalize a bill this summer.

Content moderation

- Presumptive Democratic presidential nominee Joe Biden's campaign released [an open letter calling on Facebook](#) to crack down on election misinformation and voter suppression efforts on the platform, saying in a tweet that leaving these unchecked puts "the very integrity of our elections at risk."
- New America's Open Technology Institute said it would [no longer accept funding from Facebook](#) after the social media platform declined to take action against President Donald Trump's "threatening" post about the nationwide protests against police brutality. OTI, a digital tech policy group in Washington, accepts funding from several major tech companies, but said Facebook has struggled for years "to implement content moderation policies that do not reinforce systems of racism."
- Facebook Chief Executive Mark Zuckerberg said he would [reconsider the content moderation policies](#) that led to the company allowing a controversial post from President Donald Trump to remain on the platform without any alterations. Zuckerberg's statement came after a week of employee unrest, including virtual walkouts and several resignations, due to the lack of action around Trump's posts.
- A report from New York University's Center for Business and Human Rights is [calling for social media networks](#) to end their dependence on third parties for content moderation work, arguing that the tactic has led to poor working conditions and enables social media companies to effectively outsource the responsibility for the safety of their platforms and users. The report recommends that large social media networks such as Facebook and Google's YouTube bring their content moderation teams in-house, expand content moderation to countries where online-fueled violence is likely and provide physical and mental health resources for moderators.

Antitrust and lobbying

- The European Commission is expected to file [formal antitrust charges against Amazon](#), according to people familiar with the matter, based partly on allegations that the company relied on data about the performance of products from third-party sellers to inform its own decisions about what to sell on the

platform.

- Amazon, Google and Facebook have all [become "partners" in the Connected Commerce Council](#) (3C), a Washington group representing small businesses that has started advocating on behalf of the large technology companies in an attempt to change the narrative that they are competition threats. The support comes as the three companies each face growing antitrust scrutiny on the federal and state level.

Telecommunications and wireless

- A [report from the Senate's Permanent Subcommittee on Investigations](#) states that officials at the Departments of Homeland Security, Justice and Defense "exercised minimal oversight" of the potential risks that three Chinese telecommunications companies posed to American communications networks, failed to follow up on some of the agreements designed to protect national security and did not provide enough workers to vet and supervise Chinese companies. The report, which focused on the response to China Unicom Americas, China Telecom Americas and ComNet (USA), could put pressure on the officials who make up Team Telecom to quickly cut ties with those companies.
 - The FCC proposed a record [\\$225 million fine against Texas-based health insurance telemarketers](#) who allegedly made roughly 1 billion illegal robocalls seeking to sell fake insurance plans while pretending to be companies such as Aetna, Blue Cross Blue Shield and Cigna.
 - The FCC [voted to approve procedures](#) so it can move forward with its Oct. 29 auction of \$16 billion for rural broadband service, which will also allow low-Earth-orbit satellite systems to participate. While the three Republican commissioners voted in favor of the plan, Democratic Commissioners Jessica Rosenworcel and Geoffrey Starks expressed concerns about doling out the funds before the agency completes an overhaul of its coverage maps.

Here is the spreadsheet as of yesterday afternoon 6/5/2020.

A couple of things for your consideration.

- One issue while working on the St. Paul tab is that the Agents (NRT) continually added place holder cases to NForce in real time so that I never could catch up although I did come close at one point. I anticipate during my work tomorrow that substantially more cases will be added. One person cannot equal the work efficiencies of an entire team.
- These place holder cases appear to be every building in St. Paul and Minneapolis with fire damage and/or smoke damage but the scene investigations were not completed or possibly even started. Yesterday, when I checked the cases originally notated on Thursday, a number of cases reported that those building fire scenes were due to fire extension from another fire or had only smoke damage with no signs of fire.

(b)(5) PER DPP

[(b)(6), (b)(7)(C)] assisted me by taking the lead with the LA, Phoenix, Dallas, Houston, Chicago and Philadelphia Field Divisions. He had a similar experience with the overwhelming number of cases in the Philadelphia Field Division. If we are to look at all field divisions, we need at least two more people for this task. This model does show promise since it does provide a high level look at the wide variety and numbers of fire damaged buildings in different parts of the country. It also gives a quick snap shot of the types of evidence that may be sent to the laboratory for analysis.

Lastly, an additional challenge was attempting to use Onedrive and One note in an attempt to make the spreadsheet available to both Matt and myself for simultaneous work. This challenge was not successfully met. A training session or help desk guidance on how to accomplish this will be necessary to make this an efficient process.
