### **Investigative Support Analytical Products:**

- USBDC completed a RFI (1) for the Kansas City Field Division requesting a report on the number of fire incidents entered into Bomb Arson Tracking System (BATS) by the Kansas City Missouri Fire Department for the period of 9 July 2018 – 9 July 2020. The detailed report provided information on all fire-related incidents reported into BATS, by fire category, incendiary fire type, property type and date/time of incidents. RFI/Report will provide an accurate assessment for the Kansas City Field Division on what type of fire-related incidents the Kansas City Missouri Fire Department is reporting in BATS during the requested time-period.
- USBDC completed a RFI (1) for the Tampa Field Division, regarding the type of improvised incendiary devices (IID) utilized during the civil unrest/rioting nationwide. Provided a PowerPoint presentation on current fire threats to include IIDs and Molotov cocktail utilized during the current civil unrest /rioting. Information provided will be utilized in an ATF briefing to law enforcement personnel in support of the upcoming Republican National Convention in Jacksonville, FL (24-27 August 2020).
- USBDC began working on the Thefts and Losses of Explosives in the United States – 2019 report.
- USBDC completed a review of the revised BATS/USBDC Lesson Plan for the ATF National Academy, Training Branch. The review ensured the revised Lesson Plan and the revised BATS presentation (April 2020) coincide with each other for the Special Agent Basic Training (SABT) curriculum.
- USBDC is working in conjunction with the Maryland Coordination and Analysis Center regarding a product centered around Homemade Explosives (HME) Labs. The target audience for this product

will be EMS Personnel and First Responders specifically to learn how to identify or determine the injuries associated with accidental HME lab explosions.

- USBDC participated in a joint call with Special Agents that assisted with the NRT response in St. Paul, Minneapolis. USBDC IRS's reached out to individual SA's to receive feedback on the information provided to assist with active explosive and arson cases. AAR comments were extremely positive; USBDC will utilize this information to provide the most accurate and detailed investigative support possible to support future A&E cases.
- USBDC participated in a teleconference with NETF and DHS/Tripwire regarding the Joint NETF quarterly to see how it can be improved as well as a discussion on incorporating OSINT data.
- USBDC completed two (2) ORI Verifications for new agency BATS application.
- USBDC is working to update the CONUS Explosive Trends & BATS/mBATS capabilities briefing with destructive devices recently encountered during the recent protests and civil unrest. This briefing is intended to inform state/local law enforcement, fire investigators, and bomb technicians of current trends, analysis, and intelligence products available in BATS as well as investigative support capabilities the USBDC can provide during active explosive or arson investigations.
- USBDC ETU was assisted by (b) (7)(E), who makes the M116A1 and M115A2 simulators, with providing SDS and Tech sheets to follow up with more information and finalize the request from ATF CES Franklin from Detroit with the information and technical data of Photoflash powder for the purposes of compatibility and storage requirements. An Interim Hazard Classification (IHC) needs to be assigned to enable the agent to safely store evidence and comply with DOD requirements per the DDSB. Provided the information requested for general photoflash properties.
- USBDC reviewed and distributed (b) (7)(E) each USBDC and EOD Tech Center advisories on EOD and Bomb Technician call-outs to All Bomb Squad Commanders and FVEY countries and has been posted to the Advisory Section in BATS. These products provide an awareness for the type of call-outs technicians are responding to and increases safety for the First Responder.
- USBDC distributed and posted the weekly Arson & Explosives Incident Advisories for the week ending on 10 July 2020.
- USBDC attended at briefing and consultation conference call with the Technical Support Working Group (TWSG) in reference to a project which has been contracted out to enable machine learning for IED components. This project is being developed primarily for Bomb Technicians, both Civilian and Military, for use on a boom camera for utilization on a robot to remotely identify IED components. This is phase one (crawl phase) proof of concept for the project. USBDC will be assisting TWSG by providing real world photos of components of IED's. This project also has the potential to eventually assist with the creation of a BATS and mBATS interface for the BATS database. USBDC will begin liaising to coordinate the logistics of how to provide data and maintain security and integrity of the images. More information to follow as the project is defined.
- USBDC continues to collaborate with the Naval EOD center Information Technology section to facilitate access on the JEOD DOD site via military CAC for research of ordnance items via their publications.

- USBDC continued to collaborate with the Explosives Industry Programs Branch on the modification of the ATF Form 5400.5 (Report of Theft/Loss of Explosive Materials).
- USBDC is currently developing a report focused on the use of Fire as a Weapon from both a historical and modern perspective. The report will evaluate the use of fire as a weapon as both a military and terrorism tactic.
- USBDC continues to work with EIPB to revise and update OMB 83-I (Report of theft or loss of explosives) in accordance with 27 CFR 555.30.
- USBDC assisted Little Rock, AR Field Division CFI's with BATS support to remove accidental duplicate BATS entries. USBDC provided similar BATS support to the Arson & Explosive Training Branch located at the National Center for Explosives Training and Research.
- USBDC assisted the West Palm Beach Police Department Criminal Investigations Division with BATS related troubleshooting/general BATS support.
- USBDC continues to field calls regarding new accounts/account recreations, BATS technical issues regarding external mapping and password resets.
- USBDC assisted Ventura County Fire Department (CA) with establishing a New Agency.
- USBDC assisted Fresno Fire Department (CA) with administrative changes to their BATS account.
- USBDC assisted Bowling Green Fire Department (OH) with establishing a New Agency account.
- USBDC assisted Buffalo Grove Fire Department (IL) with administrative changes to their BATS account.
- USBDC completed and tested the IFIX distribution lists and the eleven (11) newly created distribution lists are active and ready for use and the dissemination of information for IFIX.
- USBDC assisted Pennsylvania State Police (PA) with creation of a BATS account.
- USBDC assisted Tri-Lakes Monument FPD (CO) with their BATS account Reactivation.
- USBDC assisted Seattle Police Department (WA) with creation of a BATS account.
- USBDC continues to provide ongoing support to ATF Industry Operations Investigators (IOI) with compliance inspections by providing data on previously reported theft/loss of explosives and 2020 pyrotechnic theft and loss data.

### **BATS Applications:**

- BATS indicated (b) (7)(E) applications in the electronic Que. Of those (b) (7)(E) have been approved by the submitting agency BATS Account Manager and awaiting creation by ISSB. The remaining (b) (7)(E) show status as new. Of the (b) (7)(E) applications in new status, (b) (7)(E) remain in a system limbo and require ISSB follow-up. The oldest application created on 04/13/20 remains in a new status.

### **BATS Customer Service:**

- ServiceNow reports indicated thirteen (13) new incidents over the past week – eleven (11) assigned to BATS Tier II Support (ISSB) and zero (0) assigned to USBDC BATS Section. Of the thirteen (13) assigned to BATS Tier II (ISSB) support, ten (10) (77%) are resolved and three (3) (27%) are new, active or awaiting user information. Of the zero (0) assigned to USBDC BATS Section, zero (0) (0%) are resolved and zero (0) (100%) are new, active or awaiting user information.
- ServiceNow reports increased to seventeen (17) incidents assigned to BATS Tier II Support (ISSB) that remain new, active or awaiting user information. This decreased from the last report, fifteen (15). The oldest incident, created on 01/22/19, ISSB last documented work on 02/13/20. The oldest documented work by ISSB occurred on 01/22/19 (over 7-months of no reported work). Four (4) incidents remain in a “new” state and not assigned to a person, the oldest created on 03/04/20 (more than four month).
- ServiceNow reports indicated zero (0) incidents assigned to USBDC BATS Section that remain new, active or awaiting user information. This was no change from the last report, zero (0).

### **BATS Program Enhancements:**

- VersionOne reports thirty-nine (39) enhancements in backlog status within the BATS Kanban project. One (1) enhancement has been added from the last report. No backlog item completed since March 28, 2018 (start of tracking).

### **BATS Program Promotion and Training:**

- No formal BATS promotion or training during this reporting period.
