A little back story is he is the lead investigative journalist for the Heritage Foundation with a goal of providing government visibility. His example was; the FBI wanting a new huge building for staff whenever COVID era data justified them utilizing TW with a much smaller footprint. His efforts pinpoint whistleblowers. The requests he sent were sent to multiple agencies in a "templated" format effort.

Two big take aways:

- Aamot is good with withdrawing request for OIG investigations and pursuing logs.
- Aamot is fine with scoping down his timelines to records that only fall under the "DCSA era" and not before creation of DCSA.
