Subject: Freedom of Information/Privacy Act Request [25-OIG-420]

Dear Lama Elsharif:

This is in response to your Freedom of Information Act request to the Department of Justice - Justice Management Division (JMD). The JMD referred one document to the Office of the Inspector General (OIG) that was responsive to your request. Specifically, your request seeks "records sufficient to identify the name, title, and position of all DOJ officials with delegated authority to initiate or implement terminations, suspensions, reductions in force, demotions, transfers, adverse actions, or any other similar personnel actions".

The document responsive to your request has been reviewed. It has been determined that certain portions of such document be excised pursuant to the Freedom of Information Act, 5 U.S.C. §552(b)(6),

- 5 U.S.C. § 552(b)(6), protects personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;

Please be advised that the OIG considered the foreseeable harm standard of the FOIA Improvement Act of 2016 when reviewing the responsive records and applying the appropriate FOIA exemptions. Consequently, please find enclosed that information which can be released pursuant to your request. We consider this response as closing your request with the OIG.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552 (2012 & Supp. V 2017). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you are not satisfied with OIG's determination in response to this request, you may administratively appeal by writing to the Director, Office of Information Policy (OIP), United States Department of Justice, 441 G Street, NW, 6th Floor, Washington, D.C. 20530, or you may submit an appeal through OIP's FOIA STAR portal by creating an account following the instructions on OIP's website: <https://www.justice.gov/oip/submit-and-track-request-or-appeal>. Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal." If possible, please provide a copy of your original request and this response letter with your appeal.
