Dear Department of Education FOIA Manager:

We are in receipt of your email dated December 20, 2024. While CREW believes this FOIA request is reasonable and satisfies both FOIA and applicable federal regulations, in the interest of time and efficiency, we are providing more information to you in response to your email.

In response to your request that we provide "email addresses of the parties" referenced in our request who are not ED personnel, sufficient information to do so is not publicly available, but we believe that our request provides sufficient information for your office to practically and reasonably search for records. With regard to additional individuals who are not named but "represent, work for, or communicate on behalf of" the persons and groups named in the request, CREW's request can be limited to a search for responsive documents involving those who have represented to ED that they "represent, work for, or communicate on behalf of" those persons and groups. We further note that with respect to searches for communications with Senator Ernst and her office, each of her staffers' email address domains is @ernst.senate.gov.

We do note, however, that the "communications" we seek are not limited to emails or documents transmitted by email; rather, the term "communications" includes emails, notes and transcripts of calls, voicemails and voicemail transcriptions, text messages, messages on signal and other applications, faxes, letters, and other media used by ED to record its communications.
