further requests that it not be charged search or review fees for this request pursuant to 5 U.S.C. 8552(a)(4)(4)(4)(1)(1) because
CREW qualifies as a member of the news media. See Nat'l Sec.
Archive v. U.S. Dep't of Defense 880 F.2d 1381 1386 (D.C. Cir.
1985) (holding non-profit a "representative of the news media"
and broadly interpreting the term to include "any person or
organization which regularly publishes or disseminates information to the public"). CREW routinely disseminates
information obtained through FOIA to the public in several wave.
For example CREW's website receives hundreds of thousands
of page views every month. The website includes blogposts that
report on and analyze newsworthy developments regarding
government ethics: corruption and money in postics: as well as numerous reports CREW has published to educate the public
about these issues. These reports frequently rely on government
records obtained through FOIA. CREW also posts the documents
