Just saw your article <u>here</u> and thought it might be helpful to send some information about Friday's First Appearance hearing to potentially share the other side of the story. I've also sent this info to Greg and Jozsef.

The judge granted bond based upon all of the facts that he heard in the case.

The State discussed evidence of:

WHAT THEY DO: Organizing and supporting non-profits and protests. For example, non-profits include food for the hungry and a bail fund. The protests include demonstrating after the murder of George Floyd. While all of this is going on, they are also conducting unlawful activity by supporting violence and property damage.

July 5, 2020 – Demonstrations regarding the George Floyd murder. During peaceful demonstrations, a small group broke off and attacked DPS headquarters, culminating with a Molotov cocktail being thrown into the building and two people going to the hospital. The individual arrested and a person with him have financially and operationally been connected to this group.

July 3, 2022 – 10 people were walking down the road in all black. They approached Ebenezer Baptist Church, vandalized the church, and left. They split into two groups, changed into normal clothing, and removed their masks. The individuals who did this are members of the Defend the Forest group.

January 29, 2023 – A protest was organized by this group to mourn the death of a person who was shot and killed by GSP. They encouraged everyone to wear black in mourning. When the protest reached near 191 Peachtree, numerous individuals started rioting. They set an APD vehicle on fire, damaged buildings, shot mortar style fireworks into crowds, and one individual was attempting to break into a skyscraper at 191 Peachtree. He had accelerant and a lighter. Him, and the other 5 arrested, have been tied to this group financially. A recorded phone call with the man arrested with accelerant complained that too many peaceful people have joined Defend the Forest.

March 5, 2023 – These individuals organized a concert in the DeKalb County forest. They publicized it as a concert. Unbeknownst to many concern goers, a group of 100-150 individuals broke off, dressed in all black, and carried shields, weapons, and riot gear and began marching through the woods approximately ¾ of a mile. They attacked police officers who were forced to retreat because they were outnumbered 10:1. The group set fire to equipment and attempted to set fire to footing

that holds up power lines. After burning everything in sight, the group went back to the field, changed clothes, and attempted to blend into the peaceful concert goers.

Numerous other acts:

- Posted information about judges and police officers online along with personal information
- Have gone to the houses of court officials

HOW DO WE KNOW:

1. Finances show us this. The Network for Strong Communities uses a financial accounting platform that records some of their transactions.

Unbeknownst to people donating to the bail fund, food fund, and other laudable funds, another fund was established known as the Forest Justice Defense Fund. Some of the funds that were donated for legitimate purposes were routed to the Forest Justice Defense Fund. The Forest fund has been used to support those occupying the forest, doing violence against others property – and we can see that in the finances. Over \$237,000 has been spent supporting the occupation of the DeKalb Woods and the violent acts surrounding it. This \$237,000 is controlled by the three defendants.

The bail fund is also used as retention. Arrested protestors: if you don't align yourself with us, we will withdraw all financial support.

- 2. Search warrants corroborate this. Search warrant revealed extremist writings, justification of violence against people, government, property, and religious officials.
- 3. And the documents aren't new. Law enforcement conducted trash pulls for a long time. Numerous pieces of evidence were collected that demonstrate that they are running the Defend the Forest operation, but one in particular stands out, and it is a diary: "Radicalize liberals with subversive materials without using state solutions."

I'm sharing this information from DHS as it relates to their definition of Domestic Violent Extremism:

"We use the term domestic violent extremism to refer to the conduct of groups or individuals in the United States who seek to advance their ideological goals through the unlawful use of violence and the term domestic violent extremist to refer generally to individuals based and operating primarily in the United States or its territories without direction or inspiration from a foreign terrorist group or other foreign power who seeks to further social or political goals, wholly or in part, through unlawful acts of force or violence".

To follow up on that definition, as included in the warrants:

[The Defend the Atlanta Forest] group has publicly claimed responsibility for numerous acts while stating their intent was to intimidate employees of the government and private companies into not accepting or completing tasks in and around the site of the Atlanta Police Training Center. These acts have Included vandalism at offices and private residences; throwing Molotov cocktails, rocks, and fireworks at uniformed police officers; arson of public buildings, heavy equipment, private buildings, and private vehicles; shooting metal ball bearings at contractors; discharging firearms at critical infrastructure; preventing access to private land; and several other violations of law. These claims of responsibility have been made on websites, social media, and graffiti "tagging".

And, again, here's the state's Domestic Terrorism statute, of which 40+ people have been charged:

16-11-220. Definitions.

As used in this article, the term:

- (1) "Critical infrastructure" means publicly or privately owned facilities, systems, functions, or assets, whether physical or virtual, providing or distributing services for the benefit of the public, including, but not limited to, energy, fuel, water, agriculture, health care, finance, or communication.
- (2) "Domestic terrorism" means any felony violation of, or attempt to commit a felony violation of the laws of this state which, as part of a single unlawful act or a series of unlawful acts which are interrelated by distinguishing characteristics, is intended to cause serious bodily harm, kill any individual or group of individuals, or disable or destroy critical infrastructure, a state or government facility, or a public transportation system when such disability or destruction results in major

economic loss, and is intended to:

- (A) Intimidate the civilian population of this state or any of its political subdivisions;
- (B) Alter, change, or coerce the policy of the government of this state or any of its political subdivisions by intimidation or coercion; or
- (C) Affect the conduct of the government of this state or any of its political subdivisions by use of destructive devices, assassination, or kidnapping.
- (3) "Public transportation system" means all facilities, conveyances, and instrumentalities, whether publicly or privately owned, that are used in or for publicly available services for the transportation of individuals or cargo.
- (4) "Serious bodily harm" means harm to the body of another by depriving him or her of a member of his or her body, by rendering a member of his or her body useless, or by seriously disfiguring his or her body or a member thereof.
- (5) "State or government facility" means any permanent or temporary facility or conveyance that is used or occupied by representatives of this state or any of its political subdivisions, by the legislature, by the judiciary, or by officials or employees of this state or any of its political subdivisions.

I would think, at the very least, sharing DHS's definition of Domestic Violent Extremism does fit within the scope of this article.

Finally, if it helps, here's the full statement we just shared on social:

"The arrests made last week are about the violence that occurred at the site of the future Atlanta Public Safety Training Center and other locations. Our office will continue to defend the First Amendment right to peacefully protest. However, acts of violence to person or property will not be tolerated. This includes shooting police officers, throwing Molotov cocktails at law enforcement, vandalizing private homes and businesses, and setting fire to police vehicles or offices. The Georgia statute defines Domestic Terrorism, and we will not hesitate to uphold the law. In this case, as with all others, we are guided by the facts, and we will continue to use all resources at our disposal to keep the people of our state safe."

Thank you for making that update.

That said, I have to assume that this article was written to coincide with the Senator's letter to DHS. I only say this because, seeing as the very Senator who wrote that letter is the pastor of the church mentioned in Friday's hearing, this item in particular seems to be very relevant – particularly

because it has yet to be mentioned once by the AJC since Friday's hearing. Never before had that information been shared by the State.

Rather than focusing on some of the alleged acts of violence presented by the State or, more so, rather than mentioning them at all, there is an entire article dedicated to the DHS designation. Both of our Senators also got an entire article dedicated to their tweets on the subject: https://www.ajc.com/politics/georgias-us-senators-raise-concerns-about-arrests-of-bail-fund-organizers/BCZ7FO2H3VCYNKQIMJLDUQR2HU/. The bail fund is also used as retention. Arrested protestors: if you don't align yourself with us, we will withdraw all financial support.

Each of their arrest warrants had a sentence tying their charity to extremism, saying it raised money to "fund in part the actions of Defend the Atlanta Forest, a group classified by the United States Department of Homeland Security as Domestic Violent Extremists." The warrant also reads as follows:

Said group has publicly claimed responsibility for numerous acts while stating their intent was to intimidate employees of the government and private companies into not accepting or completing tasks in and around the site of the Atlanta Police Training Center. These acts have Included vandalism at offices and private residences; throwing Molotov cocktails, rocks, and fireworks at uniformed police officers; arson of public buildings, heavy equipment, private buildings, and private vehicles; shooting metal ball bearings at contractors; discharging firearms at critical responsibility have been made on websites, social media, and graffiti "tagging".

We are not asking for an entire article dedicated to information shared by the State. Instead, we are simply asking that as much attention be paid to some of the **evidence** discussed by the other side – even a couple of sentences in a story would be progress at this point.

I would kindly ask that you please correct this item in your article, since the AG has not "condemned the protests" – as his immediate statement thereafter makes clear (which I see you have cut down since the first publication of this story).

"Our office will continue to defend the First Amendment right to peacefully protest," Carr said.
"However, we will not tolerate acts of violence to person or property. Along with our law enforcement partners, we will not hesitate to hold accountable those who violate our laws including, where appropriate, bringing charges of domestic terrorism that carry a maximum sentence of up to 35 years in prison."

The AG has criticized rioters and "acts of violence to person or property."

I recommended you reach out to the GBI regarding the warrants, because its *arrest* warrants. But that is also why we tried to provide extensive information regarding the alleged violent acts involving the Defend the Atlanta Forest group.

Fourth: Our Chief of Staff and lead prosecutor had a 50-minute conversation with Senator Warnock's Chief of Staff, during which we shared extensive background information regarding this case overall. This conversation took place on Sunday morning, prior to the release of the Senator's statement.

Over \$237,000 has been spent supporting the occupation of the DeKalb Woods and the violent acts surrounding it. This \$237,000 is controlled by the three defendants.

The bail fund is also used as retention. Arrested protestors: if you don't align yourself with us, we will withdraw all financial support.

- 2. Search warrants corroborate this. Search warrant revealed extremist writings, justification of violence against people, government, property, and religious officials.
- 3. And the documents aren't new. Law enforcement conducted trash pulls for a long time. Numerous pieces of evidence were collected that demonstrate that they are running the Defend the Forest operation, but one in particular stands out, and it is a diary: "Radicalize liberals with subversive materials without using state solutions."
