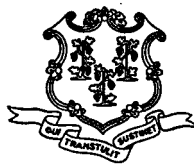

BUSINESS FROM THE SENATE

COMMUNICATIONS FROM THE GOVERNOR.

The following communication, from His Excellency the Governor, was received from the Senate, having been read, ordered printed in the Journal, and accompanying report referred to the committee on the Judiciary:

State of Connecticut,

Executive Chambers,

Hartford, April 1, 1947.

To the Honorable General Assembly:

I have the honor to transmit herewith for your consideration a certified copy of a resolution of Congress entitled "Joint Resolu-

tion Proposing an Amendment to the Constitution of the United States Relating to the Terms of Office of the President", passed during the first session of the Eightieth Congress of the United States, begun and held at the City of Washington on Friday, the third day of January, one thousand nine hundred and forty-seven.

COMMITTEE RESOLUTION

The following resolution raised by the committee indicated was received from the Senate, read and referred to said committee in concurrence:

Judiciary. Senate Joint Resolution No. 167. A resolution continuing the committee established to study the operation and expenses of the state government.

DISAGREEING ACTION

House Bill No. 331. (See House Journal, March 20th.) The report of the committee on Banks, on a bill entitled "An Act concerning Compensation of Trustees, Directors, Officers and Employees of Savings Banks," was received from the Senate, the bill having been amended by House amendment schedule "A" and Senate amendments schedules "B" and "C" and passed, and the report of the committee accepted.

The House had previously amended by House amendment schedule "A" and passed the bill.

On motion of Mr. Wake of Westport, the House reconsidered its former action and voted to concur in the action of the Senate.

The amendments were then adopted.

The bill was then passed as amended, by House amendment schedule "A" and Senate amendments schedules "B" and "C", and the report of the committee accepted, in concurrence.

The following are the amendments:

Schedule "A"

Add at the end of line 24 the words "or any committee thereof".

Schedule "B"

In line 22, strike out the words "executive officers".

Insert in lieu thereof, the following, viz.: "salaried officers or employees".

Schedule "C"

In line 24, add the words "or any committee meetings thereof".
