**BY EDUCATION AND EDUCATIONAL INSTITUTIONS
COMMITTEE**

Entitled, "An Act relating to school district libraries; amending Section 33-2602, Idaho Code, by deleting reference to incorporated town or village and population status as requirements for establishment of a library by a school district in which no public library
