A CONCURRENT JOINT RESOLUTION

RATIFYING THE PROPOSED AMENDMENT TO THE CON-
STITUTION OF THE UNITED STATES AND KNOWN
AS THE 22ND AMENDMENT TO THE CONSTITUTION
OF THE UNITED STATES RELATING TO THE TERMS
OF OFFICE OF THE PRESIDENT.

- 1 WHEREAS, the House of Representatives on February 6th,
- 2 1947, and the United States Senate on March 12th, 1947, both by
- 3 the constitutional two-thirds therefore passed a proposed constitu-
- 4 tional amendment to be known as the 22nd Amendment to the
- 5 Constitution, and
- 6 WHEREAS, said proposed Amendment was submitted to the

1 States for Ratification upon March 26th, 1947, and said proposed
 2 Amendment to the Constitution of the United States of America,
 3 is in the following words, to wit:

4 "Section 1. No person shall be elected to the office of the
 5 President more than twice, and no person who has held the office
 6 of President, or acted as President, for more than two years of a
 7 term to which some other person was elected President shall be
 8 elected to the office of President more than once. But this Article
 9 shall not apply to any person holding the office of President when
 10 this Article was proposed by the Congress, and shall not prevent
 11 any person who may be holding the office of President, or acting
 12 as President, during the term within which this Article becomes
 13 operative from holding the office of President or acting as President
 14 during the remainder of such term.

15 "Section 2. This Article shall be inoperative unless it shall
 16 have been ratified as an amendment to the Constitution by the
 17 legislatures of three-fourths of the several States within seven years
 18 from the date of its submission to the States by the Congress."

19 BE IT RESOLVED BY THE SENATE OF THE STATE OF
 20 NEW MEXICO, THE HOUSE OF REPRESENTATIVES
 21 CONCURRING:

22 That the proposed Amendment No. 22 to the Constitution of
 23 the United States of America be and the same is hereby ratified
 24 by the Legislature of the State of New Mexico,

25 BE IT FURTHER RESOLVED, that certified copies of the
 26 foregoing preamble and Resolution be immediately forwarded by
 27 the Secretary of State of the State of New Mexico, under the Great
 28 Seal, to the President of the United States, the President of the
 29 Senate of the United States, and the Speaker of the House of Rep-
 30 resentatives of the United States.
