170 members have completed initial and ongoing training to maintain eligibility and readiness for activation. The Florida State Guard (FSG) continues to coordinate mission logistics with the Texas Department of Public Safety through and alongside Florida's statewide tasking agency, the Florida Division of Emergency Management. We remain postured to activate the appropriate lines of communication with our volunteer members to deliver rapid response to our Florida and Texas state partners.

Thank you for reaching out regarding the Florida State Guard's (FSG) direct support and assistance in addressing the Texas border crisis. This historic mission marks the FSG's first out-of-state deployment through the Emergency Management Assistance Compact (EMAC), as authorized by Florida law.

FSG is working with the Florida Division of Emergency Management (FDEM) who is coordinating with the Texas Department of Public Safety to identify areas where they will need additional manpower. FDEM is actively coordinating with Texas DPS to identify where the state guard can best fill needs. For questions regarding the EMAC process, please contact the statewide coordinating agency, FDEM.
