Re: <u>Congressional Investigation of Potential Violations of the Anti-Deficiency Act</u>
<u>During the Fiscal Year 2026 Lapse in Appropriations</u>

Dear Leader Thune, Minority Leader Schumer, Speaker Johnson, and Minority Leader Ieffries.

On behalf of Citizens for Responsibility and Ethics in Washington (CREW), a nonpartisan nonprofit organization dedicated to promoting accountable government, we strongly urge you to support congressional investigations of potential violations of the Anti-Deficiency Act related to the use of appropriated funds for partisan purposes during the course of the fiscal year 2026 government shutdown. Current federal law requires that government programs must be operated separate and apart from any partisan activity and imposes restrictions on the use of appropriated funds for partisan purposes. But during the lapse in appropriations, federal agencies nonetheless engaged in partisan messaging, including the following examples:

• <u>Use of website banners announcing shutdown:</u> Numerous federal agencies added notification banners to their agency homepages and websites that used info@citizensforethics.org 202.408.5565 CITIZENSFORETHICS.ORG

partisan language to pejoratively characterize the appropriations process. The Department of Housing and Urban Development posted a full-page message on the final day of funding, stating "The Radical Left are going to shut down the government and inflict massive pain on the American people unless they get their \$1.5 trillion wish list of demands. The Trump administration wants to keep the government open for the American people." During the course of the shutdown, other agencies' websites maintained similarly partisan messaging, including "Democrats have shut down the government";2 "Senate Democrats have voted 14 times against reopening the government. This compromises not only SNAP, but farm programs, food inspection, animal and plant disease protection, rural development, and protecting federal lands. Senate Democrats are withholding services to the American people in exchange for healthcare for illegals, gender mutilation, and other unknown 'leverage' points";3 "Senate Democrats voted to block a clean federal funding bill (H.R. 5371), leading to a government shutdown that is preventing the U.S. Small Business Administration (SBA) from serving America's 36 million small businesses. Every day that Senate Democrats continue to oppose a clean funding bill, they are stopping an estimated 320 small businesses from accessing \$170 million in SBA-guaranteed funding."4

- <u>Use of federal resources to create partisan advertisements:</u> The Department of Homeland Security created a video featuring Secretary Kristi Noem to be played during the shutdown in airports where the Transportation Security Administration operates. Secretary Noem tells travelers, in part, "Democrats in Congress refuse to fund the federal government and because of this, many of our operations are impacted."
- <u>Cabinet officials' statements:</u> Cabinet secretaries made public statements in their official capacities blaming Democrats and directing their respective audiences to contact Congress regarding legislative action. During a televised interview, Secretary of Transportation Sean Duffy, referring to onscreen images of flight schedules illustrating the extent of delays, instructed viewers, "If you are delayed, if you are cancelled, there is only one mission that you have. Call [Senate Minority Leader] Chuck Schumer, and call your senator and

tell them to open up the government."<sup>7</sup> Separately, Secretary of the Interior Doug Burgum posted on his official X account, "It's time to end this foolish shutdown! Call Congressional Democrats today and demand they do their job and fund the government."<sup>8</sup>

White House website parodying congressional Democrats' shutdown positions:
 A White House website, "mysafespace," featured altered photographs of congressional Democratic leaders and a simulated social media website with fabricated messages characterizing Democrats' alleged support for the shutdown.9

Congressional investigation into the agency actions described above, and any similar examples that come to light, will reinforce the Congress's intention to keep partisan politics out of the administration of federal programs. Congress' attention to this issue is a critical exercise of its constitutional authority to conduct oversight into the misuse of taxpayer dollars by the executive branch.

## The Anti-Deficiency Act Prohibits the Use of Federal Funds for Partisan Purposes

During a lapse in appropriations, a permanent appropriations restriction known as the Anti-Deficiency Act provides guardrails against the misuse of taxpayer funds. <sup>10</sup> During the lapse, agencies are required under the statute to stop operations, which reflects the constitutional requirement that "[n]o Money shall be drawn from the Treasury, but in Consequence of Appropriations made by Law"<sup>11</sup> and "protects Congress's power over federal spending by preventing the executive branch from operating without funding."<sup>12</sup>

The Anti-Deficiency Act effectively prohibits federal employees from making or authorizing obligations or expenditures without an appropriation from Congress and imposes administrative and potential criminal penalties on officials who violate it.<sup>13</sup> Without an appropriation from Congress, an agency can incur obligations only if one of the Anti-Deficiency Act's narrow exceptions—such as responding to emergencies that "imminently threaten the safety of human life or the protection of property"—allows the agency to do so.<sup>14</sup>

Because no funds are available for agency activities—and, for that matter, partisan political messaging—during a shutdown, an agency would need to identify an Anti-Deficiency Act exception that permitted the activities described above. For example, the USDA would need to justify which strictly circumscribed Anti-Deficiency Act exception permitted its officials to post both about the "Radical Left Democrat shutdown" and, later, to update that message to state that "Senate Democrats have voted 14 times against reopening the government" and "are withholding services to the American people." CREW cannot identify any such Anti-Deficiency Act exception that would permit these activities.

As a permanent restriction on federal appropriations, federal agencies and officials are broadly aware of the Anti-Deficiency Act requirements and the nature of limited program operations during a shutdown. A lapse in appropriations inherently limits those agencies and officials from continuing previously authorized activities without meeting an exception of the Anti-Deficiency Act. Put another way, because of the Anti-Deficiency Act, the authorized activities of federal agencies and officials are *restricted* during a lapse in congressional appropriations; they are certainly not *expanded* to include partisan messaging activities that have been barred under appropriations bills for most of the past 75 years.<sup>16</sup>

## Conclusion

Congress must act as a necessary check on executive power so that executive branch agencies are not permitted to circumvent Congress's authority to manage its power of the purse during a lapse in appropriations. A shutdown cannot translate into an opportunity to skirt the rule of law without recourse. It is therefore imperative for Congress to initiate a congressional investigation into the misuse of taxpayer dollars during a government shutdown to advance partisan messages in violation of the Anti-Deficiency Act.

Congress has historically and consistently included governmentwide restrictions on the use of appropriated funds for "publicity or propaganda" when enacting annual appropriations legislation, using effectively the same language for the better part of a century. *Id.* The legislation enacted to end the fiscal year 2026 shutdown carried forward the restriction included in previous appropriations bills, and also provided that previous conditions "shall be considered to have begun on October 1, 2025." *See* Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act, 2026, Pub.
