Re: Freedom of Information Act Request

Dear FOIA Coordinator,

Citizens for Responsibility and Ethics in Washington (“CREW”) makes this request for records pursuant to the Michigan Freedom of Information Act (“FOIA”), MCL § 15.231 et seq., to the Michigan Department of Environmental Quality (“DEQ”).

Specifically, CREW requests copies of any and all communications, from January 1, 2017 to the present, sent to or from Director Heidi Gartner; Chief Deputy Director Aaron Keatley; Senior Advisor Timothy O’Brien; and Director’s Assistant Mary Beth Thelen::

- (1) With any persons or groups representing Nestlé USA, Nestlé Waters, or Nestlé Waters North America, Inc., especially those using the email handles @us.nestle.com or @waters.nestle.com in their electronic communications;
- (2) Where the key terms “Nestlé” or “Nestlé”; “White Pine Springs” or “WPS”; “Pine Springs”; “PW-101”, “PW 101”; “Permit 1701” or “1701” appear.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails (to include cc or bcc), text messages, social media messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to emails and other records. **However, please do NOT include copies of newspaper articles or other media clippings in your search as-part-of or response to this records request.**

If there are any fees for searching or copying these records, CREW requests that such fees be waived because the requested information is in the public interest and will contribute to the public’s understanding of how corporations and special interests interact with state government officials, especially when facing great public opposition to their operations. CREW does not seek the requested documents for commercial purposes. If a waiver is not granted, please inform me if the cost will exceed \$50.


