**Re: Freedom of Information Act Request**

Dear FOIA Officer:

Citizens for Responsibility and Ethics in Washington (“CREW”) makes this request for records pursuant to the Freedom of Information Act (“FOIA”), 5 U.S.C. § 552, and U.S. Department of Housing and Urban Development (“HUD”) regulations.

First, CREW requests records of all formal or informal administrative and/or personnel actions taken or proposed with respect to Suzanne Israel Tufts, who has been serving as an assistant secretary for administration, from December 2017 to the present.

Second, CREW requests records sufficient to show Ms. Tufts’ pay status from December 2017 to the present, including but not limited to any periods during which Ms. Tufts was placed on administrative leave.

Third, CREW requests all communications within the Office of Administration, including but not limited to the Office of the Chief Human Capital Officer, concerning or reflecting (1) any complaints about Ms. Tufts, and/or (2) Ms. Tufts’ selection as acting inspector general at the Interior Department.

Fourth, CREW requests all communications to or from Chief of Staff Andrew Hughes concerning or reflecting (1) any complaints about Ms. Tufts, and/or (2) Ms. Tufts’ selection as acting inspector general at the Interior Department.

Fifth, CREW requests all communications to or from Deputy Chief of Staff for Operations Drew McCall concerning or reflecting (1) any complaints about Ms. Tufts, and/or (2) Ms. Tufts’ selection as acting inspector general at the Interior Department.

Sixth, CREW requests all communications to or from the Office of the General Counsel concerning or reflecting (1) any complaints about Ms. Tufts, and/or (2) Ms. Tufts’ selection as acting inspector general at the Interior Department.

Seventh, CREW requests all communications to or from the Office of the Deputy Secretary concerning or reflecting (1) any complaints about Ms. Tufts, and/or (2) Ms. Tufts’ selection as acting inspector general at the Interior Department.

Eighth, CREW requests all communications to or from the Office of Administration, including but not limited to the Office of the Chief Human Capital Officer, and anyone at the Interior Department, including but not limited to Interior's Office of the Inspector General, concerning Ms. Tufts' selection as acting inspector general.

Ninth, CREW requests all communications to or from the Chief of Staff and anyone at the Interior Department, including but not limited to Interior's Office of the Inspector General, concerning Ms. Tufts' selection as acting inspector general.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to emails and other records, as well as those who were cc'ed or bcc'ed on any emails.

### **Fee Waiver Request**

In accordance with 5 U.S.C. § 552(a)(4)(A) and HUD regulations, CREW requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures likely will contribute to a better understanding of relevant government procedures by CREW and the general public in a significant way. *See* 5 U.S.C. § 552(a)(4)(A)(iii). Moreover, the request primarily and fundamentally is for non-commercial purposes. *See, e.g., McClellan Ecological v. Carlucci*, 835 F.2d 1282, 1285 (9th Cir. 1987).

Days ago, it was announced that HUD Assistant Secretary for Administration Suzanne Israel Tufts was being moved to the Interior Department to serve as the acting inspector general.<sup>1</sup> This appointment has raised concerns given the fact that Ms. Tufts is a political appointee being assigned to an independent oversight position in what the *Washington Post* has described as "one of the government's most active watchdog offices."<sup>2</sup> This appointment comes at a time when Interior Secretary Ryan Zinke is under active investigation on numerous fronts by his agency's inspector general.<sup>3</sup> Reportedly Ms. Tufts has no background in either government investigations or Interior Department policies and regulations.<sup>4</sup>

Ms. Tufts' appointment raises serious and significant questions about whether it was made to influence the outcome of pending investigations of Secretary Zinke. The public has a particularly strong interest in Ms. Tufts' qualifications for this position and whether her actions at HUD raise questions about her temperament and suitability to serve as acting inspector general, a position that requires independence and the highest level of professionalism. This interest unquestionably outweighs any privacy interests Ms. Tufts may have in details about any adverse personnel actions that may have been taken or proposed against her, or complaints that others at HUD may have raised about Ms. Tufts' conduct.

CREW is a non-profit corporation, organized under section 501(c)(3) of the Internal Revenue Code. CREW is committed to protecting the public's right to be aware of the activities of government officials, to ensuring the integrity of those officials, and to highlighting and working to reduce the influence of money on politics. CREW uses a combination of research, litigation, and advocacy to advance its mission. CREW intends to analyze the information responsive to this request and to share its analysis with the public through reports, press releases, or other means. In addition, CREW will disseminate any documents it acquires from this request to the public through its website, [www.citizensforethics.org](http://www.citizensforethics.org). The release of information obtained through this request is not in CREW's financial interest.

CREW further requests that it not be charged search or review fees for this request pursuant to 5 U.S.C. § 552(a)(4)(A)(ii)(II) because CREW qualifies as a member of the news media. *See Nat'l Sec. Archive v. U.S. Dep't of Defense*, 880 F.2d 1381, 1386 (D.C. Cir. 1989) (holding non-profit a "representative of the news media" and broadly interpreting the term to include "any person or organization which regularly publishes or disseminates information to the public").

CREW routinely and systematically disseminates information to the public in several ways. CREW's website receives tens of thousands of page views every month. The website includes a blog that reports on and analyzes newsworthy developments regarding government ethics, corruption, and money in politics, as well as numerous reports CREW has published to educate the public about these issues. In addition, CREW posts the documents it receives under the FOIA on its website, which has been visited hundreds of thousands of times.

Under these circumstances, CREW satisfies fully the criteria for a fee waiver.
