This responds to your Freedom of Information Act (FOIA) request, dated and received in this Office on June 7, 2019, seeking calendar entries of Attorney General William Barr pertaining to any appointment with U.S. Attorney for the District of Connecticut John Durham. This response is made on behalf of the Office of the Attorney General.

Please be advised that a search has been conducted and records responsive to your request have been located. I have determined that six pages containing records responsive to your request are appropriate for release with excisions made pursuant to Exemptions 6 and 7(A) of the FOIA, 5 U.S.C. § 552(b)(6) and (b)(7)(A). Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7(A) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to interfere with enforcement proceedings.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
