Look for more on this soon—we'll need your help to develop and keep it up to date. Meanwhile, your directors and deputies can help you keep track of our ever-changing process.)
- Ed updated the group on COVID-19 information from the EPA. Among these updates, directors and deputies are seeking out excess Personal Protective Equipment in OA&E that we could donate to FEMA for their response activities. If you see a request on this, please respond as quickly as you can.

- OA&E provided an update that you all are providing us with COVID-19-related assignment suggestions. Keep them coming. We discussed whether **Ex. 5 Deliberative Process (DP)**

- Chuck asked that we remember to either send read-ahead docs before meetings with him, or attach existing documents to meeting invitations to keep it easy for him to prepare to meet with us.

### Democrats draft legislation to protect IGs from Trump

House Oversight and Reform Chairwoman Carolyn Maloney (D-N.Y.) and other committee leaders fired off a letter today on the president's treatment of inspectors general. Francis Chung/E&E News

House Oversight and Reform Chairwoman Carolyn Maloney drafted legislation that would prevent the president from removing independent watchdogs without "good cause."

The New York Democrat's bill and accompanying letter from a host of House committee leaders comes after a series of presidential actions that critics see as against inspectors general.

On Monday, President Trump demoted Pentagon IG Glenn Fine and ordered EPA IG Sean O'Donnell to take on the workload, in addition to O'Donnell's existing responsibilities.

Last week, Trump fired intelligence community IG Michael Atkinson, who sent the now-famous whistleblower complaint to Congress that sparked an impeachment inquiry. The president declared Atkinson "is not a big Trump fan."

The president also appointed a White House attorney to be a special inspector general of the Treasury's pandemic recovery ([Greenwire](#), April 7).

IGs are appointed by the president and confirmed by the Senate but are given considerable leeway to scrutinize federal agency actions.

Maloney accused the president of trying to degrade the independent watchdogs at a time when Congress is appropriating trillions of dollars in response to the coronavirus crisis and needs to ensure adequate oversight.

"Unlike any President in modern history, President Trump has engaged in offensive and unjustified attacks against Inspectors General, criticizing them for following the law, and retaliating against them for telling the truth," they wrote in a letter to Michael Horowitz, chairman of the Council of the Inspectors General on Integrity and Efficiency.

The letter said each presidential action on its own would "raise significant concerns." "Together, they reflect a campaign of political retaliation and reward that is antithetical to good government, undermine the proper stewardship of taxpayer dollars, and degrade the federal government's ability to function competently," said the letter.

Maloney's bill, the "Inspector General Independence Act," would limit the grounds for removal to "good cause" conditions, including permanent incapacity; inefficiency; neglect of duty; malfeasance; conviction of a felony; or a conduct involving moral turpitude, gross mismanagement, among other transgressions. She asks Horowitz for input on the proposal.

O'Donnell, the EPA IG confirmed in January, recently grabbed headlines after EPA Administrator Andrew Wheeler called on him to scrap a new report on the lack of community outreach to places potentially exposed to a cancer-causing chemical. He refused to do so ([Greenwire](#), April 1).

Recently, IG Sean O'Donnell was asked to serve as the acting IG for DoD. As there have been multiple conflicting news reports, I just wanted to check in and provide you with the most current information.

Mr. O'Donnell will serve as both the EPA IG and the acting Defense Department inspector general as of this week. Regarding Mr. O'Donnell's role on the Pandemic Response Accountability Committee (PRAC), under the CARES Act, the DOD IG is a member on the PRAC. Mr. Glenn Fine, the prior acting DOD IG, was named to lead the PRAC by the Council of the Inspectors General on Integrity and Efficiency (CIGIE). By statute under the CARES Act, CIGIE will be responsible for naming a new head of the PRAC.



### Democrats draft legislation to protect IGs from Trump

House Oversight and Reform Chairwoman Carolyn Maloney (D-N.Y.) and other committee leaders fired off a letter today on the president's treatment of inspectors general. [Francis Chung/E&E News](#)

House Oversight and Reform Chairwoman Carolyn Maloney drafted legislation that would prevent the president from removing independent watchdogs without "good cause."

The New York Democrat's bill and accompanying letter from a host of House committee leaders comes after a series of presidential actions that critics see as against inspectors general.

On Monday, President Trump demoted Pentagon IG Glenn Fine and ordered EPA IG Sean O'Donnell to take on the workload, in addition to O'Donnell's existing responsibilities.

Last week, Trump fired intelligence community IG Michael Atkinson, who sent the now-famous whistleblower complaint to Congress that sparked an impeachment inquiry. The president declared Atkinson "is not a big Trump fan."

The president also appointed a White House attorney to be a special inspector general of the Treasury's pandemic recovery (*Greenwire*, April 7).

IGs are appointed by the president and confirmed by the Senate but are given considerable leeway to scrutinize federal agency actions.

Maloney accused the president of trying to degrade the independent watchdogs at a time when Congress is appropriating trillions of dollars in response to the coronavirus crisis and needs to ensure adequate oversight.

"Unlike any President in modern history, President Trump has engaged in offensive and unjustified attacks against Inspectors General, criticizing them for following the law, and retaliating against them for telling the truth," they wrote in a letter to Michael Horowitz, chairman of the Council of the Inspectors General on Integrity and Efficiency.

The letter said each presidential action on its own would "raise significant concerns." "Together, they reflect a campaign of political retaliation and reward that is antithetical to good government, undermine the proper stewardship of taxpayer dollars, and degrade the federal government's ability to function competently," said the letter.

Maloney's bill, the "Inspector General Independence Act," would limit the grounds for removal to "good cause" conditions, including permanent incapacity; inefficiency; neglect of duty; malfeasance; conviction of a felony; or a conduct involving moral turpitude, gross mismanagement, among other transgressions. She asks Horowitz for input on the proposal.

O'Donnell, the EPA IG confirmed in January, recently grabbed headlines after EPA Administrator Andrew Wheeler called on him to scrap a new report on the lack of community outreach to places potentially exposed to a cancer-causing chemical. He refused to do so (*Greenwire*, April 1).
